

PRINTERS' SESSION

International Union Convenes at Washington.

CORTELYOU AMONG VISITORS

Chief of the Weather Bureau Moore Welcomes the Delegates—Reports of Officers Show the Organization is Highly Prosperous.

WASHINGTON, Aug. 10.—The 6th session of the International Typographical Union began here today, with nearly all of the delegates present. Chairman Whitehead, of the local committee on arrangements, presided, while by his side sat Secretary Cortelyou, of the Department of Commerce and Labor; Public Printer Palmer, and a number of other prominent men. Commissioner McFarland and Willis Moore, chief of the weather bureau, welcomed the delegates. Mr. Moore, who formerly was a printer, congratulated the union upon its strength, and spoke of the President of the United States as a friend of the local union, also welcomed the delegates. President James M. Lynch responded to the welcoming address. He expressed the opinion that in a few years the union would number 100,000 members.

The president and the secretary-treasurer presented their reports and at 11 o'clock the convention adjourned until tomorrow in order to permit the members to spend the remainder of the day down the Potomac.

REPORT OF PRESIDENT LYNCH.

Past Year a Most Notable One, and the Future Outlook Bright.

WASHINGTON, Aug. 10.—The report of President James M. Lynch was presented to the International Typographical Union's convention, soon after it opened today. He said that the past year had been a notable one, not only for the International Typographical Union, but for organized labor in general. The spirit of organization, he said, has prevailed in trades and callings hitherto almost unknown, while the older organizations have made steady progress and gained in membership.

The report said the locality of any considerable importance without typographical union is rare. Mr. Lynch urged the adoption of some plan whereby the isolated printer, working in localities supporting from one to six brother artisans, but not enough to warrant organization, may be reached. In such cases, he suggests that the printer be attached directly to the parent organization.

During the present industrial crisis, brought about by the vast increase in the number of trade-union adherents, Mr. Lynch said that the International Typographical Union has been fortunate in preserving its equilibrium and has pursued a calm and peaceful course.

The report expressed regret at the tendency on the part of the trade-unionists to make light of the rights of the employers and questioned whether it would not be better to display a tolerant spirit toward them, in the hope of establishing friendly relations. "We cannot deny the right," he said, "to the right to organize, and it is not outside from the probabilities that through this era of organization may come the era of peace."

Mr. Lynch observed that the work for the future lies in the extension of the scope of the International Typographical Union by added benefits to its members in the way of financial relief, the renewal of a demand for better sanitary conditions of the workroom, insistence on the proper instructions for apprentices and the advancement of the union label.

"Above all," he said, "there should be an effort to encourage a system of education that would bring to our membership a knowledge of the conditions which surround them and enable them to defend their position as trade-unionists and members of a great international organization."

The report referred to the arbitration agreement with the American Newspaper Publishers' Association, which has been in force for more than two years, and said that all but two disputes have been settled in a fairly satisfactory manner and that there is much better feeling existing between the two organizations. The International Typographical Union was the first to negotiate a general arbitration agreement, and added that these far the union has carried out faithfully and with an earnest desire to promote and make secure industrial peace with union employers.

"If, however," President Lynch said, "the arbitration agreement is judged by unscrupulous individuals and made the vehicle for unjust and questionable decisions, through the connivance of any interest in the party, then the cause of arbitration and the cause of industrial peace will receive a blow from which recovery will not be possible for years."

President Lynch made his address to the American Newspaper Publishers' Association a part of his report, and referred to the condition existing in various cities. He also spoke of the subject of trade-union incorporation, and said that the convention might well adopt a law forbidding a local union to incorporate except under exceptional conditions and with the sanction of the executive council of the International Typographical Union.

After expressing disapproval of the action of some central labor bodies in boycotting union newspapers because of their editorial policy, President Lynch referred to the abuse of the right of appeal, the failure of the efforts to secure the passage of an eight-hour law by Congress; the establishment of printing offices on the factory plan in small villages; the flourishing condition of the printing business, notwithstanding the continued introduction of improved machinery; the necessity of every union becoming a union missionary; the Amos J. Cummings memorial movement; the vigorous prosecution of the campaign for label textbooks; the report of the copyright committee. The report concluded as follows:

"We are doing well. Careful action on the part of the delegates, coupled with moderation and ordinary business sagacity, will accelerate our progress, add to our stability as an organization, make our future even more secure and enable us to make benefit in this sixth session. Let wisdom be the watchword."

FINANCES IN GOOD SHAPE.

Secretary-Treasurer Reports Nearly \$50,000 on Hand.

WASHINGTON, Aug. 10.—The report of J. W. Bramwood, secretary-treasurer of the International Typographical Union, for the year ended May 31, 1903, shows that the receipts for the year, including the balance in the treasury June 30, 1902, of \$3,672, amounted to \$22,525. The expenditures were \$14,985, leaving a cash balance in the treasury on May 31, 1903, of \$7,540, an increase during the fiscal year of \$1,067.

The report said the growth in membership has been in keeping with the advances made in other directions, the increase in the average paying membership during the past year being 662, the largest in the history of the organization. The per capita tax was paid on an average

membership during the past year of \$6.07. The report in the history of the organization, per capita tax is now paid on an average membership of \$2.08. A tabulated statement of the number of charters issued, refused, suspended and surrendered shows a net gain in membership of 201 from this source. During the fiscal year just closed, 119 new unions were chartered, one was reinstated, two were suspended, and 13 surrendered. The total increase in the number of local unions is given as 180, while the total number of bodies subordinate to the International union on May 31, 1903, was 669, divided among the several crafts as follows: Typographical unions, English, 618; German-American, 21; photo-engravers' unions, 15; mailers' unions, 21; typographers' unions, 7, and newspaper writers' unions, 18. Death benefits paid during the year numbered 47, involving an expenditure of \$2,042. The receipts of the fund were \$235 in excess of the expenditures, leaving a balance to the credit of the fund of \$14,985. The amount of benefits has been paid from time to time, but the report says the receipts have always exceeded the expenditures, and the secretary believes the International union is in a position to raise the death benefit to \$700. STRIKE AT CRIPPLE CREEK.

Miners Walk Out Because the Mill Trust Refuses to Pay Scale.

COLORADO SPRINGS, Colo., Aug. 10.—A strike was inaugurated this morning in the Cripple Creek district shipping ore to the plants of the United States Reduction & Refining Company at Colorado City and Florence, because of the refusal of the so-called mill trust to pay the scale of wages demanded by the Western Federation of Miners, with which the millmen's union is affiliated. The strike has as yet in no wise affected operations at the Standard mill in Colorado City, inasmuch as the company has enough ore on hand to run the plant for several days. The men employed at the Standard are not members of the union, and the company expects no difficulty in operating the plant unless the strike at Cripple Creek cuts off the supply of ore. In that event, it is said that the reduction company will close its mills indefinitely, paying its present employees one-third of their present wages for a period of six months.

Three Thousand Men Are Out.

CRIPPLE CREEK, Colo., Aug. 10.—During the forenoon more than 3000 miners have gone on strike. All the principal mines except the Portland, C. K. & N. P. Pass, Strong and Clark are closed down. It is said that within a few days all small miners in the district will be called out. In order to stop shipments not only to the United States Refining & Reduction Company's mills, but also to the smelters operated by the American Smelting & Refining Company, because of its refusal to grant an eight-hour day at its Denver smelter.

TEXTILE STRIKE ENDING.

Ten Thousand Report for Duty, and More Expected to Give In Today.

PHILADELPHIA, Aug. 10.—It is estimated that 10,000 operatives in the textile trade reported for duty today at various mills, and a similar number, it is expected, will return tomorrow. This is the first serious break in the textile workers' strike, which has been in progress since June 1. The strikers who have given up the fight include cloth-weavers, loom-fixers, barmen and twisters. Their principal demand was for a 55-hour week, with 40 hours pay. In previous concessions were granted by the manufacturers. Secretary Gillard, of the executive board of the General Textile Workers' Union, stated that the large defection was due to lack of support. He said also there are still about 35,000 operatives on strike, including ingrain carpet weavers, upholstery weavers and dyers.

MINERS NOW HOLD THE WHIP.

People Who Made Them Leave Town Will Be Arrested.

DENVER, Aug. 10.—A special to the News from Georgetown, Colo., says: "Judge Frank Owens might issue an injunction against every member of the Citizens' Protective League restraining them in any way from interfering with the 15 members of the Idaho Springs Miners' Union who were driven out of the town just after the blowing up of the compressor of the Sun and Moon mine. 'Immediately after the issuance of the temporary restraining order, attorneys representing the 15 miners and the Western Federation of Miners offered criminal complaints against the members of the Citizens' Protective League of Idaho Springs. Warrants against each of them were issued and the Sheriff was instructed to start tomorrow and arrest all of them that he could find, and send them to the Georgetown to appear before Judge Owens.'"

NON-UNION HELP CAUSES RIOT.

One Man Shot at Alabama Mine and Another Seized by Deputies.

BIRMINGHAM, Ala., Aug. 10.—A report reached the office of the Sheriff this afternoon that serious trouble had broken out at Virginia City, where a strike among the miners had been on for some time. Sheriff Burgen sent a posse of deputies to the scene. According to the report, one man had been shot and another assaulted. It is said that the trouble came through an effort to work non-union men in the mines.

Building Trades' National Meeting.

DENVER, Aug. 10.—Over 100 delegates were present when President E. L. Smythe called the sixth annual convention of the National Building Trades Council to order in the Chamber of Commerce today. Many of the delegates held proxies for others who are unable to be present. Secretary-Treasurer H. W. Stedman announced that he alone held proxies for 50 votes. The greater part of the day was devoted to the routine business of organizing. The delegates were formally welcomed by President Meyer Friedman, of the Chamber of Commerce, and President Allison Stocker, of the Material Men's Association. The delegates were then addressed by President Smythe, of the National Building Trades Council, and President T. M. Hyder, of the local council.

New Element in Building Strike.

NEW YORK, Aug. 10.—A new element has been injected into the building strike today by the arrival of Frank Buchanan, president of the International Association of Bridge and Structural Iron Workers in this city. He sent a long communication to the building trades employers' organization, declaring that the agreement entered into with the Association last April should be still in force without trying to force another agreement. POPE IS AGING FAST

Looks Ten Years Older Than Before His Election.

OLD FRIENDS AT THE VATICAN

Three Hundred Venetians Are Given an Audience—Pontiff Calls All His Acquaintances by Name, Just as in Venice.

ROME, Aug. 10.—Pius X had another fatiguing day, as he received all the delegations which had come to Rome to attend the coronation ceremonies. He accorded a lengthy audience to about 300 persons from Venice, receiving them in the Clementine Hall. The pontiff allowed all the members of the delegation to kiss his hand, and called by name those whom he knew, just as he had when he met them formerly in Venice. He said to them: "I am a poor mortal, too weak for the heavy cross which God has given me. But his will be done. I will carry it as best I can, and you must all pray to our Lord to give me the necessary strength."

His old Venetian friends agree that the pope looks ten years older than he did before his election, but that his affable and simple manner has not changed.

MARTINELLI FOR SECRETARY.

FLYER IS DERAILED.

Thirty People Are Injured but None Killed in Kansas Wreck.

KANSAS CITY, Aug. 11, 3:15 A. M.—It is reported from Sedalia that 30 persons were injured but none killed by the derailment of the Missouri, Kansas & Texas fast passenger train, known as the Katy Flyer No. 6, near Schell City, Mo., late last night. The train was due at St. Louis at 7:30 this morning and is through train from Texas points. It is impossible to obtain details tonight.

MAYOR TAKES A HAND.

He Will Investigate Cause of Accident at Philadelphia Ball Ground.

PHILADELPHIA, Aug. 10.—Mayor Weaver today personally interested himself in the investigation into the cause of the collapse of the promenade at the Philadelphia National League baseball park on Saturday, which resulted in the death of nine spectators and serious injury to nearly 300 others. In compliance with an order from the Mayor, the Bureau of Building Inspection appointed a special board of expert men of experience to determine the liability. The remaining two games of the series with Boston were postponed. The schedule will be resumed on Wednesday.

CANNING FACTORY BLOWS UP.

Three Men Are Killed and Building Reduced to Atoms.

PORTSMOUTH, O., Aug. 10.—Humphreys & Hogan's canning factory at Rutland, near here, blew up on noon, killing three workmen and injuring a dozen others. The killed are: DON MUTHLER, DALE RALINE. The factory was lighted today for the first time this season, and the building was blown to atoms.

Twenty Killed in Explosion.

NEW YORK, Aug. 10.—Twenty men were killed and wounded Saturday night by the explosion of a boiler in the Santa Rita cotton factory in Lima, Peru. The financial loss is not known.

FULLER GRAND MARSHAL.

General Warfield Resigns on Account of Severe Illness.

SAN FRANCISCO, Aug. 10.—General R. H. Warfield has resigned as grand marshal of the parade during the G. A. R. encampment, on account of severe illness. Colonel Jesse B. Fuller has been elected to fill the vacancy. Grand Marshal Fuller is past department commander of California and Nevada, past commander of the Royal Legion Commandery of California, and a member of several committees in connection with the present encampment. He served through the war with the Army of the Cumberland, under General Thomas, and was engaged in all the battles between Chattanooga and Atlanta. The arrival is announced at Los Angeles of the Abe Patterson Post, of Allegheny, Pa., and they put in the entire day sight-seeing. They were received at the Chamber of Commerce and given a hearty welcome by citizens.

STRIKE MAKES MANY WALK.

New York Excursionists Find Cars Tied Up Suddenly.

NEW YORK, Aug. 10.—Thousands of men, women and children who spent Sunday at near-by Long Island resorts had great difficulty in getting back to this city owing to a strike on the New York & Queens County Electric Railway Company's lines running out of Long Island City, on account of which police reserves were on duty during the night. LIVENS UP HUMBERT TRIAL

MME. THERESA HAS NO RESPECT FOR DIGNITY OF COURT.

Demands That She Be Heard and Shouts That Judge Is Prejudiced When Examining Witnesses.

PARIS, Aug. 10.—The Humbert trial today drew another large crowd to the Palais de Justice. Mme. Theresa Humbert continued to dominate the proceedings, and created several scenes when the court attempted to examine the members of the family. M. Bonnel, the presiding judge, insisted on examining Frederic Humbert, her husband, and Mme. Theresa, rising, said: "I demand to be heard. I am strong today, and will explain where the millionaires are."

The judge, however, proceeded with the examination of the other defendants, despite Mme. Humbert's constant interruptions. During Judge Bonnel's searching interrogation of her husband, Mme. Theresa dramatically exclaimed: "Monseigneur le President, you are clearly showing by your manner that you are against us. You should discontinue your feelings and try to appear impartial."

The spectators were greatly amused at this outburst. The judge ordered Mme. Humbert to desist, but she again shouted, "You are continually showing your prejudice." Frederic Humbert testified lengthily regarding the affairs of the Rente Viagre, the insurance company which the Humberts started, and in the crash of which thousands of poor people lost all their savings. He maintained that the operations were conducted in good faith, and claimed that public prejudice aroused against the Humbert family brought about the failure of the concern. He denied the judge's statement that the rooms in the palatial residence of the Humberts in the Avenue d'Orleans were conducted by a system of secret telephones. Mme. Theresa here also exclaimed, "Lies, more lies!"

Frederic Humbert said he had devoted his time to art and poetry, leaving the entire financial operations to his wife. The examination of Romain d'Aurignac, Mme. Humbert's brother, brought nothing new.

Fourteen offices will soon be opened. Mr. Shubert has discovered that well-bred women improve the chorus and will try to engage that kind. Offices will be established in Portland.
