CURIOUS FOR HISTORICAL SOCIETY.
 A very broad board, one of the kind formerly in use when people hewed to the line, let the chips fall where they might, was added to the collection of relics of the Oregon Historical Association by Secretary Himes yesterday. It is 1 1/2 inches across the bit, which is very short, and was probably a full foot when Fred Himes brought it across the plains in 1846, as it has doubtless been rounded in size by hewing logs for many years. It was made by the "pioneer" ax manufacturers, Collins & Co., of Hartford, whose style went out of date about 20 years ago. Mr. Himes is in favor of having an Oregon building for the St. Louis Fair, made in regular old-log cabin style, and thinks there can be enough suitable logs for it secured here, and that this old relic is still capable of hewing to the line, and making a surface as smooth as if planned. In addition to this ax, Mr. Himes yesterday added to the collection in the society's museum a satin slipper, one of a pair which his wife's grandmother wore when she was married, December 16, 1788. It is of course, entirely hand-made, and has a pointed toe which shows that even in 1788 comfort was not considered in connection with fashion. With this was a "sampler," a much-worn silver spoon, and some two-pronged forks, with buckhorn handles, by which meat, etc., could be much more expeditiously, if not so safely, conveyed to the mouth than by the four-pronged silver forks in use at present, which cannot be stuck into anything, but must be handled like a spoon, though they do not answer in the place of one for even chicken gravy.

OLD BARN STRONGLY BUILT.—Two very different styles of erecting wooden buildings are shown in the debris of the building at the corner of Fifth and Jefferson streets, formerly the stable of United States Senator Dolph, and the three cottages being torn down at the northeast corner of Third and Pine streets. In the first-mentioned building the rafters are 2x4 inches and the studs 2x4, braced all the way down, and the structure so firmly nailed that it was a difficult job to get it apart. All the lumber is as sound as possible, and will be used in the new building to be erected on the corner. A man has been at work for over a week extracting the nails from the lumber, which occupies nearly the entire west side of Fifth street, from Jefferson to Columbia. The three houses at Third and Pine streets were torn to pieces in short order by a rope attached to a donkey-engine, and there was no trouble about too many nails. The rafters and studs are 2x4, as is customary now, and when the buildings came down they were in condition to be loaded on wagons and hauled away to be burned, and not a stick or a nail in them will be used again. Material, boards and nails now are at a premium, as when these buildings were put up, and few build as if to last forever.

BOY POACHER RELEASED.—It is only about two weeks more to the beginning of the duck-shooting season in Oregon, and a sportsman to another, as they met yesterday. "That's all," was the cheerful reply. "The shooting has begun already. The warden had a lot of ducks on my preserve a day or two ago, and I shot and killed game out of season." "What was he shooting?" asked a bystander. "On young wood ducks." "Are they fit to shoot yet?" "Yes, some of them are full-grown." "I can scarcely blame the boy," continued the bystander. "For young wood ducks might leap the very elect to shoot and shoot out of season. But what became of the boy?" "Oh, the Game Warden brought him up to me and asked what to do with him, and when I looked at him and saw he was a mere kid, I said: 'Oh, spare him and let him go.' It is getting too near the shooting season now, however, to have poachers around scaring away the game, and the next fellow caught shooting out of season at Dead Willow will be prosecuted to the full extent of the law. Broiled teal and wood ducks are too rich for poachers."

TO INVEST IN OREGON MINES.—A. L. Harris, a prominent merchant of Red Bank, Wis., who has lately cleared up some \$50,000 on the celebrated Baraboo iron ridge, in that state, has been on a visit to this region, looking for a chance to invest some of his money in Oregon gold mines. He visited the Sumpter district and explored and prospected a number of mining claims there. His friend, William B. McCready, of this city, says Mr. Harris secured a large assortment of samples of ores from the Sumpter region, and has now gone home to have them assayed, and if they turn out as well as he expects, he will purchase some claim at least near Sumpter, and will at once proceed to develop it, and will furnish all the capital necessary to test it. A number of persons have been making large fortunes in the Baraboo iron ridge of late, and Mr. McCready is expecting several of them here soon, in search of gold claims to invest in.

DEER PLUNTER ON UPPER MCKENZIE.
 Lovers of venison party and venison hunts will be pleased to hear that deer are plentiful on the upper McKenzie, though this is not likely to benefit stay-at-home Portlanders much, as the sale of venison is forbidden by the game laws. Regd. of this city, who is spending a vacation at Foley Springs, writes to a friend that "hunters on the upper McKenzie are authority for the statement that there are a dozen deer to be seen now where there was one ten years ago. This in the face of the fact that people who are entitled to have venison to eat are getting more than ever, one skin-hunter's occupation is gone, that is the reason." It is really too bad that, when deer are so plentiful, a few haunches do not find their way to this market once in while.

NEW BRICK BUILDING STARTED.—Work has been commenced in earnest on the brick building to be erected on Taylor street, between Second and Third streets, by Dr. W. L. Wood. It will take the place of an old shack torn down some time ago. This was the building in which a Chinaman was foully murdered, and which has been the scene of several tragedies in days past. That part of the city has been missed by the march of improvement for the past two years, but has a bright future in store for it.

BUTY WORRY APPLIES.—A housekeeper who bought a lot of new Oregon apples from her grocer a day or two ago, was giving him a sample of the rough side of her tongue yesterday and venting her opinion of orchardists who brought scrubby, wormy apples to market. She said there was not one sound apple in the box she had bought, every one being scrubby and misshapen, and having one or more worms in it, and she considered that she had been extolled. The grocer assured her she had not, as it was the regular custom of farmers to bring to market at this time of year all the apples which fall from their trees on account of having been attacked by the codlin moth. He argued that this was commendable, as it showed the exertion made by fruitgrowers to destroy the worms which were the outcome of the codlin moth, and the preparatory stage of future generations of these pests, and if they were not destroyed, there would soon be nothing but wormy apples. The housekeeper said she had no objection to the destruction of codlin moths at any stage of the game, but she did object to having wormy apples sold to her in order that she might go to the trouble of preparing and cooking them for her family to eat in order to destroy the pests; and if any such joke was perpetrated upon her again, she would be likely to be exterminated. It might be well for the farmers to feed their wormy, wind-fall apples to their hogs, or eat them themselves, instead of forcing them on people who have no appetite for worms.

"PROFESSORS" OF WOOD-PILING SCIENCE.—A citizen in need of some one to carry in a pile of wood yesterday went down along Second street, where "professors" of wood-piling were having their hauls to look for one. He did not find any till he opened the door of a Chinese establishment labeled "Family Liquor Store," coming out of a Chinese gin mill, when he came upon a group of seven seated around in different styles, with their heads hanging over the backs of their chairs, all so much under the influence of the potent liquid that they were unable to do anything but stare at him. There was any more wood piled in the yard or not. The sight was calculated to jar the preserves of one's grandmother, but what particularly shocked the intruder was the sight in the game of one with whom he went to school in this city when he was a boy, and who was then the neatest, tideliest and best-dressed boy in the school, and who was now a stevedore, father being a tailor in a leading clothing-house here. Minnie Erickson Is Stabbed by Dora Freeman.

Jealousy between Dora Freeman and Minnie Erickson, two young women employed in a laundry at Third and Glisan streets, led to a hair-pulling match yesterday, and the end of it came when Dora stabbed Minnie with a knife in the left shoulder, inflicting a painful wound. Dora was subsequently arrested by Policeman Griffith Roberts, charged with assault with a dangerous weapon, and was again released on bail to appear for a hearing before Municipal Judge Hogue. According to Miss Erickson, Miss Freeman had been applying various ill-sounding epithets to her, and the trouble came to a climax yesterday about noon. "I could no longer endure Dora's insolence, and I admit that I struck her first," said Minnie Erickson. "Then she began to pull my hair, and we mixed up. My friend, Miss Myers, came to my rescue, and Dora stabbed me. Why I have been selected by Dora as a target for her abuse, I do not know."

AXES STILL CLASH

Woodmen of World Dispute Over Carnival.

MORROW BLAMES JENNINGS

President Says Director-General Is Responsible for Paying Directors \$100 Each—Jennings Tells How Morrow Was Defeated.

The Woodmen of the World carnival directors are still swinging their axes with a vengeance, blows are being landed right and left, the chips are falling where they may, and no one seems to care. As yet the complaint of Sunnyside Camp has not been filed, but the papers have been completed and are pigeonholed in the attorney's desk, awaiting the expiration of the "days of grace," which will be to-morrow night.

"Unless some settlement is reached by to-morrow night, where 'professors' are sure as you are a foot high the complaint will be filed in the Circuit Court on Saturday morning." Tonight, at Webfoot Camp, a mass meeting of all Woodmen will be held. No one is disposed to talk about the meeting, but the threatened lawsuit will undoubtedly make up the evening's discussion.

Every one seems to have their troubles. Director D. J. Beakey was heard to say that he feared to buy a new suit of clothes because his "neighbors" would accuse him of making the money off the carnival.

One of the directors had no grievance against any of the directors, but is worrying over the sum made by Messrs. I. W. Baird and George L. Hutchins, in the contest, and the naming of some of the royal court.

One Woodman can think of nothing but "graff," but to this the auditor and treasurer have replied by offering their books for inspection to contradict the charge of every transaction is to be found.

Politics in the Order.

Director-General J. J. Jennings is patiently awaiting the white flag. He said last night: "When we first organized, J. W. Morrow elected me director, and by a vote of 7 to 2. He thought he had the important office, but he later on found out he was wrong. An executive committee of five was appointed by the directors, but was later dissolved, and the committee had all the power, leaving the other five as mere figureheads. Morrow's clique controlled the executive board by a 3-to-2 vote, but when we dissolved the committee, the other fellows came into power. "When the subject of pay was first brought up, I was opposed to any salary for the directors. Later I changed my mind, and when he wanted \$100 up I was absent, leaving the directors to suit themselves."

"I don't hesitate to say that I am glad the boys got the money, for they deserved it all more than I did. I was not at the meeting, and he opposed it because he thought he could get more, and I understood that he is to get \$100 from his camp, although they turned him down the other night, when he wanted \$200. "I don't see how Sunnyside Camp can sue the head camp, as Sunnyside is only a subordinate camp, and has no charter of its own. "What I hate most about the business is to see some of these other directors getting the worst of it. They can't say anything against me."

Morrow Blames Jennings.

President J. W. Morrow has been at the bedside, and up to this time has not spoken for the press. When seen at his office yesterday afternoon, he said: "I have nothing against any of the other directors, but I want the case plainly understood."

"The first contest among the directors was for the presidency, in which I defeated Jennings. C. C. Bradley was elected secretary. A week later Jennings was unanimously elected director-general. Directors W. O. Manion, C. C. Bradley and A. J. Rathbun demanded that Jennings be elected director-general, or they would withdraw. This was where we made the mistake—by not letting them draw out."

Jennings was to blame for those fellows paying themselves that \$100, for if he had stayed at the meeting when the question came up, and voted according to a previous statement of his sentiments, the directors would not have had the four-fifths majority vote required to pass the motion. Bradley, Beakey, Jennings, Day, Rathbun and Manion had a contract binding themselves to vote together on all matters, and this control and run the carnival to suit themselves. While I was president, I had no power, as Barringer, Van Zante, Sullivan and myself were in the minority."

Then the president said some things about the director-general. "Previous to the commencement of the carnival, Jennings expressed himself as against paying the directors a salary. The directors wanted a salary, and Jennings was bound to vote with his crowd, so when the meeting came round at which the matter was to be settled he sneaked off just before it was called and hid, for he was nowhere to be found. Before the meeting was over, and after the motion was passed, he returned."

"All Took Their Hundred But Me."

"They all took their \$100 but I refused the check, and it was turned back into the general fund and divided amongst the different lodges, per capita. "Look what a mess Jennings made of that Forest Grove carnival Queen election," continued Morrow, and handed the reporter the following letter, signed by John Anderson, clerk, and Conrad Commander Nevel Macrum, of Forest Grove Camp, No. 8, W. O. W.:

Forest Grove Has Grievance.
 "I write this that you may know that we, the undersigned, appreciate the manner in which you conducted (except Jennings) handled the decision of the contest at this place. We wish further to thank Mr. Barringer for the trouble and expense he took in the matter, and must say that no better man and square decisions could have been rendered by any person. No doubt he has told you the condition things were in here over Jennings' unjust rulings and underhanded work. We hope that the friendly relations heretofore existing shall continue always."

The contest in question caused no little excitement in Forest Grove. The story goes that a number of tickets were sent to the manager of the contest at Forest Grove, and that he sold part of them to his friends, who had a "Queen" selected. When other contestants applied for tickets, they were informed that there were none for sale.
