AFTER "GAS" ADDICKS.

Suit Filed Alleging Fraud in Speculation of Stock of Big Company. WILMINGTON, Del., Aug. 20.—In the United States Circuit Court today George W. Hartman, of Philadelphia, filed a bill of complaint against J. Edgar Addicks, United States Senator of Delaware, charging that Addicks, with intent to defraud, had sold to him 1,500,000 shares of stock of the Bay State Gas Company without consideration.

The bill further asks that Addicks be ordered to deliver to the receiver for cancellation certificates for the 1,500,000 shares of stock, and that an accounting be made of the damages and loss sustained by the Bay State Gas Company, of Delaware, in consequence of the alleged fraudulent and unlawful issue of stock, and that the defendant be ordered to pay an amount equivalent to the alleged fraud and loss. The defendants are required to appear and make answer on the first Monday of November.

The stock is alleged to have been transferred on July 2, 1902. The bill alleged that the stock was not issued direct to Addicks, but to another man, presumably in order to defraud the stockholder. It is made that the stock was issued to Edwin M. Post, a New York broker, who is alleged to have been in the office of Addicks at the time the stock was sold. It is further alleged that the \$250,000 stock Addicks is believed to still control a large portion.

NEW SCHEME IN BANKRUPTCY.

"Porter Brothers in Liquidation" to Handle Old Firm's Business. CHICAGO, Aug. 20.—"Porter Brothers in Liquidation" is the name of a new kind of corporation formed by creditors to conduct the business of a bankrupt stock company while it is in the Bankruptcy Court. The trustees' bond of \$50,000 is said to cover the value of the local merchandise held by the firm's commission houses, which failed to pay for the stock. This corporation is composed of the largest creditors, mostly bankers. Trustee L. A. Potter is its head. The liabilities now to be seen.
