

JABOUR SHOW ENDS

Enmeshed in Hopeless Tangle of Attachments.

SPOKANE VISITORS ON STREETS

Look for Place of Amusement, While Promoter Wrestles With Rheumatism and Plans for One-Ringed Circus Next Year.

SPOKANE, Wash., Oct. 7.—(Special).—Jabour, the noted promoter of horse shows and other Oriental attractions, lies on his back in a local hotel reading the life of Napoleon Bonaparte while a few of his former performers are earning meek tickets and the balance are cursing the fates which told them to follow Jabour to Spokane, the final wind-up of his checkered journey in the West.

Jabour's show is no more. Railway agents have attached and reached his paraphernalia and seized all his goods. Meeting after meeting of the board of directors of the Interstate Fair have been held in the hope of straightening out the tangle and giving some kind of a show, but the financial end was too hopelessly involved and the project has finally been abandoned.

For years country people have flocked to Spokane during fair time, attracted by the excellent entertainments given in the big pavilion downtown. The collapse of the Jabour show leaves the town without a big night attraction, and as a result people can be seen at all hours of the evening walking around and swearing over the lack of entertainment.

Meanwhile Jabour lies on his back nursing his rheumatism and planning for next year, when he will take a one-ringed circus on the road.

POOR POLITICS, SAYS HURLEY.

He Did Expect McBride to Make a Personal Fight.

SPOKANE, Wash., Oct. 7.—(Special).—State Senator George Hurley, representing Okanogan, Douglas and Ferry counties, said today:

"It was certainly very good politics in Governor McBride making the speech he did at Colville. I had not expected it of him and it was not warranted. I was talking with a number of men here and down on the train and some of them were friends of the Governor, but all were of the opinion that Governor McBride has done wrong in bringing into a personal fight with Senator Stansell."

"Senator Stansell, on the other hand, I do not think has lost any of his friends. The Governor made more enemies for himself by that speech than he did for Stansell."

"I do not want to antagonize the Governor. I am willing to let him alone and for him to lead me where he will, but I will, however, have a front seat at his speech here and if he makes any attack upon me he will certainly hear from me."

"Yes, I intend to be a candidate for re-election. The people in my district can vote for Governor McBride if they want to, and for me, but if the Governor tries to make a fight on me, then it will be either he or myself. As for Ferry County, he cannot possibly carry the county."

"At the convention that nominated me were 12 delegates, six from each county. I informed the convention that I opposed a railroad commission of any kind and was nominated with four understanding. I am just as consistent as the Governor is."

EVANS WANTS HIS LIBERTY.

Says His Eleven Years' Punishment Is Sufficient.

SACRAMENTO, Cal., Oct. 7.—Chris Evans, who for the past 11 years has been incarcerated in Folsom Prison and who, according to the prison officials, has been a model prisoner in every respect, has forwarded an application to Governor Pardee asking his intervention for a parole. In the course of his letter Evans wrote:

"I am not innocent of wrongdoing, for if I had not violated the law I would not be in prison, but they were errors of the head, not of the heart. I permitted my sympathies for victims of oppression to lead me to overcome my judgment, but if I have sinned, I have also suffered. I lost my right eye and my left hand and I have been separated from my wife and children, who love me dearly, for 11 years, and I therefore pray for parole."

Chris Evans was convicted of murder, his crime growing out of the troubles with the railroad company over land titles in the Milled Slough district. In company with Charles Brown, he was convicted of the murder of a man named John Smith, who was killed by a bullet from the foot of the Sierra, and for a long time evaded the officers of the law. Several persons were sent in pursuit of the fugitives and in an encounter with one of these Brown was mortally wounded. Evans was caught, but was not captured until he was disabled by bullets.

WEATHER IS UNFAVORABLE.

Visitors to the La Grande Fair Suffer From the Cold.

LA GRANDE, Or., Oct. 7.—(Special).—The weather promised well for the District Fair this morning, but about noon it clouded up and a cold rain fell from the North, which made it very uncomfortable on the grounds, and especially so in the grandstand. The racing events were all disappointing because the horses and the people were cold. No starting records were made by any of the horses, and there were numerous complaints of uneasiness, due more to the chilly atmosphere than anything else.

The fine stock show is especially fine this year, some of the finest cattle in the state being on exhibition. Tomorrow is La Grande day and a large attendance is expected, as all places of business will close during the afternoon. The racing events for tomorrow will be the best of the fair if the weather and the track will permit.

ALBERT MONAHAN, RESCUED FROM PLUNGE, DROWNS.

Saving of Companion Was the Third Brave Deed Performed by Young Logger From Maine.

ASTORIA, Or., Oct. 7.—After having saved a companion who had fallen into the Nasel River while working at Owen's logging camp, Albert Monahan, aged 28, sank back into the water, exhausted and chilled through, and met his death. The two men were working on a log boom and Monahan's companion slipped between the logs and fell into the river. Monahan plunged in after him, and succeeded after much difficulty in assisting him upon a log. Monahan was completely exhausted.

DOMINION LIBERAL WITH SUBSIDIES.

VANCOUVER, B. C., Oct. 7.—The Dominion government has announced subsidies for 461 miles of railway, which at \$250 a mile, makes \$115,250. The western grants include Nicola, Kamloops and Similkameen from Spence's Bridge to Nicola Lake, 45 miles, \$11,250. For a line from Winnipeg Beach to Icicle River by way of Gimli, 35 miles, \$8,750. Edmonton, Yukon and Pacific, from Edmonton toward Yellowhead Pass, 35 miles, \$8,750. Kootenay Central Railway, from Golden to International boundary by Windermere and Fort Steele and crossing the Crow's Nest Railway at \$250 a mile, \$8,750. For Kettle River Valley Railway, from Grand Forks up the north fork and west fork of the north fork of the Kettle River, 50 miles, \$12,500. For a line from Wellington to Union Bay, 55 miles, \$13,750. For a line from Midway to Vernon, 130 miles, \$32,500.

BARBERS WITHOUT STATE PERMITS.

LA GRANDE, Or., Oct. 7.—(Special).—Two barbers were hauled up before Justice Grant this morning, after the State Board of Examiners were in the city, and found that they had not secured permits to work in the barber trade in this county. Three examiners were in the city today, J. C. Wells, president of the board, Portland; H. G. Meyer, secretary, Salem; and F. T. Rogers, treasurer, Portland. Notices had been issued to Eastern Oregon barbers that an examination would take place in La Grande today and those failing to appear, who have only temporary permits, will have them revoked and will be prosecuted if they attempt to continue to work.

The board came to La Grande, as it is the most central point in the state. The barbers who were arrested were E. H. Hubbard and A. E. Keen and are employed at M. H. Kierley's shop.

ARRESTED FOR CRIMINAL ASSAULT.

LA GRANDE, Or., Oct. 7.—William James, of Elgin, 25 miles from here, is in the hands of La Grande officers for criminal assault upon Elsie Ezelle, a 13-year-old girl of Elgin. James is 70 years of age. The child was attending school and was bribed with a present not to tell her father. James was arrested by the old man dropped a statement while drunk that awoke suspicion. He was arrested at Elgin, waived examination before Justice Morelock and was placed under \$1000 bond to appear in court. Officers and will be taken to the County Jail tonight.

FIVE YEARS FOR ASSAULT ON WOMAN.

NEW WESTMINSTER, B. Governor Chamberlain will not be here for the good roads meeting, but will prepare an address to be read for him.

PROTECTION AGAINST DEAD BEATS.

HOQUIAM, Wash., Oct. 7.—(Special).—At a meeting of the retail merchants of this city last evening a Merchants' Association was formed to protect themselves from "dead beats" and wholesale merchants who do a retail business in this city. Every firm in the city was represented, and the following officers were elected: Charles Ryland, president; Floyd Hall, vice-president; and L. H. Brewer, secretary and treasurer.

DUFFY LOSES SUIT FOR GOLD.

SAN FRANCISCO, Oct. 7.—A jury in Judge Graham's Court today gave a verdict for the defendant in the suit of Thomas Duffy against Jafet Lindenberg. The suit was for \$99,000, Duffy claiming that the defendant took that amount in gold dust from a claim owned by him. The testimony showed that Duffy had sold the claim to the defendant for \$29,000.

SELL TIMBER AT LESS FIGURE.

ABERDEEN, Wash., Oct. 7.—(Special).—Ladd & Tilton and Mrs. Amy Farquhar, of Portland, and Samuel and G. T. Woodling, of this city, sold today 800 acres of timber land in Chehalis County for \$30,000. They were offered \$50,000 before the option given by C. H. Green, of Salford, and W. A. Avery, of Detroit, expired.

PLANS FOR HOQUIAM CHURCH.

HOQUIAM, Wash., Oct. 7.—(Special).—The plans for the new Presbyterian Church here have been received. The drawings show a beautiful structure in the English-Gothic style. The fine building, when finished, will cost between \$10,000 and \$12,000, and will be one of the finest churches in the southwestern part of the state.

BUD JONES CUT HIS SON-IN-LAW.

LA GRANDE, Or., Oct. 7.—(Special).—O. Knight, of Kamela, was cut at 8 o'clock twice in the left shoulder, making superficial wounds. His father-in-law, Bud Jones, a man aged 50, cut him because he threatened to kill his family. The wounds are not serious. The men are under arrest.

Telegraphic communication showed the order had been bought at Seattle for 40 cents and raised to \$55, paraffine being used to conceal the erasure.

RIDES MADDENED STEER

FEAT PERFORMED BEFORE CROWD AT SUMPTER RACE MEET.

Daring Man in Saddle Saves Life of Boy Knocked Down by the Frenzied Beast.

BAKER CITY, Or., Oct. 6.—There was an excursion from this city to Sumpter yesterday under the auspices of the White Swan Band. It was a cloudy, rainy day, but a large crowd took advantage of the cheap rates and braved the storm. The occasion of the excursion was the horse-racing at the Sumpter Race Association Park. The races were pulled off according to the programme, but they were uninteresting. The real fun, if it can be dignified by

murder of M. W. Ragdale, at an early hour Monday morning. The officers left for Trout Creek Monday afternoon on No. 5. They examined the saloon where the murder took place. The daylight shone through 30 bullet holes in the front of the saloon. All the glassware on the back bar was broken and the bar itself had 30 bullet holes in it.

There were 15 men and two women in the saloon when the shooting began, and all lay flat on the floor until after the shooting. Ragdale went to get his gun after the first shot, but fell to the floor wounded before he could open the drawer. Udell was in bed in a back room, and hearing the shots, he went around and was immediately hit by two bullets. He died a few hours later.

COURTHOUSE FOR SKAMANIA.

County Commissioners Accept Plans, and Will Advertise.

STEVENSON, Wash., Oct. 7.—(Special).—The Board of County Commissioners here in session here this week, and have taken a decided action toward building a new Courthouse. The plans and specifications submitted by Architect J. H. Burdick, of Albany, Or., have been accepted, and advertisement for bids will be made. Contractors will be asked to bid on two buildings, a frame and a brick. After bids are opened the board will decide whether to build a brick or frame Courthouse.

The Board of Commissioners had James Campbell, of Carson, arrested yesterday for selling liquor without a license. He was brought before the Justice's Court here and fined \$25. He afterward arranged with the board for a license and went back this morning to cater to the thirsty Caribonites.

The board has taken action to have townships 4 north, 7 east, and 4 north, 8 east, which are in the Rainier forest reserve, thrown open for settlement. The former is in Wind River valley and latter in the Little White Salmon valley, and both are excellent agricultural lands. They are only about eight miles back from the Columbia River. Petitions will be sent to both Forest Reserve Inspector Pinchot and the Department at Washington.

BROWN HELD FOR ASSAULT.

If Turnbow Dies at Garfield, He Will Be Tried for Murder.

COLLAX, Wash., Oct. 7.—J. E. Brown, the Garfield real estate man, who probably shot and seriously wounded Thomas J. Turnbow at Garfield some time ago, pleaded not guilty to the charge of assault with intent to commit murder this morning before Judge Chadwick in the Superior Court. Brown's attorneys made a motion for the dismissal of the case, alleging improper filing of the information and complaint. That motion was overruled by Judge Chadwick, and they then presented a demurrer to the information, which was also overruled. The defendant's counsel then asked for time in which to file an application for a change of venue, and a hearing of the argument will be held on November 14.

Turnbow is gradually growing weaker at his home in Garfield from the effect of the pistol shot inflicted by J. E. Brown, and physicians are of the opinion that he cannot possibly live until the time of Brown's trial. In the event of Turnbow's death the trial will probably be held in the federal court and bring a direct charge of murder in the first degree against Brown.

CONTEST SUIT AGAINST MUCKLE BROS.

Ida May Hays, who married Charles Hays at Portland in 1901, now asks to be divorced from him, claiming that he deserted her in the month following their wedding. She desires to resume her maiden name, Ida May Hays. Frederick Witta is the plaintiff in the other suit. Caroline Witta being the defendant. They were married at Chicago in November, 1893. The plaintiff alleges desertion in December of the following year.

RUSH TO PAY THEIR TAXES.

ALBANY, Or., Oct. 7.—(Special).—

When the second payment on the Lane County taxes became delinquent \$17,000 had been turned in to the Sheriff by the taxpayers. There has been a rush during the past few days, as the time for becoming delinquent approached dangerously near. The Sheriff's office averaged writing 100 tax receipts per day, and presented a busy scene. Taxpayers as a rule have taken advantage of the opportunity to save extra expense, and taxes are paid up remarkably well.

APPOINTMENT OF LANE SCHOOL FUNDS.

The Lane County school fund has been apportioned among the various school districts by County School Superintendent W. L. Jackson. The total amount of the fund is \$229,280, and it has been apportioned in 22 districts. The amounts range from \$123.06, which is the sum set aside for the smallest district, to \$18,720, the amount that will support the district embracing the three Albany schools.
