Time Is Made Without Wind-Shield at Memphis.

MEMPHIS, Tenn., Oct. 22.—A mile in 1:56 1-4 was made by Dan Patch today at the Memphis Trotting Association's track in a trial against time. The pacer slipped three-fourths of a second from the world's record of 1:57 held by Prince Albert, and lowered his own record by 3/4 seconds. The mile was paced without a wind shield and at the finish Dan Patch seemed fresh and vigorous. The demonstration that greeted the new world's pacer champion as he flashed under the wire was a memorable one. Horse owners who stood about the track before the start, and who caught the time with their own watches and before the official time flashed out across the track they set up a shout, and threw hats and caps high into the air. The shout was caught up by the people in the grand stand, the space before it and on the clubhouse grounds and the name of the new pacer idol was proclaimed in shouts of applause that reached their climax as Driver McHenry pulled up before the judge's stand and faced his hat in acknowledgment of the race. The trial was made with two runners to set the pace, the sulky preceding the power carrying a canvas strip between the wheels. The quarter was reached in 38 seconds, the half in 1:17 and the three-quarter pole in 1:57. As the horse swung into the stretch, Dan Patch was pushing the forward runner so closely that scarcely a hand's breadth intervened between his nose and the back of the driver on the forward sulky.

PARKS SENT TO THE TOMBS. Devery Won't Go His Bail Because He Works With Tammany.

NEW YORK, Oct. 22.—Samuel J. Parks, walking delegate of the Housewives' and Bridgemen's Union, who was indicted on a charge of perjury Tuesday and was to have appeared in court yesterday, surrendered himself today. He said he had been in New Jersey on business for the union. Parks was sent to the Tombs Prison today, his offer to give \$500 cash bail being refused. The District Attorney argued that Parks' nonappearance in court had vitiated the \$10,000 bail furnished by John J. Byrne, Devery's nephew. Up to midnight Parks was still in a cell in the Tombs, having been unable to secure a bondsman. William S. Devery, who had originally procured a bondsman for Parks to the amount of \$10,000, has declined to aid him any longer. In a long statement issued tonight Mr. Devery gave his reason, saying: "I had already procured bondsman for Mr. Parks in the sum of \$10,000. This was done merely as a matter of friendship to him, and because I believed he was a persecuted man. I have not seen Parks since October 7, when he returned from Kansas City. Since that time he has been consorting with Mr. Murphy and his friends, and they have been undertaking his defense, so I am informed. I will not stand for any man who carries water on both shoulders, and who is not as straight in his friendship to me as I am to him. Parks has acted the part of an ingrate to me."

Immigrants Appeal to Washington. PHILADELPHIA, Oct. 22.—Appeals against deportation were sent to Washington tonight by the Welsh miners who are detained here by the Immigration Commission. Officials of the contract labor law on their way to work at Ellsworth, Pa. A decision is expected by them before the hour fixed for their sailing Saturday. British Consul Powell of the Welsh Society of Philadelphia are taking an interest in the men and are doing their utmost to stop the deportation.

Too Socialistic for Union. PHILADELPHIA, Oct. 22.—At today's session of the annual convention of the International United Textile Workers' Association, the organization was re-elected to favor the collective ownership as a means of production was voted down because of its Socialistic tendencies.

Steel Plants Will Resume Work. JOLIET, Ill., Oct. 22.—Officials of the Illinois Steel Company have received orders to resume operations at the steel plants here next Monday in all departments. This will give employment to 9,000 men. The plant shut down two weeks ago.

GERMANS DRINK TOO MUCH. High Official Recommends State Aid to Reform Organization.

BERLIN, Oct. 22.—Count von Posadowski-Wehmer, Secretary of the Interior, yesterday addressed the Society for the Prevention of Abuse of Spirituous Drink and recommended granting state aid to the organization. He said: "The greatest obstacle in the physical, mental and moral development of the people is undoubtedly the excessive use of alcoholic beverages."

IN LINE FOR PEACE

GERMAN ON AMERICA'S NEED. Banker Believes Our Currency System Should Be More Elastic.

BERLIN, Oct. 22.—President Koch, of the Reichbank, discussing American financial matters, said today to the correspondent of the Associated Press: "According to my private information from the United States, the most live interest is manifested there for further reform of the currency system in the direction of greater elasticity. Your country already has taken long steps toward a sound monetary system in the repeal of the Sherman law, as well as in more recent measures. This legislation has been dictated by a determination to keep the currency "But, from our German experience, we regard elasticity as being next in importance to soundness, and as being indeed indispensable to the circulating medium of a great commercial nation, and we think it would be of immense advantage to the United States to adopt some plan under which the volume of circulation would naturally adjust itself to the monetary needs of business besides developing a check and deposit system. Whether this end would best be attained through the establishment of a single central bank, like the Reichbank, or several such banks in the important financial centers, but operated in harmony with each other in some other way, are questions which we at this distance are unable to answer, and must be determined by American conditions."

"Secretary Shaw's recent suggestion that reform be undertaken along the general lines of the German system is a gratifying tribute from a competent foreign source to the successful working of the Reichbank. Whatever may be the result of his suggestion, the Secretary's speech shows that the minds of the leading American statesmen are seriously grappling with the problem, and that they are moving in the right direction."

PLEA MADE FOR AMERICA. Argument for Preferential Treatment in Venezuelan Case.

THE HAGUE, Oct. 22.—United States Minister Bowen and Judge W. L. Penfield, Solicitor of the United States State Department, who is assisting Mr. Bowen in the Venezuelan negotiations before the Hague tribunal, have submitted to the tribunal a plea which will resume its session November 4, preliminary statements concerning the question whether the allies are entitled to preferential treatment over the United States from Venezuela in the matter of claim payments. They explain it is the most earnest wish and purpose of the United States to uphold the high character of the tribunal to advance the cause of peace and good sense they desire the most friendly and most peaceful relations between the nations. In his statement Judge Penfield says that if any government is entitled to preferential treatment it is the United States, which should share in the distribution of the 30 per cent trust fund. The warlike preparations of the allies did not benefit the United States. Mr. Bowen says that to avert the possibility of war the allies consented to present the matter at The Hague. Why the allies resorted to warlike measures, he continues, is a question they cannot answer credibly. If they did so through a lack of tact and good sense they deserve to be punished. In the opinion of the Minister, Venezuela is entitled to exemplary damages from the allies far in excess of even the combined claims against her.

LITTLE HOPE FOR ELKINS. Condition of Multi-Millionaire Is Becoming Graver.

PHILADELPHIA, Oct. 22.—It was stated tonight that after a consultation of physicians attending William L. Elkins, the multi-millionaire of this city, who is seriously ill at his home, the family of the sick man was informed that there is little hope for his recovery.

Foraker Is Recovering. SANDUSKY, O., Oct. 22.—Senator Foraker is recovering from the attack of bronchitis which prevented his speaking here last night. The Senator will leave for Cincinnati in the morning and hopes to be sufficiently recovered to fill his speaking engagements next week.

Home of General Clay Sold. RICHMOND, Ky., Oct. 22.—Whitehall, the home of late Senator Cass M. Clay, was sold at public auction today to Warfield Bennett, a grandson of the "Sage of Whitehall," for \$25,225. The five wills left by General Clay are still being contested. In the event, on which the principal contest is being conducted, General Clay provided that Whitehall should become the property of the United States Government, and that on the site a National Park should be founded.

Masons Approve Action. WASHINGTON, Oct. 22.—The Supreme Council of Scottish Rite Masons, southern jurisdiction, today approved the action of Grand Commander Richardson in protesting against the issuance of a charter for the establishment of a symbolic lodge of Scottish Rite Masons in Hilo, Hawaii, by the grand orient of Portugal, on the ground that Hawaii is United States territory and the grand orient of Portugal has no authority to establish lodges there.

Alarmed Over Bank Failure. MEXICO CITY, Oct. 22.—The local stockholders of the failed International Bank & Trust Company held about \$90,000 worth of stock, but a portion of the amount, it is said, is represented by notes given instead of cash. Now that the first excitement is over, it appears that the failure was a disastrous one and that American interests have been much harmed.

Involves Aluminum Industry. NEW YORK, Oct. 22.—A case involving the entire aluminum industry of the country was argued today when the United States Court of Appeals handed down a decision upholding the validity of the so-called Bradley patent for smelting by the use of electricity. The Bradley patent is a general one applying to the electrolysis of any material.

Decree Signed in Nipper Case. BUTTE, Mont., Oct. 22.—Judge Clancy this morning signed the decree of judgment in the Nipper case, tried before him and decided in Helms' favor.

The order refuses to grant permission to the Boston & Montana Company to make an inspection of the Pennsylvania ground through the Barus workings.

Bulgaria Dismisses Reserves. SOFIA, Bulgaria, Oct. 22.—The War Minister has dismissed the reserves of the second class and it is expected that all the reserves will be disbanded by October 27, just prior to the elections.

Roosevelt to Receive Ministers. WASHINGTON, Oct. 22.—The annual session of the general convention of the Universalist Church began here today. President Roosevelt will receive the ministers on Saturday.

AMERICA Favors Arbitration Treaty With Britain.

Barclay Sounds People

Prominent Englishman Finds Roosevelt, Hay and All Others Favorable to the Revival of the Movement.

WASHINGTON, Oct. 22.—Thomas Barclay, of Paris and London, formerly President of the British Chamber of Commerce, who is in Washington, expressed himself as favorable to the revival of the efforts to secure an arbitration treaty between the United States and Great Britain, and added he felt somewhat encouraged over the prospects. He expressed the opinion that the United States, it would be the success of the Franco-British treaty would prove helpful as a precedent, and said that, while that treaty did not cover as much ground as the treaty with the United States, it would be effective as an entangling wedge. Referring to the prospects for an Anglo-American treaty Mr. Barclay said: "At New York I had an opportunity of conferring with many of the business, and without exception I gathered that on their part a revival of the movement would be heralded with great satisfaction. Everybody I spoke to had a vivid recollection of the financial results of the famous Venezuelan dispatch of Mr. Olney, and everybody showed a disposition to do their level best to get some system adopted to prevent a recurrence of such a disaster."

"But it is in this city that I have, without exception, received the warmest encouragement. Everybody of importance here agrees that in the case of the Anglo-French movement we must not push forward with too great speed, but gradually get representative bodies of the country to show their approval and testify to the general desire of the country to consolidate the relations with Great Britain in some permanent form."

Mr. Barclay has talked with President Roosevelt and Secretary Hay on this subject.

LOOKS MORE LIKE WAR. Russo-Japanese Negotiations Take a Less Favorable Turn.

ST. PETERSBURG, Oct. 22.—A request of the Associated Press for a statement today of the Foreign Office indicating Russia's position in connection with the Far Eastern question elicited only the significant reading of a less reassuring dispatch from Tokyo. The newspapers here say the Russian Pacific squadron consists of 34 warships, including six battleships, eight first-class and five second-class cruisers, seven sailing gunboats, two torpedo-boats, two torpedo transports and 24 torpedo-boat destroyers, having an aggregate of 750 officers and 11,200 men. There are now on the way to the Far East two battleships, three first-class cruisers and 11 torpedo-boats of various classes, with 164 officers and 2,254 men.

The Novoye Vremya declares many of the most influential Japanese newspapers are subsidized by Americans and Englishmen.

RUSSIA THREATENS CHINA. Severe Punishment to Be Meted Out if Latter Sides With Japan.

LONDON, Oct. 22.—It is reported from Peking that M. Lessar, the Russian Minister, has addressed a long note to Prince Ching, head of the Chinese Foreign Office, saying that Japan's interference in the Manchurian question will compel Russia to adopt final measures, and threatening China with severe punishment if she sides with Japan. This action, while the negotiations are pending, has caused deep umbrage.

ALARMED BY WAR RUMOR. Honolulu Steamer Will Stop at Midway Island for Orders.

HONOLULU, Oct. 22.—The steamer Nippon Maru, which sailed from here today for Yokohama, will stop at Midway Island for orders through fear of capture caused by the circulation of a report here that the Japanese consulate at Honolulu had received a cipher cablegram that war with Russia had been declared. The passengers on the steamer were very much alarmed.

CONGER WILL NOT ACT. China Wanted Him as Mediator in Russian Trouble.

VICTORIA, B. C., Oct. 22.—According to advices received by the steamer Tacoma, which arrived today from Yokohama, a Peking correspondent of a Japanese paper reports that Prince Ching, the Chinese Chancellor, had endeavored to induce Mr. Conger, United States Minister to China, to offer his services as mediator between Russia and Japan, but that the American Minister had refused.

Elder Statesmen to Confer. LONDON, Oct. 22.—A dispatch to Reuters' Telegram Company from Tokyo says: "It is believed that another conference of the elder statesmen will be convened, probably tomorrow, when decisions having important bearings on the future course of events are expected, although there is no fear of an immediate rupture. In the meanwhile, precautionary preparations are progressing."

Denies Mobilization of Army. LONDON, Oct. 23.—A dispatch to the Daily Mail from Tokyo says the government has issued an official denial of the statement published in the Morning Post, a Conservative newspaper, that a preliminary mobilization order has been issued by the Japanese Army. There is a wide belief in local circles, continues the correspondent, that this denial is merely technical.

Gunboats for Niu Chwang. LONDON, Oct. 23.—The Tien Tsin correspondent of the Standard says that three American, Russian and British gunboats are preparing to go into winter quarters at Niu Chwang. Similar preparations on the part of the Japanese gunboats were stopped by telegraphic orders from Tokyo.

Russia to Call Out Special Reserves. NEW YORK, Oct. 22.—Preliminary arrangements have been completed, says a Moscow dispatch to the Times, for the expedition calling out of portions of the Russian infantry reserves. The men employed on the Russian railway system are alone exempted.

OPPOSES OPEN PORTS. PEKING, Oct. 22.—It has been announced that the Russian Viceroy of the Far East, Admiral Alexieff, is opposed to the opening of Manchurian towns to foreign trade. This has excited no surprise here. The treaty of commerce between China and the

United States, recently signed at Shanghai, provides that suitable concessions be given at Mukden and An-Lung for the residence of foreigners and for their commerce. Russia's latest proposals to China, which embody Viceroy Alexieff's policy, stipulate that such concessions be given only to Russians.

The officials of the Japanese Legation here say the negotiations at Tokyo between Russia and Japan are proceeding satisfactorily.

DEMANDS SENT TO PORTE. Russia and Austria Present Note Agreed on at Conference.

CONSTANTINOPLE, Oct. 22.—The Russian and Austrian Ambassadors today presented to the Porte notes embodying the demands agreed on at the recent conference between the Czar and Emperor Francis Joseph.

Early Developments Expected. LONDON, Oct. 22.—In a dispatch from Vienna, the correspondent of the Daily Telegraph says now that the Austro-Russian note has been presented to the Porte developments are expected to follow rapidly. The best-informed persons in Vienna, the correspondent goes on, have been assured that the Emperor's trouble this winter, but certain armed intervention is necessary before the reforms really will be enforced. Austria is strengthening her garrison in the Sanjak of Novi-Bazar, European Turkey, in which, under treaty, she maintains a military force, and is rushing the completion of the railway between Sarajevo and Mitrovica.

INSURGENTS ARE SLY. Macedonians Who Are Giving Up Could Not Stand Winter.

SALONICA, Macedonia, Oct. 22.—Recent advices from Monastir say that a considerable number of insurgents have surrendered in response to the Sultan's last call. The first of these who surrendered were beaten and imprisoned, but under stringent orders from the Yildiz Kiosk palace all the men who are now coming in are well received and have been pardoned. This, however, does not indicate the collapse of the rebellion, but is in conformity with the revolutionary committee's decision to thin out the insurgent bands during the winter and retain under arms only an aggregate of about 300 men.

The insurgents who are coming in are men of inferior physique, who could not stand a winter campaign. They leave their rifles with the leaders, who secrete them in the mountains in readiness for operations in the Spring. Not one of the leaders has surrendered. The revolutionary committee has no intention of resorting to the use of dynamite bombs in the towns this winter, but it declares that if the powers do not succeed in causing the establishment of a satisfactory form of government by the Spring every available man will be called out and the desperate struggle of gaining the ends of the revolution will probably be resorted to.

The Turks report that both Chakalaroff and Sarafoff, the insurgent leaders, were killed recently in the village of Boof, in the Florina district. The Bulgarians assert that Sarafoff is on his way to Bulgaria.

The Rev. Henry Haskell, the American missionary, has arrived at Monastir to help in the relief work inaugurated by the Rev. Mr. Bond.

COREANS MOB AMERICAN. Jaapene Accused of Aiding Him to Escape, and Are Beaten.

VICTORIA, B. C., Oct. 22.—The steamer Tacoma, which arrived today from the Orient, brought advices of excitement in that city. The city gates were hurriedly shut, the officials fearing an outbreak similar to that which was nipped at the last Chinese New Year holiday. News was received from Seoul, Corea, that an American motorman of the American Electric Railway at Seoul ran over and killed a Korean boy. He was mobbed by a number of Koreans, and to escape them grabbed a bicycle from a Japanese postman and hurried away. The Japanese was accused by the Koreans of aiding his escape and was badly beaten and a store in which he took refuge was damaged.

The sailing schooner Victoria reached Newport today from Behring Sea with 462 pelts.

RELIGIOUS WAR GOES ON. French Deputies Sustain the Policy of the Government.

PARIS, Oct. 22.—The first important move in the Chamber of Deputies resulted today in an unqualified victory for the government. Premier Combes demanded that the interpellations, of which there are many on the subject of religious congregations, be united with those on the general policy of the government, and the religious interpellations were withdrawn. The government intended, the Premier said, to carry on the war against the congregations as well as a war of free thought against slavery of the intelligence, and announced the government's intention to repeal the falloux law, thus finally destroying congregational education. The Chamber voiced its unqualified confidence by a vote of 333 to 223.

Politics Cause His Removal. BERLIN, Oct. 22.—Herr von Tschudi, director of the National Gallery, has just been removed by Dr. Althoff, chief of the Ministry of Public Instruction and Worship, that appoints university professors and supervises art. This step was probably taken because Von Tschudi leans toward the impressionists.

Political reasons are cited as the government's attitude toward the impressionists. They are looked on as being free thinkers and revolutionists.

Miners Oppose Protection. LONDON, Oct. 22.—Representatives of the Miners' Federation of Great Britain have met in conference today to consider Joseph Chamberlain's fiscal proposals, and adopted a resolution to the effect that in their opinion any change in the fiscal policy of the country would be detrimental to its general interests.

CELEBRATE HARVEST FESTIVAL Chinese Residents Seek to Placate Their Deities.

China town is just now bustling with celebration. All the almond-eyed disciples of Confucius are engaged in observing a religious occasion bearing an outlandish name, but which is the equivalent of a harvest festival. Prayers and weird music and queer ceremonies in the joss houses and the burning of beams of colored paper in the streets are the features of the celebration which will continue until Sunday evening, when it will close with a big demonstration of bonfires. All of which is intended to place the chinks in good standing with the gods and drive out the devil.

Death of Sister Mary. After being afflicted for several months with dropsy, Sister Mary, one of the Benevolent Sisters of Mount Angel, died yesterday, aged 43 years, at St. Vincent's Hospital. Her burial will take place at Mount Angel.

Widow of Rev. Charles Spurgeon. LONDON, Oct. 22.—The widow of the Rev. Charles Spurgeon, the noted preacher, who died January 21, 1895, died today.

SURPRISE TO BRYAN

Bennett Not Solicited to Bequeath Him \$50,000.

GOT \$300 FOR DRAWING WILL

Check Came at That Time, and Boy Orator Presumed It Was for Services Rendered.

NEW HAVEN, Conn., Oct. 22.—William J. Bryan again occupied the witness stand in the Chamber of Deputies when the application for probating the will of the late Philo S. Bennett was resumed today.

In the cross-examination of Mr. Bryan, Judge Stoddard, counsel for Mrs. Bennett, the widow, spent considerable time in questioning Mr. Bryan why it was that in the letter which was left by Mrs. Bennett by her husband directing her to give Mr. Bryan \$50,000 for himself and family, it was not stated that a certain part of the fund was to be given to Mrs. Bryan and part of it to the children. Mr. Bryan replied he did not know, but that it was so understood between himself and Mr. Bennett, and after Mr. Bennett's death he told Mrs. Bennett about the arrangement. The witness was asked to explain why he had received \$50 from Mr. Bennett, and he said he was paid for drawing up the will, and he stated that while there was nothing said about it, he supposed it to be for drawing up the document.

When Judge Stoddard asked the witness if Mr. Bennett had ever made any investments for him, Mr. Bryan replied he had made investments of the Common fund, buying Government bonds with the proceeds of the subscriptions which came in advance.

Lawyer Newton then asked his client, Mr. Bryan: "Was it ever suggested by yourself or Mr. Bennett that he give you the \$50,000?" "No, sir, we never suggested it. It came as a surprise to us when Mr. Bennett made the suggestion himself."

James D. Dewell, a wholesale grocer, stated that for many years he had known Mr. Bennett. He had always believed him to be a shrewd, capable business man and bore a reputation as such. Mr. Bennett, he said, appeared to be in good mental condition at the time when he last saw him, which was shortly before his death.

"Did he worship Mr. Bryan?" asked Judge Stoddard.

Witness replied: "I always knew that he held an honest opinion of him."

The case was adjourned until Monday.
