Henry Ach Takes the First Event at Oakland.

MUDDY COURSE TO HIS LIKING

Prince Brutus Is the Favorite—Constantly, 15 to 1, Surprises the Talent by Taking the Third Race.

DRAFT OF SCHEDULE.

Outline Discussed at Session of Pacific Coast League.

SAN FRANCISCO, Cal., Jan. 4.—(Special.)—The greater part of today's session of the Pacific Coast League was devoted to talk on the schedule and a rough draft of the correct way to make the best of awkward travel through irregular territory was discussed in full. A general plan was outlined and the members of the schedule committee will repair to their homes and formulate an individual idea of the best way to apportion dates. When this is finished a balance will be struck. The work of this committee was greatly simplified when arrangements were made for an equal division of holiday receipts in every city.

All of the Northern visitors were pleased at the treatment accorded at the meeting. Swigert and Cohen came prepared to fight for their rights and were treated with the utmost consideration. Swigert offered a vote of thanks for the manner in which they were treated.

It was one session of the meeting that President Bert be given more authority to enforce discipline than has been in the power of league presidents in the past. Bert may now suspend or fine an offending player without referring the case to the directors, and a mail or telegraphic vote on vital questions may be taken by him at any time.

Los Angeles was assessed an extra \$200 for Dillon's offense in Seattle. Dillon withdrew his team from the field because he was personally ordered to leave. It was ordered that 25 copies of the league rules be forwarded to each club manager to be distributed among the players. In case of infraction of rules, excuse on account of ignorance will not be tolerated in the future. It was also ordered that all fines inflicted be paid by the players at fault. A penalty of \$200 will be incurred by any manager accepting the player's burden.

Home suits will be white, as they were last year, but no restrictions were placed on colors for uniforms to be used abroad. The selection of umpires was left to Bert, and Jack O'Connell and Jim McDonald will probably be asked to officiate again. The third man has not been chosen.

The league members will depart for home tomorrow. The report that Charlie Kelly, Householder and Stricklett had been blacklisted for jumping contracts was denied. They secured others to jump and their services will not be permitted in the Coast League.

TO BRING COAST LEAGUE IN.

Hanlon Will Come West With Hart and Johnson.

NEW YORK, Jan. 4.—Edward Hanlon, of the Baltimore baseball club, has been appointed the representative of the National Association to go to California with James Hart, of the National League, and Ben Johnson, of the American League, for the purpose of inducing, if possible, the Pacific Coast organization to come in under the National agreement. Hanlon will leave for California during the latter part of January.

SEASON IS ENDED

Multnomah Met Only Two Defeats.

WEAKEST PLAY IN THE SOUTH

Great Credit for Victories Is Due Captain McMillan for Coaching and Quarterback Murphy for Generalship.

The football season of the Multnomah Athletic Club, which has just closed, has just one blot on it, the California games. Otherwise it was entirely successful. Excuses for the defeats by Berkeley and Stanford have never been attempted, but there are one or two. The eleven did not have half the team work it showed at the end of the season, and Kerrigan, the quarter, should have been on crutches. These two facts are sufficient to account for what were not bad defeats by the California universities.

All the rest of the season was satisfactory. And with the exception of the California games, all the club's games were played on Multnomah field, making a clean record of no defeats on the home grounds. The best contest of the whole season was undoubtedly the Washington game, in which both eleven fought till they were shaky in the legs, when Multnomah, with Chester Murphy managing the plays, made a dash for goal, in a series of fast, well-executed plays.

The Oregon game was much less snappy, but the All-Oregon team alone of all the teams that played in Portland this year did not allow Multnomah to score at all.

In the Reliance game the home team had reached its best form, and though Reliance was far from weak, by consistent short gains Multnomah scored three times, only the last touchdown being made without hard work.

The making of a team generally rests with the captain, and a great part of Multnomah's success is due to George McMillan. He is a man who never becomes excited, always keeps his head and comes out of a game as cool as when he entered. His quiet manner never seems to change in the most violent plays, but his ability to gain ground with the ball and to break up the opponent's plays shows that he has much more force than is apparent on the surface.

Almost, if not quite as much, of the team's success was due to the generalship of Murphy on the field. Murphy made his fame as quarter and field captain at Stanford and later on the Harvard Law School team, and he is capable enough at the position to make any college team in the country. His work on Multnomah field at crucial moments of the game has often materially affected the score. Multnomah could hardly have had a better field captain.

But the stuff that the players themselves are made of is what saves an athletic club team. With college teams coaching counts more than anything else, but athletic club players never receive rudimentary coaching; they are supposed to know the game. The Multnomah team was com-

posed mostly of old, well-trained men, but there were some notable developments, principally that of Corbett and Ross.

The list of men who played the various positions on the Multnomah team the past season shows the constantly shifting squad the captain has to contend with. It also shows the ease with which some of the older players, like McMillan, played one position or another.

HURDLED THE TACKLE

SPECTACULAR PLAY OF TEABO IN CHEMAWA-RELIANCE GAME

California Team Beaten 16 to 0 by the Indians at Salem—Visitors in Poor Form.

SALFEM, Or., Jan. 4.—(Special.)—Chemawa Indian School defeated the Reliance team, of San Francisco, on the Williamette University grounds this afternoon by a score of 16 to 0. After a good kickoff by Chemawa, Reliance got the ball and carried it by steady plunges to within four inches of the goal. In an effort to make a touchdown, the ball slipped and Chemawa secured it. This mishap seemed to break up the Reliance team, for they did not again get the ball dangerously near the goal. Chemawa made one touchdown and kicked in the first half. In the second half the Indians increased the score to 16 by making two touchdowns. The field was sloppy and, as a rule, the game was devoid of sensational plays.

One event, however, threw the spectators and players into the wildest cheering for Teabo, who covered himself with glory last summer when catching for the Chemawa line. Reliance had made a 2-yard punt and Teabo caught the ball. A Reliance man met him as he sped down the field and stooped for a tackle. Without an instant's hesitation, Teabo leaped into the air and went over the adversary without touching him. His leap was a full four feet from the ground and when he alighted, he sped on as if nothing had happened. When he had carried the ball back near the line from which it was punted, he was caught while attempting a second hurdle. The lineup was:

ODD WILL OF SISTER. Fortune Is Left Broker, and Friends Think Convent Is to Get It.

PARIS, Jan. 4.—The Chilean Consul is investigating the remarkable affair of Maria De Pal Luz Cosimo, a Chilean unmarried woman, who died recently in the Convent of the Assumption at Passy, where she had been educated. She had not taken the vows of the sisterhood, but wore the novice's robes.

By her will, the woman bequeaths a fortune estimated at several millions to Roland Gosselin, a Parisian stock broker who, it is alleged by those who have brought the case to the attention of the Chilean Consul, is a mere cover for the convent. This, however, is denied by Gosselin, though he says he is not aware why the fortune should be left to him. The mother superior of the convent denies having any knowledge of Gosselin, or of the motives which actuated the woman in making her will.

Young Men Murdered Woman. DENVER, Jan. 4.—Frederick O. Arnold, Newton A. Andrews and Charles O. Peters, aged respectively 15, 22 and 24 years, pleaded guilty when arraigned in the Criminal Court this afternoon to an information charging them with the murder of Mrs. Anamanda Youngblood, who was shot dead at her home in Valverde last Thursday night. Their trial was set for Wednesday.

Ingersoll Stanwood. ST. HELENS, Or., Jan. 4.—Ingersoll Stanwood, an old resident of this section, died at his home at Yankton, last night, aged about 70 years. He left several grown-up children, but his wife had been dead for several years. The funeral will take place in Clark County, Washington, tomorrow.

Young Randall Named for Congress. PHILADELPHIA, Jan. 4.—Samuel J. Randall, son of the ex-Speaker of the House of Representatives, was nominated for Congress tonight by the Democrats of the Third District, to succeed the late Henry Burke.
