VALUE OF THE POULTRY BUSINESS.—Many of the strangers in the city attending the livestock and other conventions have been making critical examinations of the markets here and have had many flattering things to say about the fine quality of the poultry and eggs produced in this country. It is supplied. They also have looked into the pork-packing business here and were very favorably impressed with the quality of the hams, bacon and lard produced here, and especially with the style in which the hams were cut and trimmed. Some of the ladies were especially pleased to note the absence of any small or cottony adulterations in the lard. One Kansas man, however, who is largely interested in poultry raising as well as in cattle, could not express his admiration of the fine display of fine clean, dry-picked poultry displayed by dealers at this season, just after having gone through the strain of supplying the holiday markets. He utterly astonished several by stating that the poultry products of this country is point of importance and value completely throw the livestock business in the shade and more than that asserted that the value of the poultry and eggs produced in this country exceeded that of all the wheat raised here.

DEATH OF INDIAN WAR VETERAN.—Turner Chatman, an Indian War Veteran, died at the Good Samaritan Hospital, January 12. He was born in Kentucky in 1817, and came to Oregon in 1852. He served in the Indian war as a member of Captain William A. Carson's Company, 1st Regiment, 1st Cavalry, and was with the Mounted Volunteers in the Indian War of 1855-56. After his discharge from the service Mr. Chatman lived at The Dalles, Or., for 17 years, since which time he resided in Portland. He was married to Mrs. Margaret Price in November, 1867, who died on February 25, 1900. Several step-children survive him, but no far as is known he has no blood relatives on the coast. The funeral services were held at Dunning's Undertaking Chapel and his remains were interred at the Lone Fir cemetery. The pallbearers were: Captain J. H. McMillan, B. Stuart, Samuel Wishard, L. M. Parrish and T. A. Wood.

INJURED BY PAROL MATCH.—A red-eyed man was going about town yesterday with his hand in a sling made of a red silk handkerchief, owing to injuries received by the head flying off a so-called parol match, which he struck on the wall to light his pipe when lying on a lounge in his room. The little match, which he had lit, burst into a blaze with such suddenness that his hand was badly burned before he could get on his feet. He is unable to explain how the lounge burst into flame so suddenly and furiously. At all events, it was only by the most lively rustling that he was able to save the house from being burned down, but his lounge went up in flames and he is now on the warpath after big red-headed parol matches, and proposes to secure the enactment of a law to prohibit their use in Portland, as has already been done, he says, in Chicago and some other Eastern cities.

LEVEL ON SWERNEY.—The improvement of three blocks on Madison street between Second and Fifth streets, by laying a vitrified brick pavement, has been completed by Contractor Sweeney, and he was at the City Engineer's office yesterday morning, anxious to have the work accepted. Sweeney looked a little jolted at this remark, and a friend to cheer him said: "Never mind, these fellows will all be let out next June." "That can't be done now," said a bystander. "They have passed an examination and hold their positions under civil service rules."

HOME FOR HEPPNER ORPHAN.—Ada Morris, a little girl whose age is yet numbered by months, was taken into the Boys' and Girls' Aid Society's home yesterday at the suggestion of the Yamhill County Court, which was solicited to appoint a guardian for the little child. The child is exceptionally bright and pretty, lost her parents in the Heppner flood and was only prevented from being drowned herself by her nurse, who managed to escape the torments. Since then the child has been cared for by Mrs. Elizabeth Florey, who, after having the little one eight months, asked the County Court to provide a permanent home for the child.

BLIND LEAD THE BLIND.—Yesterday a man was seen crossing Alder street to the Oregonian building having hold of the hand of a boy whose eyes were covered by a bandage and whose face was scarred in many places. Another man wearing large smoked glasses which quite concealed his eyes, had the boy by the other hand. A man on the sidewalk spoke to the man whose eyes were open and, expressing sympathy for the others, asked what was the nature of their trouble. He was shocked to learn that they were both entirely blind. The man in charge of the two unfortunates apparently was being shown around town by the blind man, and the boy was the son of the other. W. W. Reese, of Prairie City, Baker county, to unravel the circumstances which brought them together was quite a long story. The blind man was Charles Nebergall, of this city, whose sight was ruined by a burning of a common bottle of pop soda seven years ago. The blind boy was Albin Reese, the 12-year-old son of Mr. Reese, whose sight was instantly destroyed by the explosion of a box of dynamite caps which a man was showing him. Mr. Reese used to live in Baker City, and so did Nebergall, who knew him and the boy, even a little chap. Nebergall was at the Blind School in Salem two and a half years, and has since that time been in the clear business here. The boy is now attending the Blind School, and his brother, who was visiting him, brought him down here for a pleasure trip and they met Nebergall, who took a run up to Woodburn Sunday to "see some friends." The sight of these two blind persons naturally created great sympathy for them, but of this they had little need, as both were as lively as possible. Nebergall said being blind amounted to nothing, and he used to it, and the boy apparently felt the same way. They learn to dance at the Blind School as well as to read and write, and Nebergall said he did not take a back seat for any one when it came to dancing, and especially in the waltz. He can run a cigar store as well as any one, and thinks he can get along in almost any kind of business.

Han Burt, a wayward home—a man who had been away from Portland for several years and who has lately returned was walking up Third street yesterday looking curiously around at the many changes in the city, and in the old acquaintances he met. Finally he encountered W. K. Smith and stopped to shake hands and congratulate him on his youth and vigorous appearance. Mr. Smith said he was 75 years old and was feeling pretty well and while admitting that the frosts of passing years had whitened his once raven locks, said he could still put up with the world. "Are you really in earnest?" asked the surprised man. "Oh, yes," said Mr. Smith. "I can place my hands on the sidewalk and flip over my hand on my feet more than once." As he is still considerably over six feet in height and slender and rambled, the friend gazed at him in wonder and was about to ask him to stop, when he suddenly remembered the consequences of a misadventure and a fall, so Mr. Smith continued his way unharmed. The next man he returned traveler met shook hands with him warmly and said he could still put up with the world. "I don't seem to remember you," was the reply. "Did I ever hear anything good of you?" "Well," said the fellow, "I used to tend bar for Johnny Morgan, First and Stark streets and in 1882 I was elected a Constable for Multnomah County on the Democratic ticket, the only man on the ticket elected." "Well," said the returned traveler, "I am not certain that that much to your credit, but shake and let's take a drink."

MADE ERROR IN HIS WILL.—The story published yesterday in regard to the misadventure of a man who desired to be buried bi-annually attracted the attention of a number of employees about the County Courthouse and started a discussion in regard to the use of "bi-annually" as a word. It is a word which is used by some people to mean "biennially," but it is not a word which is used by the law. The word "biennially" means "once in two years," and it is the word which should be used in a will. The man who made the error in his will was a man who died some years ago. In distributing his property, he devised that if his son, Ernest Edward Hamilton, should be imprudent in regard to spending money, the administrator of the will should not invest his share of the property that he would receive the income from it bi-annually. This was interpreted so that the boy received his income only once in two years, and there has been some trouble over the matter, as the boy's friends insist that it was intended by his father that he should receive a dividend twice a year. A strange feature in connection with the affair is that in placing the will on record a slip of the pen or correction was made in writing the word "bi-annually" but it is still plain in the original will it is "bi-annually" plain enough. The Century Dictionary gives the definition of bi-annual and bi-annually as occurring twice a year, and adds that bi-annually is distinguished from biennially. On another page it gives the definition of "biennially" and "biennially" as "taking place once in two years."

CIVIL ENGINEER'S BODILY OVERT.—C. H. Lorraine, the civil engineer who was arrested with a collection of 25 forged checks in his possession, after having attempted to pass several of the worthless papers, was remanded to the grand jury yesterday. Men May Present Ultimatum.

YOUNGSTOWN, O., Jan. 14.—A final meeting of the 1200 employees of the Ohio plant of the Carnegie Steel Company will be held Saturday night, at which an ultimatum will be prepared and presented to the company. Upon its acceptance or rejection depends, the men state, the question of whether they shall continue at work or strike. The wages of the men have been cut 6 to 7 per cent, and they are unwilling to accept such an extensive reduction.

Steelworkers to Be Paid Less.

CHICAGO, Jan. 14.—Notification of a cut in wages ranging from 5 to 46 per cent has been given to the skilled steelworkers of the Illinois Steel Company's plant at South Chicago. Only 100 men are involved, but their wages for an eight-hour day range from \$8 to \$15.

SOCIETY TO OSTRACISE THEM.

Wearers of Low-Neck Dresses, Divorced Folk, Etc., Under a Ban.

NEW YORK, Jan. 14.—Social ostracism for divorce and wearers of décolleté gowns, gamblers, including players of bridge, whist, and users of liquors, is the object of a society which has been organized under the name of "Daughters of the Faith." Its purpose is declared to be to "discontinue these usages and customs that are the evident causes of the spread of moral evil in society." Women of the best families and most distinguished Catholics in New York City are among the charter members. The most severe restrictions are contained in the manual, open only to members, which contains a foreword by Cardinal Gibbons, Monsignor Falconi and Archbishop Farley.

Military Cuts His Liberty Short.

CHIPPENHAW, Colo., Jan. 14.—Sherman Parker, one of the men charged with complicity in the blowing up of the Victor mine some time ago, was released on \$10,000 bonds, this evening, but was immediately re-arrested by the military. It is not known what the next move of the defense will be.

GEORGETOWN, Colo., Jan. 14.—The jury in the case of the union miners charged with conspiracy to destroy the buildings of the Sun and Moon mine at Ashcroft Springs, retired at 4:30 this afternoon.

CABMEN'S STRIKE IS RESUMED

After Truce of Fifteen Days, Chicago Men Quit Work.

CHICAGO, Jan. 14.—The strike of heavy drivers began anew today, after a truce of 15 days, following the fire of a car. Twenty-five per cent of the 1600 drivers of cabs and hearse were said to be out, and only the black underground wagons were put into service in lieu of hearse at funerals, while mourners were obliged to resort again to the street-cars in journeying to and from the cemetery. Failure of employers and employees to agree on a wage scale was the cause of the resumption of the strike.

To avoid the distressing interference with the burial of the dead, witnessed at the beginning of the strike, a modification of the strike order was made, and before the day was over hearse men by union drivers were at the call of every funeral in the city.

Subway Men May Walk Out.

NEW YORK, Jan. 14.—A general strike of 3000 men employed on the Rapid Transit subway, may grow out of trouble with a small force of the layers. Fifty of the latter have quit, and the workers on a powerhouse in Fifty-ninth street followed by presenting an ultimatum declaring that unless the nonunionists now engaged in
