## Remains of Hanna Arrive in Cleveland.

## MANY PAY HIM RESPECT

## Catafalque Surrounded by a Garden of Flowers.

## MILITIAMEN ARE ON GUARD

People Do Not Mind Severe Weather and Long Wait in Line to Secure Last Glimpse at Face of Dead Statesman.

CLEVELAND, Feb. 18.—The mortal remains of Senator Marcus A. Hanna were in state upon a shrouded catafalque in the auditorium of the Chamber of Commerce, where they were taken immediately upon their arrival here from Washington today. The catafalque is surrounded by a veritable garden of flowers and guarded by a detail of soldiers from the state militia. From 10:30 to 11:30 tonight fully 30,000 people passed the flower-covered casket and took a last look upon the features of the dead statesman.

With snow blowing in their faces through a cold wind chilling them there, thousands upon thousands of people stood for hours in a double line stretching for more than five squares, waiting for an opportunity to pass into the building.

At 9:30 o'clock tonight Memorial Post, G. A. R., of which Senator Hanna was a member, marched to the Chamber of Commerce in a body and in the presence of their dead comrade conducted the ritualistic service of their organization. After this service the catafalque was closed, members of Troop A remaining to guard the body during the night.

Upon the request of many friends of the Hanna family, Bishop Leonard will deliver a short eulogistic address at the conclusion of the regular funeral services tomorrow upon the life of the dead statesman. Bishop Leonard will be assisted in the services by Rev. William Pierce, president of Kenyon College, at Gambier, O.; Rev. Dr. McGrew, of St. Paul's, and Rev. A. H. Jones, of St. John's Church, of this city, of which Mr. Hanna was a vestryman.

At the close of the services at the church the body will be conveyed to Lake View cemetery, and after a brief burial service in Wade vault, will be placed temporarily in the Wade vault, it not being yet decided where the body shall finally be interred.

The remains of the late Senator Hanna arrived early today over the Pennsylvania Railroad. Snow storms at intervals made the day a gloomy one. Not since the body of the martyred Garfield lay in state in this city have there been such a deep and sincere grief. A large crowd was assembled about the depot when the train arrived.

At Salem, members of Governor Herrick's staff joined the funeral party of which the Governor had been a member from Washington. When the members of his staff had joined him at Salem, near the state line, the Chamber of Commerce committee soon alighted, followed by members of the funeral party. The family and immediate friends who occupied the private car were last to leave the train.

Mrs. Hanna, Dan Hanna and wife, Joseph Medill McCormick and wife, Harry Parsons and wife, Secretary Elmer Dover and wife, Miss Mary E. Phelps, niece of the Senator, Mrs. Frances Baldwin, a sister, and her husband, Governor Herrick, Bishop Leonard and Andrew Sculer. The members of the family immediately entered carriages and were driven to the home of Dan H. Hunt.

The handsome black casket, completely covered with flowers, was then taken from the car through one of the large windows by two men in civilian dress, by pallbearers, who carried the body through the depot and deposited it in the funeral car. Troop A, which will act as escort at the funeral, was at the depot, drawn up in two platoons, when the train arrived.

When the casket had been placed in the funeral car and the members of the committee and friends had been assigned carriages, the cortege, headed by a platoon of police, followed by Troop A, on black horses, moved for the Chamber of Commerce building, where the body will lie in state until Friday noon.

All along the line of march the reverence, respect and love felt for the dead Senator was shown. Men stood with heads bowed in almost blinding snow, while the cortege passed, and many eyes were filled with tears.

At the Chamber of Commerce building an immense crowd awaited the coming of the cortege. The Chamber auditorium, where the body now lies in state, is appropriately draped for the occasion.

Beneath a canopy of black staves the catafalque upon which rested the remains of President McKinley at Canton, Ohio, was placed. It was a simple but dignified structure, and it was thought fitting that the same bier should be used for Senator Hanna that did service for President McKinley.

The auditorium where Senator Hanna's body lies in state has been made beautiful with rich floral decorations. At the head of the bier stands a pillar eight feet high, composed of tiles of the valley, violets and ferns. This is from the United States National Bank, of which Mr. Hanna was president. Among the other handsome offerings is a piece six by three feet from members of Memorial Post, G. A. R., of which the Senator was a member. The city mail carriers sent a facsimile of a letter, six by three feet. The face of the letter contained this inscription: "Senator M. A. Hanna, Cleveland, Ohio." It was postmarked "Washington, February 18, 6:40 P. M., 1904."

Long before the hour set this afternoon for opening the doors to the public, a throng of people gathered eager to gain admittance. When the doors were finally opened, the crowd numbered close to 3000 people, the line stretching out for a block and a half. A driving snow storm had no effect in diminishing the large number of waiting people.

Ohio People Pay Him Tributes.

ALLIANCE, O., Feb. 18.—The special train bearing the remains of the late Senator Hanna pulled into the station here at 9:30 A. M. today, and departed after a brief stop. A large number of persons were at the station to silently pay their respects to the dead statesman. At Salem, near the state line, the Governor's staff boarded the train to accompany the funeral party to Cleveland.

## Roosevelt's Absence Explained.

CLEVELAND, O., Feb. 18.—Elmer Dover, private secretary to the late Senator Hanna, said tonight, replying to the many queries as to why the President did not come to Cleveland to attend Senator Hanna's funeral, that it was the wish of the President personally to do so, but after conference with members of the Cabinet, he realized that to do so would establish precedent that he could not always comply with the instance of the death of others of equal rank.

## PANAMA IS THEME.

## Senate Again Discusses the Panama Canal Treaty.

WASHINGTON, Feb. 18.—The Panama question again today was the uppermost topic in the Senate and Spooner spoke on that subject during the greater portion of the day's session. He discussed many phases of the subject, sustaining the course of the President throughout the proceedings resulting in the Republic of Panama. He was interrupted frequently by Morgan.

Early in the day Tillman moved to reconsider the vote of last Monday by which the bill to grant \$150,000 to ex-Queen Liliuokalani was defeated, but further consideration of the matter was not pressed at the time.

The Senate adjourned until Saturday on account of Senator Hanna's funeral, which will take place tomorrow.

Spooner contended that in making a strenuous effort to secure the Panama route, the President had only undertaken to carry out the preference for Panama, and on this account he could not understand why the President should be so harshly criticized for his course.

Morgan said he had been among those who had accused the President of "tampering with the Spooner law," and during the remarks that the act had seemed to him like an act of bad faith.

Spooner replied that Morgan himself had voted to fix a definite time in which to enter upon negotiations with Nicaragua, and he said the time fixed in that amendment had not expired when the Hay-Bunau-Varilla treaty was sent to the Senate. Spooner discussed at some length the failure of the Hay-Herran treaty, and during his remarks on that point Morgan said that his position on that treaty had been vindicated.

"The fact remains," said Spooner, "that the Senate from Alabama was the only American country while the treaty was under consideration at Bogota."

"That," replied Morgan, without rising from his seat, "is not the first time that Panama has ever accused of quibbling."

Spooner said that he had observed that whenever our ships were in the vicinity there were also French ships there. "I have no doubt," he said, "if on August 12 the President had abandoned Panama, and gone to Nicaragua there would still have been ships there, although they would not have been ours."

"What would they have done?" Morgan asked.

"They would have taken care of French interests, just as all governments are expected to protect their interests," Spooner replied.

Without concluding, Spooner suspended his remarks at 2:30 and the Senate went into executive session, adjourning at 2:30 until Saturday.

When the Senate met this morning a request for an extension of the time until Monday, on the motion to reconsider votes which had been cast last Monday, and no objection being made, the order was entered. The order is in the interest of the bill to pay \$150,000 to ex-Queen Liliuokalani, which it is understood is to be responded by a motion to reconsider.

A few minutes later Tillman, who voted against the Liliuokalani bill entered the Senate, and he said he would not vote for it because the friends of the bill consider that the "snap judgment" had been taken. The motion was not taken up for consideration.

The Senate adopted the joint resolution directing the Secretary of Commerce and Labor to inquire into the claim of the Wales Island Packing Company on account of the recent decision of the Alaska boundary commission concerning Wales Island in Portland Canal, Alaska.

The Senate then adopted without objection a resolution offered by Morgan calling upon the President to supply such information as he may have relative to the present state of the organization of the government of Panama, a copy of the constitution of the said republic and to inform the Senate as to any ordinance or any other proceedings of the constitutional convention recently in session in Panama relating to the Hay-Varilla treaty.

Spooner then spoke on the isthmian canal question. He defended the President against attacks upon his course in connection with the rebellion in Panama and said that the criticism of the present executive is not severer than his predecessors, and he predicted that he would be fully vindicated by history as his predecessors had been.

Spooner also discussed the relative merits of the Panama and Nicaragua routes, contending that the advantages were all in favor of the Panama route.

## Hebrews Speak for Resolution.

WASHINGTON, Feb. 18.—The House committee on foreign affairs today authorized a favorable report on the Hitt resolution authorizing the President to correspond with the governments of the principal maritime powers with a view of incorporating into the permanent law of civilized nations the people of the exemption of all private property at sea, not contraband of war, from capture or destruction by belligerent powers. The Goldie resolution, declaring the sense of the American people that Russia should not restrict the privileges of American citizens, because they were Jews, was taken up by the committee, but no action was taken. Representatives Goldie and Harrison, of New York, were heard in favor of the resolution, as also was Simon Wolf, representing the B'nai B'rith.

## Reorganizing Army Corps.

WASHINGTON, Feb. 18.—Secretary Taft has sent to Congress for introduction a bill providing for an increase and reorganization of the medical corps of the Army. There have been some differences of opinion among the Surgeon-General and the general staff as to the increase to be allowed and Secretary Taft has framed a compromise bill providing for 15 surgeons with the rank of Colonel, 24 with the rank of Lieutenant-Colonel, 130 Majors and 300 Captains and Lieutenants.

"A number of Japanese refugees from Port Arthur, who arrived recently at Chefoo on board the British steamer Wenchow, give in the form of a diary an account of their treatment while at Port Arthur, as follows:

"February 8.—The Japanese were forbidden to embark on the British steamer Wenchow. All the Japanese were prohibited from leaving the harbor.

"February 9.—Eight Russian soldiers were sent on guard over the Japanese on board the Wenchow. None of the Japanese was allowed to land. The Wenchow was detained and some 20 Japanese on board are about to starve.

"February 10.—After appeals to Viceroy Alexieff, ten bags of rice and some biscuits only were sent to the ship in the evening."

"February 11.—No food was taken by the Russians of our repeated signals: 'No drinking water.'

"February 13.—Renewed appeals made to the Russians to give some food at least to the infants and sick women. One hundred and three Japanese boarded the Wenchow from Harbin. On their way they were robbed of all their baggage and rendered penniless. There are now 300 Japanese on the Wenchow, and their distressed condition is beyond description."

"February 14.—At 3 P. M. the Wenchow was allowed to starve.

"February 15.—Arrived at Chefoo in the morning.

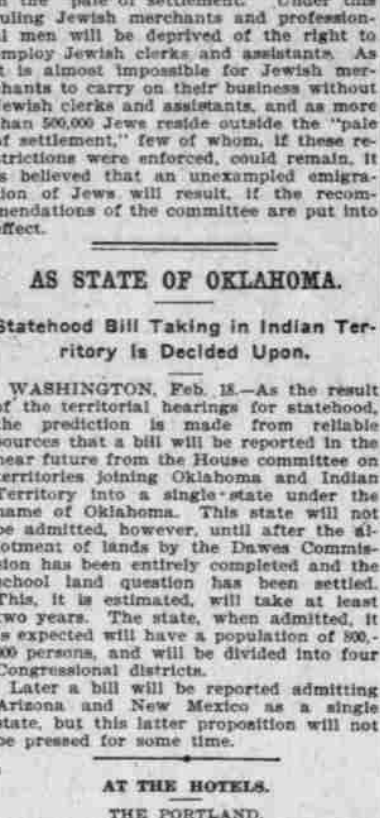

He also won a Hunt Club cup in a special race, and is therefore eligible.

The race will start Monday from the Piedmont water tower, at 2:30, and through the courtesy of the Irvington Fair Association the finish will be on the track in front of the big grandstand. This will enable the spectators to see the race in any kind of weather.

## PRESIDENT IS WANTED.

## Lyons May Fill Position for the Browns.

Just as soon as the incorporation papers of the Portland Baseball Company have been returned from Salem, where they were sent to be filed, the work of reorganizing the Browns will be taken up. The first thing that will be taken up will be the election of officers, and since it has become known that the reorganization means new officers there has been considerable speculation as to who would be the next president.

Yesterday Manager Ely was chosen president at the annual meeting. He accepted the office under protest and while he is willing to take an active part in directing the destiny of the Browns, he will not be willing to serve the club in the past. The president of the club is an important one and has a great deal of work and worry attached to it, and since it is known that Mr. Ely is willing to side step the duties of the office, he has been asked to resign. At present there are two men who would fill the bill, Ed Lyons and Ben C. Ely, who, with his brother, Fred, owns a half interest in the team. Since the Oregonian announced that Mr. Lyons would be one of the largest stockholders in the club, outside the Elys, the fans have been talking for him as president. Mr. Lyons, owing to the fact that he has been identified in the past with local baseball, and on account of his wide acquaintance, would make an ideal president. Ben Ely is not a new beginner in the game by any means, but he has only recently arrived in Portland, and it is the opinion of many of the fans that the president should be a man who is well known. It matters little, however, which of the men are chosen, for both are well fitted for that responsible berth.

## TELL OF RUSSIAN CRUELTY.

## Japanese Refugees Recount Their Bad Treatment on Board Ship.

LONDON, Feb. 18.—The Japanese Minister today gave an official cablegram received from Tokyo as follows:

"A number of Japanese refugees from Port Arthur, who arrived recently at Chefoo on board the British steamer Wenchow, give in the form of a diary an account of their treatment while at Port Arthur, as follows:

"February 8.—The Japanese were forbidden to embark on the British steamer Wenchow. All the Japanese were prohibited from leaving the harbor.

"February 9.—Eight Russian soldiers were sent on guard over the Japanese on board the Wenchow. None of the Japanese was allowed to land. The Wenchow was detained and some 20 Japanese on board are about to starve.

"February 10.—After appeals to Viceroy Alexieff, ten bags of rice and some biscuits only were sent to the ship in the evening."

"February 11.—No food was taken by the Russians of our repeated signals: 'No drinking water.'

"February 13.—Renewed appeals made to the Russians to give some food at least to the infants and sick women. One hundred and three Japanese boarded the Wenchow from Harbin. On their way they were robbed of all their baggage and rendered penniless. There are now 300 Japanese on the Wenchow, and their distressed condition is beyond description."

"February 14.—At 3 P. M. the Wenchow was allowed to starve.

"February 15.—Arrived at Chefoo in the morning.

"It is also reported that there is a general disorder at Port Arthur, mounted Manchurian bandits and Russian soldiers are all armed to protect themselves from plunder by Russian soldiers."

## Attell Wins From Hermann.

CHICAGO, Feb. 18.—Abe Attell, the California featherweight, won a decision over "Kid" Hermann in a six-round contest here tonight. Attell had a shade the better of the fight from beginning to end.

## Patient for Insane Asylum.

SALEM, Feb. 18.—(Special.)—Mrs. Amanda Allen, aged 75 years, was brought to the asylum today from Grant's Pass.
