ANTHONY CAN BE A PARENT.—Rescued from a life of vice, little 7-year-old Irene Stinson will be turned over to the Boys' and Girls' Aid Society to be properly cared for. Her father, who was arrested last week, is not content with life on a farm, and prefers the more exciting ways of the city. And only the most exciting parts of Portland are fast enough for her, for she was picked up yesterday in a Fourth-street crib where she had her little girl with her. The matter was first reported to Officer Hawley, of the Boys' and Girls' Aid Society several weeks ago. The father, he was told, did not like the life in the city, and he continued to love his wife, however, despite her questionable ways, and made frequent visits to the city, spending several days with her. Each time he was taking the little girl, and allow her to be kept amid surroundings of vice until he was ready to go back to his farm. Officer Hawley watched the case until he was sure the father was together, and then made the arrests. On the police docket Irene is designated as "rescued girl," while the mother is charged with a violation of the city statute by having a child in such surroundings.

RUSTLING NEW MEMBERS.
 Special Committee of Multnomah Club Will Report on Plans.

A smoker at the Multnomah Club has been announced for next Friday evening. Besides the social, the special committee of the club, for the purpose of devising a plan for obtaining new members, has been working hard. The committee has been successful in securing a number of new members, and will announce this to the members of the club on that occasion. For that reason it is anxious to see as large a crowd as possible at the smoker.

JAMESTOWN COMES NEXT.
 Centenary of First English Settlement to Have an Exposition.

OREGONIAN NEWS BUREAU, Washington, Feb. 21.—(Special.)—The State of Virginia, which contemplates holding a Jamestown Exposition in 1907, has been less modest than Oregon in seeking Federal aid. A few days ago she was introducing appropriate \$200,000 for the Government exhibit and National co-operation. The directors of this exposition assert that they have recently raised \$100,000 at the annual Legislature and appropriated \$200,000, and the cities of Tidewater, Virginia, have pledged themselves to raise \$200,000 more.

General Fitzhugh Lee, the president of the Jamestown Exposition Company, was in Washington last week conferring with members of the Virginia delegation relative to securing legislation for their exposition, and said in an interview:

"We claim that we are not only going to celebrate the most important historical event in the history of America, next to the discovery of this continent, but also that in other respects it is unique and stands alone. While a great many expositions have been held throughout the country to celebrate important events, none of them can be compared in this respect with the historical event to be celebrated in 1907, namely, the first permanent settlement on this continent by English-speaking people."

General Lee quoted from a letter written by ex-President Cleveland heartily endorsing the Jamestown Exposition and commending it to the consideration of Congress as a project worthy of National recognition. The ex-President closed his letter by saying: "I hope that nothing will be lacking to make the exposition successful as an agency for the stimulation of our National pride and the increase of our faith in free institutions."

General Lee also quoted from a speech made by President McKinley at Buffalo just before he was shot, in which the late President said:

"Expositions are the time-keepers of progress. They record the world's advancement. They stimulate the energy, enterprise and intellect of the people, quicken the human genius. They go into the home. They broaden and brighten the daily life of the people. They open mighty storehouses of information to the student. Every exposition, great or small,

has helped to some onward step. Comparison of ideas is always educational, and as such instructs the brain and hand of men."

"Friendly rivalry follows, which is the spur to industrial improvement, the inspiration to useful invention and to high effort in all departments of human endeavor."

General Lee concluded by saying: "If the British colonists had not 'stuck' at Jamestown, the history and map of the continent would in all probability have been different from what it is now. In other words, the probabilities are that there would never have been a George Washington, a Thomas Jefferson, or a Louisiana Purchase. Then, too, there might never have been any landing of the Pilgrim Fathers at Plymouth Rock, or elsewhere, because their attention was turned to America by the fact that English-speaking people had already effected a successful settlement here."

NEARLY WHIPPED THEM BOTH.
 "Speck" Hurlburt and "Mysterious Billy" Smith Catch a Tartar.

Baseball players with fighting records, or even prizefighters of bygone fame, were unable to instill fear into the heart of J. C. Dale. In a fast-to-night fight last night with "Speck" Hurlburt, Portland's noted fielder, this unassuming young gentleman is said to have shared the honors equally, and witnesses declare that but for the interference of a blue-coat the victory would have been his. "Mysterious Billy" Smith, who in his time has punished heavy-weight fighters until the sponge went up, was Hurlburt's companion, and had something to say in the mix-up.

"Take that!" cried Dale, and Billy, whose defense was not exactly adjusted, received a resounding whack for his suggestion.

The fighters gave no special reason for the encounter. The prizefighting hero and the ball-player had been drinking during the evening. Dale declares that they picked upon him, and were going to give him "a thrashing he would remember." However, they met in Albina. Bluffing did not go with Dale, and he stood his ground.
