Ballinger Expected to Have About 2000 Plurality

IN SEATTLE CONTEST TODAY

His Success Will Mean the Administration's Influence Will Be Thrown Against McBride-Town Will Continue Open.

SEATTLE, March 7.—(Special.)—R. A. Ballinger will be elected Mayor of Seattle tomorrow. His election means that what ever influence the administration will have will be thrown against McBride in the canvass for Governor. Whether it will be given Dr. J. J. Smith depends upon the attitude of the Great Northern and Pacific Coast Company, at present neutral in the gubernatorial fight. Neither of these companies has endorsed Smith, though both of them are opposed to McBride.

Ballinger is pro-railroad in sentiment. He has not pledged himself even to the men that brought him out, but this is not necessary. His position on state issues is well known.

Politicians have leaped to the conclusion that Ballinger's election means a boom for Sam Piles for Senator, a conclusion based upon theory and wrong in its conception. Neither the Great Northern nor the Pacific Coast Company are with Piles, and without their support he would not be a serious candidate. Naturally, Ballinger would not contribute to the fight of a losing Senatorial candidate.

It is reasonable to assume, in view of the fact that Ballinger has pledged himself to keep his hands off, that the Senatorial fight will be fought out without his interference. In the event that one of the two Senatorial candidates should withdraw, Ballinger can be counted upon to support the other. In the meantime, the King County mix-up will remain the same as though some one else had been elected Mayor.

There is little prospect from Ballinger's election of a change in the Mayor's policy toward the saloons. Ballinger is not regarded as a pro-gambling man, and these interests may be compelled to knuckle down to an opposition policy, but he will make the town as nearly wide open as possible without an alliance with violators of the felony laws.

Tucker's election tomorrow means, despite promises to the contrary, a closed town. Tucker has never given personal sanction to the deals with the gambling and saloon element, and he cannot be expected to deliver his administration to their assistance. He might be more liberal than Ballinger with the saloonkeepers, but even this is doubtful. The two men mean the same in administrative policies.

The size of the Seattle majority for the Republican ticket tomorrow has little effect upon state issues. Tacoma will be split up next month because of bitter personal fights, and the past municipal elections have shown the effect of local issues. The state is overwhelmingly Republican, and despite the effort to make Seattle the key vote tomorrow, the city campaign will be decided on local issues. It is merely a question whether or not the voters believe in Ballinger.

Tonight, the Republicans overwhelmed the Democrats in their final political meetings and the betting is on the basis of Ballinger's majority. It is estimated by the sporting element and the politicians that a fair estimate of the vote will give Ballinger not to exceed 2000 plurality over Tucker. This may be increased.

A pretty fight is expected in the First Ward. Money was distributed to elect to insure the election of the Republican candidate for Councilman. This money was put out as a bribe, conditioned on the delivery of pluralities for William Holt, the Republican nominee. Both the Great Northern and the Pacific Coast Company are interested in the election, and the issue means largely the question of supremacy for the tenderfoot forces which have dominated the district for years.

In the Second Ward betting runs even on Republican success for the Councilman's issue, and in the Ninth every eye is in the air where practically no question of Republican success exists. An interesting feature of the closing fights is that Charles C. Dalton, Assistant Attorney-General, presided over the big Republican mass meeting tonight. Dalton is a McBride man and was chosen as chairman after Preston refused to speak. He led the applause for the sentiments expressed and showed his sympathy with the ticket.

SENSATION AT HOOD RIVER.

W. T. Hume Presents Bill for Legal Services, and Mayor Coon Resigns.

HOOD RIVER, Or., March 7.—(Special.)—A regular bombshell was exploded in the City Council meeting tonight shortly after the session convened by the reading of a communication from Attorney W. T. Hume, of Portland, relative to payment of his services in the prosecution by the city last October of S. F. Fouts for violation of the Sunday closing ordinance. The letter at once stirred up an ugly sore which has troubled the Mayor and Councilmen, the saloon people and prohibitionists of Hood River for several months. There were some lively hits between the Mayor and Councilmen, and the remarks of His Honor were not intended to be soothing. It all ended by Mayor Coon calling J. E. Rand, President of the Council, to the chair, when the city's chief executive grabbed for a sheet of paper, a pen and some ink, and while the Councilmen coolly looked on, the Mayor wrote out his resignation, which he handed to the Recorder, took up his coat and hat and departed.

In explanation of all this, it must be stated that last October, T. R. Coon, as Mayor of the City of Hood River, considered it his duty to prosecute the saloonkeepers of the town for selling liquor on Sunday. With the aid of the Town Marshal and hired detectives, who were supplied with money to buy drinks and secure evidence in the matter, S. F. Fouts was arrested on the charge of selling whiskey on Sunday. Fouts was found guilty by jury trial and fined \$100. His conviction also included revocation of license. The saloonkeeper immediately appealed to the Circuit Court. When a bill for \$200 for incidental expenses in the prosecution was presented to the Council, the whole proceedings were snuffed. Some of the Councilmen were sore because, in their opinion, the Mayor had exceeded his authority in going ahead with such work without laying the whole matter before the Council. Private citizens took up the fight, funds were raised and injunction proceedings instituted to prohibit the Council from paying the bill. A city campaign came on and Mayor Coon got out printed circulars, in which he alleged certain Councilmen were in collusion with the saloon men, and, therefore, the Mayor's prosecution of Fouts had to be secret. The matter dragged on. The new City Council was anti-Coon and in January Mr. Fouts won his appeal in the Circuit Court.

Since then the whole affair was considered dropped, but it seems now that attorney Hume was in a Portland hospital when the Circuit Judge decided the appeal, and as Hume was then the city's attorney, he declared snap judgment was

taken, and he has asked to have the case reopened. His letter tonight wanted to know whether the city intended to pay him. It not, he hinted at a suit against the town. The Council voted not to pay any bill he should present.

BETRAYED BY HIS COUSIN.

Canadian Forger is Turned Over to Spokane Officers.

SPOKANE, Wash., March 7.—(Special.)—Through the betrayal of his identity by a cousin in quest of blood money, John Stuart, lately agent for the Equitable Life Assurance Society here, is under arrest, charged with forgeries in sums estimated as high as \$10,000. E. Clemens, who betrayed him, was actuated by hope of a reward which he believed hung over Stuart's head.

Stuart's real name is John H. Thamer, and he is named as Berlin, Ont., on charges of alleged forgeries committed upon the Bank of Commerce of Ayre, Ont. He had been in Spokane for a year. The story of the arrest is dramatic. Clemens is about the same age as Thamer. Three years ago Thamer, then a prosperous young cattle-dealer, 30 years old, living at Ayre, disappeared and forged notes were left in the hands of the bank. Clemens has led a roving life. A few weeks ago he landed in Spokane broke. He pawned his luggage and was on the ragged edge of starvation one day, when he chanced to see Thamer on the street. Thamer would not speak, but Clemens knew the cousin. Spurred by the hope of blood money, Clemens wrote back to the bank in Ontario, asking whether there was a reward.

Detectives were employed and Clemens was arrested, as he bears a marked resemblance to Thamer, the forger. On proving that he was not the forger, Clemens was released and then engaged to remain in control of the Pinkerton men for five days at \$10 a day, and to identify Thamer if he could find him. The detectives soon encountered "Stuart" on the street and suspected at once that he was the much-wanted forger. They arranged a meeting between Clemens and Thamer. The two refused to speak to each other, but they were plainly so agitated that the Pinkerton men arrested "Stuart," who admitted that he was Thamer, the forger, and promptly offered to go back to Ontario to stand trial. Instead of being staggered, however, "Stuart" seemed intensely relieved from the load he had been carrying for three years.

Clemens, through whose greed for blood money his cousin is now in the hands of the law, has disappeared.

FORGERY FOLLOWED BY SUICIDE

Accusation Made by Wife of Late Adolph Krug, of Seattle.

SEATTLE, Wash., March 7.—Adolph Krug, formerly Treasurer of the City of Seattle, now dead, is accused in two suits filed in the King County Superior Court with having forged the names of his wife and her brother, William Rittenhoff, to notes aggregating many thousands of dollars, which were cashed at discount at several banks in the city. Officers of the American Savings Bank & Trust Company say that exposure of the forger came a few hours prior to the death of Krug, who died a supposed suicide.

Krug died January 1. The day before he and his wife went into the bank to see about the notes. Mrs. Krug had received notice about it, and had been assured by her husband that it would be all right and that he would attend to it. Krug tried to dissuade his wife from going to the bank. She was persistent, however, and the two went together. Krug stood on the outside while his wife went to see about the note. A bank officer showed her the note with her name attached. Mrs. Krug at once pronounced the signature a forgery. Krug immediately went away. That afternoon he crossed the Sound, going to Pleasant Beach. The next morning his dead body was found in a room in the Pleasant Beach Hotel.

Mrs. Krug and her brother have filed actions in the Superior Court to have declared void a note for \$100 held by the American Savings Bank, and another for \$200, held by the Puget Sound National Bank, each bearing their purported signatures alleged to have been forged. The Seattle Brewing & Malting Company also holds one of Krug's notes for \$200, which is signed by his wife and brother-in-law. That note is also said to be forged. The note was given by Krug while he was proprietor of the Log Cabin saloon. He sold the saloon a short time before his death.

GRANT COUNTY INDEBTEDNESS

Experts Find That It Amounts to \$130,000.

JOHN DAY, Or., March 5.—(Special.)—The indebtedness of Grant County, as shown by the report of the expert accountants, Clark & Buchanan, is \$130,749.66. Of this amount \$553.45 extends between the years 1881 and 1888, the largest sum unpaid being in 1888, for which there are outstanding the sum of \$84 in county warrants. There is \$400 yet unpaid for the year 1896, while none of the warrants have been called for in any of the succeeding years. The county's obligations for one year were in 1902, the amount of scrip for that year being \$29,887.55. It is considered probable that warrants extending for more than seven years have been cancelled at the May session of the Commissioner's Court.

On the other hand, the amount of cash on hand in the Treasurer's office is only \$200.25, and it is probable the county might be applied on the reduction of the indebtedness.

Butcher Dies of His Wounds.

SAN FRANCISCO, March 7.—Joseph Buttgenbach, who was mysteriously wounded at a saloon in the city last Saturday night, died today without regaining consciousness. Albert Buttgenbach, the dead man's son, and Louise E. Brune, the bookkeeper, are still detained at the city prison, and it is probable the young Buttgenbach will be charged with murder. A similar charge will probably be placed against Brune.

The police now say that John Riley, Edward Gonzales and John Blumhansett, who were arrested on suspicion, had nothing to do with the murder, and they will probably be released. The captain of the patrol said today that Buttgenbach was apparently shot while he was bending over a desk at work, as the bullet entered the top of his head.

Tillamook Creamery Elections.

TILLAMOOK, Or., March 7.—(Special.)—At an annual meeting of the Tillamook Dairy Association, Charles Kuna, Alfred Carlson and John Morgan were elected directors and C. E. Thayer treasurer. The officers received 1,283 pounds of milk last year.

The annual meeting of the Red Clover Creamery was held this afternoon, when Henry Leach, Marion Chance and Mike Ahlens were elected directors and C. E. Thayer treasurer. The factory received 82,397 pounds of milk in 1903, and this brought \$1.30 per hundred pounds, the patrons being paid \$1.14. The price of cheese averaged 12.5 cents.

Penitentiary Suit Argued.

SALEM, March 7.—(Special.)—The injunction suit against the superintendent and warden of the Penitentiary was argued today before Judge Boise upon demurrer and taken under advisement until tomorrow.

Homeseekers for Goldendale.

THE DALLES, Or., March 7.—(Special.)—A carload of homeseekers arrived here today from Iowa and Kansas, en route to Goldendale, Wash., for which point they will leave by boat tomorrow.

FLEE FROM THE FLOOD

CLOUDBURST CAUSES FARMERS TO GO TO THE HILLS.

Section in the Blue Mountain foothills is under several feet of water.

WALLA WALLA, Wash., March 7.—(Special.)—A cloudburst occurred above Dixie, in the foothills of the Blue Mountains, about 5 o'clock tonight, and as a result ranchers along Mud Creek bottom have been compelled to flee from their homes to the hills, and communication with Dixie and points intervening has been broken off.

Pears are entertained for Dixie, which lies only four feet above the creek. Trainmen report the water overflowing the track, and rushing down the hills in torrents. Details of the damage cannot be obtained, owing to communication being interrupted. The creek here, to which Dry Creek is tributary, was about three feet higher than usual at midnight.

Ranchers along Dry Creek report the rise of the water unprecedented.

PARSON IS A SLUGGER.

Minister and One of His Flock in a Street Fight.

MILTON, Or., March 7.—(Special.)—Rev. R. L. Cartwright, pastor of the Christian Church of this city, and Otis Ingle, one of the leading members and also president of the Christian Endeavor Society, as well as a leader in the temperance cause in this city, engaged in a fist encounter this afternoon on Main street. It appears trouble has been brewing between these two ever since the appointment of Rev. Mr. Cartwright to this charge two years ago, where he was called from Kentucky. He is a single man, and has won considerable favor with the fair sex of his congregation, because of the amorousness of Ingle, who is somewhat of a winner himself.

This afternoon Cartwright called at Ingle's place of business and asked him to take a walk. They were noticed to be engaged in an animated conversation, in which language was overheard unbecomingly Christian gentlemen. When in front of the residence of the pastor, the two exchanged blows. A clinch followed, and the reverend gentleman showed himself to be master of the situation, and remarked: "I will chew his face off." It soon became evident to Mr. Ingle that he was carrying his words into effect, and Ingle's lusty cries for help soon brought assistance.

Ingle, smarting from the severe punishment, and thirsting for revenge, proceeded to swear out a warrant for the arrest of the clergyman. Ingle is a nephew of Charles Ingle, the saloonkeeper of Freewater, who was one of the principals in the disgraceful scene at Freewater last Saturday night.

How They Fight in Freewater.

MILTON, Or., March 7.—(Special.)—A Freewater saloon was the scene of one of the most disgraceful fights ever witnessed in this vicinity last night. Jack Temple and Art Wright, two notorious characters of Freewater, became very abusive to Charles Ingle, one of the proprietors. He tried to put them out, when they began the assault. Ingle was overpowered and thrown to the floor. Wright began using his teeth, biting off Ingle's ear in two places and part of his lip. Marshal Lombard arrested both the aggressors, and Justice of the Peace Freeman, who was called immediately, fined both men, Sheriff Taylor will arrive tomorrow, and take both prisoners to Pendleton, where they will be held awaiting the outcome of Ingle's injuries.

STATE CONTROLS FISHERIES.

Has Jurisdiction Over Its Tide Lands.

SAN FRANCISCO, March 7.—The United States Court of Appeals today decided that a state has jurisdiction over its tide lands, unless such lands have been deeded away. The case, which was appealed from Alaska court, was that of J. R. Heckman and the Alaska Packers' Association et al. against Clark A. Sutter et al. The decision states that it is a settled principle that the right to control and regulate the fisheries is on the same plane with the right to control navigation. The latter is a right reserved to the federal government. The right of fisheries is common right, regulated and controlled by the state.

The decision is important, as nearly all of the Alaska fisheries are interested.

NORTHWEST DEAD.

James A. Stevens.

EUGENE, Or., March 7.—(Special.)—James A. Stevens, an old pioneer of this county, died this afternoon at his home four miles northeast of Eugene, aged 65 years. Mr. Stevens was born in Polk County, Mo., January 28, 1838. At the age of 8, he came across the plains to Oregon with his parents. They settled on a donation claim in the forks of the river, a point which they soon later acquired. He had lived continuously on the old homestead since his first arrival. He was married in November, 1868, to Emily F. Greenwood, who survives him. They have three grown children, Lemm L. Stevens and Welby Stevens, both farmers in this county, and Mrs. M. Summerville, of Eugene. The funeral will be held Wednesday from the family residence.

Mrs. Margaret Keyes.

OLYMPIA, Wash., March 7.—(Special.)—Mrs. Margaret Keyes, for 12 years a prominent educator of this city and state, died here Sunday, after a brief illness. Mrs. Keyes was for several years principal of the Olympia High School, but resigned about two years ago on account of the arduous duties of the position affecting her health. She had, however, been employed as teacher here since that time. School flags were at half-mast today and the school was dismissed out of respect to her memory.

Mrs. Ann Schoelling.

THE DALLES, Or., March 7.—(Special.)—Mrs. Ann Schoelling, for many years a well-known and respected resident of The Dalles, died at her home in this city this afternoon after a prolonged illness. Mrs. Schoelling was a native of the Willamette Valley, and was 65 years of age. She leaves a mother, Mrs. M. O'Brien, and three daughters, all residents of this city.

Says Tanana Is Rich.

SEATTLE, March 7.—A special to the Post-Intelligencer from Valdez, says: Right Rev. P. T. Rowe, Captain Geiger and party have just arrived in Valdez from Fairbanks. Bishop Rowe has just completed a 2000-mile trip by dog team through the Yukon country. He says Tanana is beyond question a rich camp and that the best reports are not exaggerated.

Appointed to Agricultural Board.

SALEM, March 7.—(Special.)—W. F. Matlock, of Pendleton, was today appointed a member of the State Board of Agriculture to succeed George Chandler, of Baker City, whose term has expired. Both Chandler and Matlock are Democrats. At the recent meeting of the board Chandler

was elected president, but as his term has expired a new election will be necessary. The principal duty of the board is to manage the State Fair.

Acquitted of Libel Charge.

ARARDEEN, Wash., March 7.—(Special.)—William Hill, an ex-police officer, was acquitted of the charge of criminal libel in the Superior Court this evening. Hill made an affidavit during the recent stirring up of the police force that ex-officers Burgess and McGahan were guilty of accepting bribes. They were suspended from the force and then brought the charge against Hill. The case has been on trial several days during which the former police methods under ex-Marshall Anstieff administration were well aired.

Rainier Town Election.

RAINIER, Or., March 7.—(Special.)—At the town election today 187 votes were polled, the largest vote ever cast since the town was incorporated. Two tickets were in the field, the caucus of citizens and the independent. The former won out, except for Police Judge. The following are the officers elected:

Roosevelt Club at Salem.

SALEM, March 7.—(Special.)—A petition was circulated here today by George G. Bingham, calling a mass meeting of Republicans at the City Hall Thursday evening for the purpose of organizing a Roosevelt Republican Club. Every Republican to whom the paper was presented signed it. It will be further circulated tomorrow.

Melting Snow Threatens Flood.

PENDLETON, Or., March 7.—(Special.)—Snow in the mountains is melting rapidly and with heavy warm rain today, the Umatilla River is rising rapidly. Farmers arriving in the city this evening report stock in the lowlands in danger. The indications are most ominous for flood than they have been in ten years.

Arrested for Horsestealing.

OLYMPIA, Wash., March 7.—(Special.)—Frank Green and Eugene Horton, both 18 years old, were arrested at Tenino today for horse stealing. Sunday they started for Oregon, taking two horses from the farms of Alexander Henry and J. L. Miller. Both boys have been in the Reform School.

Asphyxiated in Bathroom.

SAN FRANCISCO, March 7.—Louis B. Wiley, member of the Elks Lodge at Seattle, was found asphyxiated in the bathroom of his apartments on Octavia street tonight. He recently came from Nevada.

Pays Taxes in Full.

SALEM, March 7.—(Special.)—Columbia County is first in the state to pay her state taxes for 1904 in full. The payment was made today by a remittance of \$12,085. Marion and Benton have made partial payments.

OLD FRANCHISES UNUSED.

Big Batch of Them Will Be Repealed by City Council.

Unused and forgotten by their owners, a number of franchise ordinances, which have cumbered the boxes of the City Auditor's office for years, will be repealed at the next meeting of the Council.

The ordinances are long-lost echoes of many schemes and devices. In many cases they would be extremely valuable at the present time, but first it must be proven that a regular transfer has taken place. So next week they will be repealed and thrown away for good and all.

One authorizes the Mount Tabor Street Railway Company to operate street railways in the city. This is covered by the franchise of the East Side Railway Company, and the document is marked "owner unknown." It is dated February 14, 1890.

Another, dated June 23, 1892, grants to the Portland Heat & Power Company the right to lay pipes and dig trenches for the purpose of supplying steam heat and steam power to buildings. This was never claimed.

Awake back in 1878 the Council had wrestled with telephone franchises apparently. On March 8, 1878, an ordinance was passed authorizing the Northwestern Telephone & Electric Company to operate a telephone and electric system in the city. Like the majority of the others, it is marked "owner unknown."
