His work will live as an integral part of the religious life of the Pacific Northwest. His long and varied experience as a Methodist preacher, united with a vivacity and cheer possessed by few, has made him an invaluable factor in our local work, and we hope he may continue his residence in this beautiful city for many years."

Williams, whose son is a member of the class, has consented to be present.

Y. M. C. A. BOYS' CAMP—A few days ago the annual announcement of Camp Ladd was issued to the boys of the Y. M. C. A. and the applications are already coming in. The camp is an adult boys' camp all over the country has been made so popular with the boys that it has become a regular part of the year's work with nearly all of the Y. M. C. A. in the country. The Portland camp will be held on the Columbia near Cascadia, beginning July 6 and continuing for 10 days. A large number of boys are expected to attend, as the line of work is still in its infancy in Portland. Camp life will be made as safe as possible without unduly restricting the boys' liberties. Every six boys will be assigned an adult leader. The boys' secretary will be in charge of the camp and among the leaders are the physical director and religious work director.

He wrote the "History of the Nineteenth Century" and was acting as correspondent for Collier's Weekly and the New York World at the time he was shot.

P. McQuire, Collier's manager in the Northwest, with offices in Portland, was personally acquainted with Mr. Emerson and speaks of him as one of the best men Collier's had in the Northwest. He received from him a letter asking him to forward to Tokio to him a number of sets of his history, but the news of his death came before the shipment could be made.

PANORAMA OF PORTLAND—A beautiful panorama, photographic view of Portland has just been issued in the form of an album by L. C. Henriksen of this city. The picture is a bird's-eye view taken from the hills back of the city and shows the entire city on each side of the river, the harbor, the principal business and public buildings, the Hotel St. Helens and Adams in the distance. The view embraces everything between Portland Heights on the south and Wilamette Heights on the north. The album is the most elaborate thing of the kind ever gotten out here and should do much to exploit the beauty of Portland.

TITLE TO LAND ATTACKED.

Thirty Thousand Acres in Southwest Oregon is Attacked.

The validity of the title to 30,000 acres of valuable timber and agricultural land in Southwest Oregon which have been in the possession of the Southern Oregon Company and its predecessors for the past 30 years, will be tested by a suit filed yesterday in United States District Court by L. K. Nichols, of Marshfield, as complainant against the Southern Oregon Company, a corporation organized under the laws of this state and of which L. K. Nichols is president and L. E. Shiner, of Empire, Or., is secretary-treasurer.

The suit thus instituted is the culmination of a long and bitter struggle on the part of certain citizens of Coos County that the Federal enactment under which the lands were appropriated to the state and subsequently to corporations and individuals were being enforced.

The history of the case runs back to 1890, when Congress granted 90,000 acres of land in Coos and Douglas Counties to the State of Oregon to be sold and disposed of under certain restrictions, the proceeds to be devoted to the construction of a military wagon road from navigable water at Coos Bay to Roseburg.

The grant was made in two sections, one on either side of the proposed road, to be held in trust by the state and disposed of to actual settlers at a price not exceeding \$1.50 per acre in tracts not exceeding 160 acres to any one person. The state accepted the grant, and shortly afterward the Legislature transferred the land to a corporation which contracted to construct the road. In due time the road was built, and the road company went out of business, making a sale of the lands to a certain John Miller, who in turn transferred it to Collins E. Huntington, Charles Crocker, Leland Stanford and Mark Hopkins. Crocker purchased the interests of his associates, and after holding it for a time, passed it on to Russell Bates, a prominent Wall street operator, from whom eventually title passed to the Oregon Southern Improvement Company, and at last to the Southern Oregon Company, which is defendant in the present action. Meanwhile the Government issued patents to the land in 1874, and while there has been much agitation against the corporation, the suit brought by Mr. Nichols is the first time the question has been brought into the courts.

The complaint recites the facts as set forth above, and recites further that the plaintiff, acting under the provisions of the original act has repeatedly made a legal tender of \$1.50 per acre for a quarter section of the land included in the grant; that the Southern Oregon Company has refused to accept said offer and deed him the land, that the present value of the quarter section in question is in excess of \$2000; that the complainant is a bona fide prospective settler, and that the Southern Oregon Company is acting in violation of the act of Congress of 1869. He asks that an order be issued out of court directing the defendant to comply with its contract and issue a deed to the quarter section on which the suit is based.

Eljah Smith, president of the Southern Oregon Company, declares that the purpose of the suit filed by Nichols is speculative; that he is a resident of Marshfield, a dry goods clerk and in no sense a bona fide settler on the land. He believes the suit to have been prompted by persons who desire to obtain possession of valuable tracts of timber land now in the possession of the company, and that their purpose is fraudulent. The

contention of the company will be that the land was deeded to it outright, and that the lands had ceased to be a trust before it obtained possession, and that the act of 1869 no longer applies.

WELL-KNOWN ARTIST COMING.

Eanger Irving Couse Will Study Indians in Oregon.

Eanger Irving Couse, who, with Mrs. Couse, is expected to arrive in Portland this morning as the guest of Mrs. Charles Kamm at 215 Fourteenth street, enjoys an international reputation as an artist of ability, creative power and force. His name is most familiar to the artistic public on both continents, and the many distinctions he has won in competition with other well-known artists stamp his work as of great merit.

Mr. Couse developed a talent for drawing as a small boy, but did not receive instruction until he was about 17 years of age, when he entered the Academy of Design in New York. The four years he studied in this country laid a foundation for the finishing touches which nine years abroad rounded out into a master of the brush. Upon his return to America, his work was at once recognized, and from that time he has been most successful in taking prizes and obtaining honorable and special mention for his work.

The Shaw prize at the Salon in Paris was won by him at the Salon in 1893. His work was won by him at the "Fishing Scene," and

the Proctor prize was his the next year for "A Helping Hand." Early that same year, at the Academy of Design, "Along the Quai" took the Hallgarten prize. This same picture has been made a business of the Paris exhibition and is considered very fine by able critics. In 1902, the first Hallgarten prize, available only for American-born artists under the age of 35, was carried off by "The Pipe of Peace" from Mr. Couse's brush, and at the Buffalo Exposition "The Forest Camp" was honorably mentioned.

The January number of the Art Review says of Mr. Couse: "One of the foremost American artists who 'achieved greatness' early in life. Mr. Couse did not make a name for himself by a single work, but by a series of pictures, each of which has won public approval by subsequent efforts; but has earned the high esteem in which his work is regarded by a continuous succession of men of taste, making an unusually brilliant record for so young a man."

The North American Indian is the favorite study of this young artist, who spends each Summer among them, studying from life what he later puts onto canvas. A number of his prize winners have been Indian subjects, and his success is largely due to the fact that he has been able to mingle with them. He is now on his way to Eastern Oregon and Washington, where he will spend the Summer among the Yakimas and other tribes.

Klamath Against Local Option.

KLAMATH FALLS, Ore. June 18.—(Special.)—Klamath County gave a majority of 125 against local option. The vote on this and other referendum measures was: Local option, yes 329, no 455; direct primary, yes 518, no 164; Herndon's plurality, yes 184, no 14; Moore, for Judge of Supreme Court, 175; Laycock, for Senator, has 104 plurality; Steiner, Rep., for Representative, 114; and Griffin, Dem., 83. The Register elects the Sheriff by 26 margin and also Treasurer, School Superintendent and Surveyor. The District Attorney, Clerk, Assessor and Commissioner are Democrats.

Woman Gored by a Cow.

NEX PERCE, Idaho, June 18.—Mrs. David Pugh, living a mile and a half southeast of here, was gored by an infuriated cow Saturday afternoon, and it is feared she will not survive.

She had a young calf, which Mrs. Pugh endeavored to drive into the shade of the barn. The cow, frantic with rage, made a rush at Mrs. Pugh's little boy, whom she was holding in her arms, and he was injured. The cow then charged on the woman, goring her through the body. Mrs. Pugh's recovery is not expected.

We waited long, while all the world was ringing with praises of her and from a long distance we paid homage to her rare genius. Then after our waiting, the sweetest, most magnetic and the best little woman who has ever played on the stage, Maude Adams, came to us, unencumbered by her heart and enraptured our intelligence with the beautiful charm of her personality. The coming was worth our waiting. It measured up to the high level of our anticipation. We have seen Maude Adams as Lady Babbie, and now we understand "The Little Minister" in a new way. In the presence of so fine an audience as ever welcomed a star to Portland Miss Adams and her splendid company presented "The Little Minister" at the Marquam Grand Theatre.

The occasion was something of a homecoming for Miss Adams. It was here, as a little child, that she received much of the encouragement which prompted her to pursue a career which has had but few equals in the history of the stage. As long ago as 1879 her mother and she appeared at the old Newmarket in old-fashioned repertoire.

A forgotten writer on this paper in a quaint and extravagant appreciation chronicled her introduction to the Portland public. The play was "A Celebrated Case" and the incident has been immortalized after the following fashion:

"In the prologue, playing the part of Adrienne, the child actress, for so we must call her, as she is a natural born actress, little Maude Adams, 5 years of age, her first appearance before a Portland audience. Her acting was simply sublime and received the hearty and enthusiastic applause of the large and intelligent audience. Her intense emotion left few dry eyes among the spectators."

Who will say that the unknown enologist did not have the gift of prophecy, but one is prone to wonder if his notice did not have something to do with Miss Adams' long absence from the scene of her early triumphs. That was 25 years ago, and while she has been here in incidental capacity, once in "The Lost Paradise," once in "Southern in Lord Chalmers," and once in the cast of "Men and Women," but never since she became a great star, with the world at her feet, has she declined to pass this way until last night when the little girl grew to womanhood, came back to us again and received a welcome home.

Of the play, but little need be said: It has become familiar through the wide circulation of Barrie's book and its production by imitators of the original "Lady Babbie." The lovable daughter of stern old Lord Rintoul is the character which stands out in relief from among a number of others which would be of great importance under different circumstances.

It was in Thruza that the boyish mind loved the "Reginald" and the scandal of the good folk of the kirk, and it was there, when the lights of the village twinkled through the darkness, that the elders waited for him that could not be waited for, when they remained to rejoice that the castle and the "meetin' house" had one thing in common, the love of a maid for a man. The story is such a simple one, with a happy end, and that one feels the air of the Scottish hills in his nostrils and feels vastly better and more hopeful for his kind because he has seen the play.

Of the elusive, winning, beautiful art of Miss Adams, what can be said? The highest encomiums have been passed upon it everywhere and adjectives are mere words and weak. It may, after all, be no art at all. It may be something better, absolute naturalness. When she smiles she is merry, when she weeps she is sad, and the audience believes in her with her one moment and be heartily-beated the next.

At all events, the power which this frail, girlish creature has over the minds of the hearts of men and women and children is a power for good. It is something high, and ennobling and apart from sordid things. It is because of this that we joy in Miss Adams' return to the stage, and the Portland has some claims upon her.

The supporting company is an admirable one and worthy of the star. Henry Ainley makes of Gavin a delightful contrast to Miss Adams' "Reginald." A talented leading man and it is hoped will be seen often hereafter in the West. Without exception, the remaining members are convincing, capable and have just discovered the power of light effects are very beautiful and seemingly accurate.

The theater was filled to its utmost capacity. There were many new faces, and Maude Adams and Portland have every reason to feel satisfied at last night's triumph.

There will be a special matinee this afternoon and a closing performance tonight.

NEW YORK, June 21.—A strike of 50,000 persons employed here in the clothing trades has been called, to take effect at once. Most of the tailors involved are employed by middlemen or contractors. Strikes of similar character are an annual feature among the local garmentworkers, but the present one involves opposition to the "open shop" declaration of the Manufacturers' National Association.
