



SWAMP LANDS OR NOT?

Review of Facts Bearing on Warner Valley.

PORTLAND, Nov. 8.—(To the Editor.).→ I have always made it a rule to fight my cases in the courts and not in the news-papers, but the repeated published inter-views with the Governor and the Attorney-General, and especially the one in your issue of November 5, relating to the Warner Valley swamp case, induces me for once to deviate from this rule and to ask space in your paper for that purpose.
