Hamburg. WITHDRAWN FROM RESERVE SENTENCED FOR CONTEMPT. Denver Election Officers Permitted Fraud at the Polls. DENVER, Colo., Dec. 22-City Detec-tive William H. Green, John de Saye, Frank McMahon and Robert Goodman re today adjudged guilty of contempt by the Supreme Court for their work at the late election, and were each sentenced to serve six months in jail and pay \$100 fine and costs. The court announced that the evidence showed that De Saye, who was an election Jadge, permitted repeating, and that the other three assisted in the irregularities. Green was assigned by the police department to protect the Supreme Court watchers and assist in preserving McMahon and Goodman were Democratic workers. egraph. 
