PREACHES AT FAIR

Dr. Robert McIntyre Speaks to Exposition Crowd.

SERVICE IS IMPRESSIVE

Eloquent Discourse on "The Fatherhood of God" Declared One of Best Sermons Ever Delivered in Portland.
