Russians' Flank Is Turned.

ST. PETERSBURG, June 18 .- A dispatch from the headquarters of the Russian army at Godzyndani describes fighting in the vicinity of Linoyangwopeng from 2 until 8 o'clock on the morning of June 26. The Russian artillery forced the Jap-anese to retire along the whole line. Meantime another force of Japanese turned the Russians' right flank, compel-ling the Russian detachment to retire from Linoyangwopeng.

At this moment a strong Japanese in-antry column was observed approaching. The Russian losses, the dispatch says, were only six wounded.


