METEORITE IS SEEN TO FALL

Heavenly Visitor.

OREGON CITY, July 10.-(Special.)--Residents of this city at 10 o'clock Satur. day night saw a meteorite fall on the West Side. The aerial visitor, which was of an irregular shape, appeared in the south and east, and, after following a south and east, and after following a southwesterly course, was deposited evi-dently near Bolton. Instead of exploding, the molten mass appeared gradually to enlarge as it neared the earth, and was plainly visible for several seconds,


