ARRESTED FOR STEALING COPPER WIRE.—George J. Dwyer, an electrical worker, was arrested yesterday afternoon on a charge of larceny after having courted a trouble in a most ridiculous manner. Dwyer was observed recently in the act of selling 35 pounds of copper wire to a second-hand junk house. Detectives Carpenter and Day questioned him regarding the source of the wire and he told such a probable story that he was not molested. Later, however, the officers learned that the wire had been stolen from the O. W. P. Company. They then went in search of Dwyer but for a week or more could not find him. Dwyer in the meantime had secured a lawyer to collect the money for the stolen wire, fearing to go himself. The junk dealer refusing to settle without an order from the police, the officer began civil action in Justice Rold's court. Through this action his whereabouts were traced and Detectives Carpenter and Day arrested him yesterday afternoon. He was locked up on a charge of larceny.

NATIONAL GUARD ENCAMPMENT.—The date of the National Guard encampment was announced yesterday afternoon at the Guard headquarters. The state troops will leave Portland August 11, for American Lake, Wash., and will remain under canvas at that place for ten days. Within a short time the annual encampment order will be issued from headquarters. This order will set out all the details of procedure, and will contain full instructions to the various commanders of organizations. The state troops of Oregon to participate at American Lake include six companies of Oregon Infantry and the hospital corps. The battery will leave next month for a practice march through Willamette Valley. The state will put up for the battery's outfit, while the infantry and signal corps' outfit will be paid for by the United States Government.

TRAIN ON CHINESE LOTTERY.—Fortified behind many doors and with a female lookout, Ah Suey, the agent of 13 Chinese lottery companies, thought he was entirely secure from intrusion. However, his downfall came yesterday afternoon when Patrolman Smith, attired in civilian garb, managed to slip past the lookout and raid the lottery office. When the heathens saw him enter their place they made a wild scramble for cover, and Suey, the almond-eyed proprietor of the place, tried to hide his lottery tickets under a bunk. They were unearthed, however, by the officer. Suey put up \$100 bail for his appearance in court this morning.

BOYS CARELESS WITH RIFLES.—Robert Hall and Adolph Munn, while at the "Castle" on Portland Heights yesterday afternoon, had a narrow escape from being wounded by small-caliber rifles fired by small boys. The juvenile henchmen were firing in a reckless manner when one of the bullets struck between the two men and within six inches of their heads. They at once went in pursuit of the reckless runners who dropped their guns and ran. The boys made good their escape but their rifles were captured and turned over to the police.

SCHOOL OF TELEGRAPHY.—The Morse School of Telegraphy Company will establish a branch college in Portland. The headquarters of the college are at Cincinnati, O. It had a branch school in San Francisco which was destroyed by the fire. The manager of the company has written to Secretary E. C. Gilmer, of the Chamber of Commerce, and states in his letter that the company has decided to re-establish the Western branch and that in his estimation Portland is the most desirable of Western cities for the purpose.

He thought the boy was working at the Pacific Coast Biscuit Company but on inquiring there found that he had not been working for three weeks. The police were asked to look for the missing boy.

REV. JOHN GLIN RETURNS.—Rev. John Glen has been returned as pastor of the First Free Methodist Church, East Ninth and Mill streets, for another year. This will be his third and last year at this church. A pastor can remain at a station but three years, when he must be moved somewhere else.

ARCHITECT BROWNE'S CLAIM.—Architect Chas. P. Browne has a claim against School District No. 47, at Astoria, for preparing plans for a \$10,000 schoolhouse, which the district did not build. When the district was first organized it was decided that a modern building would be needed. Accordingly Mr. Browne drew plans for a building that would cost \$10,000, and at a meeting of the Board of Directors, these plans were accepted. Afterwards it was found that the district could not raise that much money on bonds, or by borrowing money, and the erection of the building could not go ahead. On the basis of having prepared the plans and their being accepted Mr. Browne put in his claim, which will have to be adjusted by District No. 1 if not settled before July 1.

Sargant, well known in Portland as a restaurateur and caterer and for a number of years in charge of the Astoria Club, writes to a friend in this city, from San Diego, that he expects shortly to return to the Oregon metropolis for the purpose of establishing a new restaurant and grill on the Pacific Coast. He has instructed his agent to find him a suitable location and as soon as this is done will bring his family. Although owning one of the finest restaurants in San Diego at the present time Mr. Sargant is of the opinion that this is a better place to have a restaurant, and that he will be able to secure a better location than the Southern California metropolis.

In response, he says, Isakson threw him down, after a slight exchange of words, breaking his arm. The officer, in reply, claims Nelson was hurt in a drunken brawl and that he did not handle him roughly.

STEAM ROLLER UPSETS.—The steam roller that is busy flattening out the roadways in the vicinity of Park and Washington streets went wrong yesterday forenoon. It first tried to climb the curbing and falling in that rolled clumsily over on its side. The driver had to make his escape from being flattened out under the ponderous machine. As it was he suffered a severe squeezing from being caught by the rollers. His address was had to leave off work for the day.

SHIRLEY REBORN FROM EXECUTIVE BOARD.—Eugene Shelby handed to Mayor Lann yesterday his resignation as a member of the Executive Board. Mr. Shelby has been on the board only a short time, having taken the position vacated by Senator Gearin, and gives up the work because of his new duties as manager of the Western Division of Wells, Fargo & Company. Mayor Lann has not yet selected a successor to Mr. Shelby.

ST. JOHN'S SCHOOL ELECTION.—At the St. John's school election Monday night, J. A. Williams was elected director and W. C. Williams was elected secretary. Reports of the retiring clerk, J. Tanch, were received and accepted. No action was taken relative to the establishment of the proposed high school class in the Fall. However, it is settled that such class will then be opened.

REV. E. M. SHARP SPEAKS.—Rev. E. M. Sharp, of the Mount Taber Presbyterian Church, who was a representative to the General Assembly, at Des Moines, spoke last evening before the Men's League of the Methodist Episcopal Church on the subject of "The Church in the Future." He gave a full and interesting address, and was the guest of the league during the evening.

MOTHER OF H. E. JUDGE DIES.—H. E. Judge, of this city, was advised yesterday of the death of his mother, Mrs. Cornelius Judge, at Quebec, Canada. Mrs. Judge had reached an advanced age and the recent death of her husband, which made her recovery impossible. Mr. Judge has the sympathy of his great host of Portland friends.

POOR CROSBY ON MOUNTAIN.—Charles Hughes, a workman, had his first crowd yesterday forenoon while occupied on a building at Fifth and Alder streets. The falling of a weight was responsible for the accident. He was taken in the patrol wagon by Patrolmen Price and Inskeep to St. Vincent's hospital.

DR. HILL WILL GO

Accepts Chair of Homiletics in Chicago.

POST OF HONOR IS GIVEN

Position With McCormack Seminary Is Considered an Advancement and Carries With It Large Salary.

Dr. Edgar P. Hill, of the First Presbyterian Church, has been tendered the chair of homiletics in McCormack Seminary, Chicago, and has determined to accept the call. At the meeting of the board of directors held last Wednesday evening Dr. Hill announced that he had been offered this position, but that he was only considering it. Now it is authoritatively stated by his friends and church workers that he will accept the call. A chair in McCormack Seminary is considered a post of honor and the salary attached is probably much larger than attaches to a church in a city of this size.

Has Had Other Calls.
 In making the announcement to the directors of his church Dr. Hill explained that he has had other calls aside from the one to New York last year, one of them being to Philadelphia

and another to San Anselmo. Being much attached to Portland and his congregation here, however, he declined these flattering calls, and it was until the honor of a chair in McCormack was tendered that he decided to leave.

There are many who will regret the departure of Dr. Hill from this field, and the news of his intended departure was a great surprise to his congregation. He has been a member of the church since he came to Portland from a long Oregonian.

Give Pastor Purse.
 The members of the First Presbyterian Church have given their appreciation of the devotion to their pastor in their generous treatment of him, having presented him with a check for \$1,000, which was accepted by him and accorded him full salary during his absence.

While there will not be an official announcement of Dr. Hill's determination to accept the Chicago call until after the next meeting of the board of directors, the news that he is going is generally known in Presbyterian circles, and at yesterday's meeting of the Women's North Pacific Board of Presbyterian Missions the members expressed their deep regret over the coming departure of Dr. and Mrs. Hill.

MARKED FOR DEATH

Pole Tells the Police Nihilists Threaten Him.

M. VOPASKI MUCH ALARMED

Declares to Chief Gritzmacher That a Committee of Anarchists Told Him He Would Be Killed Within a Few Days.

That Russian and Polish anarchists not only have their rendezvous in Portland, but have become so daring as to openly threaten the lives of those who have revealed their secrets to the press and federal authorities, is the assertion of a group of Polish informants who fear their lives are in danger. M. Vopaski, a Pole who has been most active against the local order of anarchists appeared at the police station yesterday forenoon in a state of great alarm. On the street, a few minutes before, he had been approached by a committee of three anarchists and informed that he was marked for death. They told him, he said, that he had but three days to live, that in three days he would be killed like a rat, and that there was no way in which he could avoid his end.

Goes to the Police.
 Accompanied by three of his countrymen who were afraid to ward off a possible attack Vopaski went to Police headquarters. He first sought out municipal Judge Cameron, who heard his story and turned him over to the Chief of Police. Chief Gritzmacher notified the Federal authorities and a secret service man was sent to interview Vopaski. The threatened Pole repeated his story in detail and without conflicting statements. There is an order of anarchists or nihilists with headquarters in Alhambra, at 53 Morris street, he said. They talk against God and Government, extol the assassin of President McKinley and say Roosevelt should be killed. They conduct their meetings under the mask of socialism in order to ward off suspicion of police interference.

Work in Secrecy.
 They also claim that their meetings are open to any and all, but when some stranger happens in the true spirit of the session does not develop until all but tried and dyed-in-the-wool anarchists have disappeared, so the informants state. It is also asserted that since the facts concerning the order were first printed by The Oregonian several weeks ago, a stricter secrecy has been maintained and every precaution taken by the anarchists to cover up their tracks. Several are said to have become so alarmed at the prospect of police investigation that they left the city. Vopaski was assured by the authorities that precautions would be taken to prevent his assassination in the event those who threatened him really meant business. This committee that called upon him, he said, was made up of three Poles named Pavel, Alais Barak, Lukaszewski and Koszolk.
