PROTESTS TOO LATE

Slain Missionary's Widow Wants No Blood Money.

BUT SHE HAD RECEIVED IT

Fear of Injury to Mission Cause in Persia Causes Woman's Strange Appeal—Asks That Innocent May Not Pay.

WASHINGTON, July 16.—In the Persian correspondence in the portion of the Red Book on Foreign Relations, which was made public by the State Department today, is contained a strong protest addressed by Mrs. Mary Schaeffer Labaree, formerly of Urmia, Persia, to American Minister Richmond Pearson, at Teheran, against the execution by the United States Government of an indemnity of \$50,000 for the murder of her husband, Rev. Benjamin W. Labaree, a missionary, killed on Mount Ararat by religious fanatics. While believing that, when an American citizen has been murdered because of the criminal hostility of foreign government, those dependent on him for support should be awarded a suitable indemnity, Mrs. Labaree made the following declaration:

"I believe the mission cause to which my husband and I dedicated our lives and which has become dear to me because of the terrible sacrifice I have been called upon to make for it, I believe that this may receive serious injury if my children and I accept an indemnity for this murder. The matter would not be understood by the great mass of the people in this district, who would inevitably know of it, as the Persian idea of 'blood money' is so different from our civilized understanding of an indemnity. Thus such serious and lasting injury might be done to the mission cause for which we have already sacrificed so much that I prefer to waive my rights as an American citizen rather than to see this cause suffer."

Murderers Rejected Sultors.

NEW YORK, July 16.—Adam Scheuing, a butcher, today shot and fatally wounded Miss Louise Karcher, daughter of his employer, shot and seriously wounded the girl's mother and committed suicide by cutting his throat. The supposed motive was the rejection of Scheuing's attention to Miss Karcher.

Motorman Crushed at Post.

ST. LOUIS, July 16.—One person was probably fatally injured and 50 others were more or less bruised and badly shaken up by a rear-end collision on a down grade between a Broadway and

Seventh-street car last night. The accident was due to a broken trolley on the Seventh-street car. Owing to his heroism in sticking to his post in the face of danger, Motorman John C. Downs, of the Broadway car, will probably die. He was unconscious when pried from under the wreckage.

DIAMOND KING IS DEAD.

Alfred Beit, Who Controlled African Gem and Gold Output.

LONDON, July 16.—Alfred Beit, the well-known South African financier, died yesterday. He had been in bad health for some time.

Mr. Beit was born in 1853 at Hamburg. He was a life governor of the De Beers Consolidated Mines, a partner in the firm of Werner, Beit & Co., and a director of the Rand Mines, Rhodesia Railways, Bechuanaland Railway Trust, Consolidated Companies, and other prominent British Chartered South Africa Company. He was reported to have been implicated in the Jameson raid. Later a suit was brought against him on the ground of complicity in the raid, and his prosecution was demanded by Dr. Leyds, the representative of the Transvaal in Europe, and in 1898 his resignation from the board of directors of the British Chartered South Africa Company was accepted. When Cecil Rhodes died in 1902, it was found that Mr. Beit was appointed one of his executors, and Mr. Beit thereupon returned to the board of directors of the British Chartered South Africa Company. Early in 1903 Mr. Beit, an apostle of peace, while at Johannesburg, and it appears that he never fully regained his health. Since that time he had lived in London.

Mr. Beit, who is said to have been the richest man in London and who controlled the output of gold in South Africa, was at one time alleged to be forming a "gold trust" in which the names of prominent American financiers were mentioned. He gave large sums of money to the Red Cross and other institutions, and was a great devotee of philanthropy. He was hardly known outside of the circles of finance. He controlled the output and product of the world's diamond industry, had a great distaste for publicity, and was very popular with his intimates, and was usually referred to as the "little man."

Mr. Beit, who was a staunch friend of Cecil Rhodes, arrived in South Africa several years ahead of the latter, and when he died, was by far the largest individual owner of mines and land in South Africa. He was accused of financing the Jameson raid.

The markets were not affected by Mr. Beit's death, as for a long time it had been recognized that he was in delicate health.

William Painter, Inventor.

BAITMORE, Md., July 16.—William Painter, whose fame as an inventor is national, died at the Johns Hopkins Hospital yesterday. He was 63 years of age. The United States Patent Office has granted Mr. Painter more than 100 patents on his various inventions, of which, perhaps, the most widely known and used are a bottle-sealing device and the machinery for its manufacture and application. He was a member of the American Society of Mechanical Engineers, the American Institute of Mining Engineers and numerous other organizations.

SHOCK TO NEW MEXICO

EARTHQUAKE RATTLES TOWNS AND SCARES THE PEOPLE.

Panic in Albuquerque and Adobe Buildings Damaged—Due to Landslide in Mountains.

ALBUQUERQUE, N. M., July 16.—This section of New Mexico experienced a slight earthquake today. Objects moved perceptibly, and a dull, sickening sensation was experienced. No serious damage has been reported. The people in the Armijo building thought that the building was about to collapse and ran into the street.

Towns south of Albuquerque also felt the shock, and residents of Socorro and San Marcial are in a state of alarm. The Adobe buildings at Socorro occupied by the Colorado Telephone Company and other structures built of mud were badly damaged.

DUE TO SLIDES IN MOUNTAINS

Shock Most Severe of Hundreds in Last Two Years.

SANTA FE, N. M., July 16.—Considerable property damage was done this afternoon at Socorro, San Marcial and nearby settlements by an earthquake shock, which was the severest of the 200 shocks that have occurred in that part of New Mexico during the past two years. The shocks are local and are caused by earth slides in the Magdalena Mountains.

Tremor Felt at El Paso.

EL PASO, Tex., July 16.—A distinct earthquake shock was felt here at 11:50 A. M. today. Buildings rocked and swayed and many people fled to the streets. The thermometers and instruments in the weather bureau in the Federal building swung back and forth for several minutes. No damage was done.

JEROME AND FOLK IN 1908

Georgia Legislators Declare Choice for Democratic Ticket.

ATLANTA, Ga., July 16.—William Travers Jerome, District Attorney of New York City, was the guest for a few moments today of the lower house of the Georgia Legislature. A short recess from the regular labors of the session was taken, and Mr. Jerome, upon invitation, addressed the Legislature. He spoke briefly of the relations of the North and South, expressing the belief that there is little difference in the ways of thinking and doing business between the two sections and suggested that whatever misunderstanding had existed in recent years had come largely from sensational writing.

Following his address, the enthusiastic legislators adopted a resolution endorsing "Jerome and Folk for the Democratic Presidential team in 1908."

In an interview here today regarding the Thaw case in New York Mr. Jerome referred to the case as the "every-day Police Court story." "In the eyes of the law," he continued, "the defendant's millions add no luster to his situation. Most of the apparent romance is a newspaper product."

BRYAN'S PLAN OF PUBLICITY

Suggests Publication of Subscription to Reception Fund.

NEW YORK, July 16.—At the suggestion of William J. Bryan, says today's Herald, advantage will be taken of the reception which is to be given on his return from abroad to give a practical illustration of the feasibility of applying the publicity principle to the collection of campaign contributions.

In a letter to William Hoge, president of the Commercial Travelers' Anti-Trust League, which was received yesterday, Mr. Bryan approved the plan for the reception so far as they had been heard before him and cautioned the managers to avoid all factional disputes, that all factions might have an equal chance, and "so that it will not be our fault if everything is not harmonious."

Chicago Mail Goes Under Ground.

CHICAGO, July 16.—The underground electric railway mail service was put into actual operation for the first time today. The service is to be maintained through the tunnel, which has been constructed beneath the city streets from Postoffice to the majority of the depots in the city.

NO GROUND FOR ACTION

ATTACK ON TAGGART'S GAMBLING DEN HAS FAILED.

Court Finds No Warrant for Injunction, Since French Lick Casinos Have Been Raided.

PAOLI, Ind., July 16.—Judge Thomas B. Buskirk, in the Orange County Court, today dismissed the third section of the demurrer of the French Lick Springs and Baden Hotel companies against the petition in quo warranto of the state for a temporary injunction to stop such proceedings against gambling at the resorts. In this third section the hotel companies set up that the allegations of the state in its complaint do not state facts sufficient to constitute a cause of action against them. He overruled the two sections of the demurrer in which they asserted that the prosecuting attorney was not the proper relator for the state in such proceedings and the state has not the legal capacity to sue.

The court held that, under the law, before such extraordinary relief could be granted as is asked for by the state there should have been an examination by the Auditor of the affairs and business of the companies, notice to stop doing unauthorized business, if such a condition had been found, and failure or refusal on the part of the hotel companies to stop such unauthorized business. This, the court held, was not done. In his decision, Judge Buskirk says:

To the lay mind the recital of the great, venerable, venerable charges alleged in the information, which it is also alleged have brought the state into reproach and disgrace, may portend great injury to the state and violate its rights, but that will not excuse the absence of those warrants in the information without which the state is not entitled to the extraordinary remedy asked for. In their absence we cannot read these into the information nor can we supply them by inference. Again, injunctions will only lie to prevent sudden or anticipated acts, and not when the act has been consummated.

The conditions that would warrant injunction exist at this time when, through the medium of the public press, from the published interviews with counsel for both plaintiff and defendant, and from the notices of the trial of this case by counsel in the columns of the daily press, we all know—the whole country knows—the casinos or clubhouses described in the law prior to the filing of this information, their gambling apparatus, and that it is now in the custody of the Auditor awaiting orders for its destruction and that the casinos or clubhouses are not open.

MADE SICK BY CLEANLINESS

Canal Negroes Thrive in Dirt—Spaniards Better Workers.

WASHINGTON, July 16.—Perfect sanitation and clean linens are proving fatal to the West Indian negroes employed on the Panama Canal. Although Colonel Gorgas and his assistants have banished yellow fever and other tropical fevers, which made the canal zone a large breeding ground of the French and Spaniards, they have found that sanitary precautions taken in the quarters occupied by workmen make the Jamaican negroes especially susceptible to pneumonia and other throat and lung troubles.

West Indians are not accustomed to an abundance of fresh air and well-ventilated, clean quarters. Living for generations in small huts where large families crowded in rooms tightly closed against the night air, the negroes from Jamaica and other tropical islands have developed lungs with cramped capacity and especially susceptible to changes of temperature. The officers in charge have found that the West Indian laborers cannot be induced to eat sufficient wholesome food to keep them in good health, even when supplies are furnished to them at cost price, and meals are made attractive at great expense to the Canal Commission.

LEISHMAN CAN MANAGE TURK

Difficulties About Embassy Imagined by Powers Jealous of America.

NAPLES, July 16.—Minister Leishman is here on his way to Constantinople, where he will present his credentials as Ambassador within a fortnight. He says he does not anticipate any difficulties, the reports to that effect being the result of misunderstandings concerning the intention of the United States to take a more active part in the Armenian and other questions in the Near East. There is reason to believe certain countries encouraged this view for the purpose of diminishing American influence in Turkey.

Fleet Gathers for War Maneuvers.

BROCKPORT, Mass., July 16.—Headed by Rear-Admiral Robley D. Evans' flagship Maine, with the battleship Missouri close behind, the North Atlantic squadron began to rendezvous in this harbor today in preparation for the naval war maneuvers. The warships anchored about a mile and a half off shore.

Marines Get Malaria on Isthmus.

SAN JUAN, Porto Rico, July 16.—The United States cruiser Columbia sailed today for Boston with 300 marines on board, of whom 165 are suffering from malaria contracted at Panama, where they were stationed in anticipation of trouble during the recent elections there. Nineteen of the marines are seriously ill.

Engineer Crushed to Pulp.

TRINIDAD, Colo., July 16.—Passenger train No. 7, on the Colorado & Southern Railway, carrying hundreds of Texas Elks to the convention in Denver, was wrecked three miles north of Fort Junction at an early hour this morning. Engineer Martin J. Cullen was killed and Fireman Charles T. Carroll badly hurt. The engine rolled over, carrying the two baggage cars with it. None of the passenger coaches left the track. Cullen was caught under the locomotive and his body crushed to a pulp.
