

SAGE'S FORTUNE ALL FOR WIDOW

Not a Dollar Left to Charity
or to His Poor
Relations.

TROY HEIRS TO CONTEST

Only Exception Is Small Bequest to
Sister, Who Is Since Dead—Estate
Will Total \$60,000,000,
Not \$100,000,000.

NEW YORK, July 25.—The World to-morrow will say:

Every dollar of Russell Sage's great fortune is left to Mrs. Sage by will made in 1901, except an insignificant bequest made to Mrs. Fannie Chapin, of Oneida, N. Y., an only sister, who died two years ago.

The will is to be read at the home of Mrs. Sage at 632 Fifth avenue today, and will be offered for probate immediately. It will undoubtedly be contested by the Troy relatives of Mr. Sage, who will charge that the 1901 will was made after a mental breakdown on the part of Mr. Sage and that Mrs. Sage exerted undue influence over him in the distribution of his wealth.

Not one dollar of the fortune is left to charity. The only contribution Mr. Sage ever made during his lifetime for this purpose was when, after a year's solicitation by Mrs. Sage, he contributed \$50,000 to build a wing of the Presbyterian Hospital, of which Mrs. Sage was vice-president.

The fortune of Mr. Sage, which was popularly believed to be \$100,000,000, even thought to be greater by the best informed financiers of Wall street, amounts to only about \$60,000,000.

BODY PUT IN STEEL CASE.

Electric Alarm Wires Are Attached
to Russell Sage's Grave.

NEW YORK, July 25.—The scenes today at the residence of the late Russell Sage on Fifth avenue lay the body of the deceased financier, were in keeping with the simple funeral services held at Far Rockaway, L. I., yesterday. A few intimates of Mr. Sage and Mrs. Sage heard the prayers that were read by the Rev. Andrew Hageman, D. D., assistant pastor of the Collegiate Reformed Church, a few minutes before the body was removed from the house to be taken to Troy, N. Y., for interment. The entire first floor of the residence was filled with floral tributes. At the head of the coffin stood a large wreath of orchids and white roses, a token from the clerks in Mr. Sage's office. In the center of the casket lay a wreath from Miss Helen Gould, and at the foot was another from George Gould.

Enclosed in a hermetically sealed copper envelope, placed within a solid mahogany coffin, the body of Mr. Sage was put in a chilled steel case, four inches thick, riveted with steel bolts, locked with a lock which can only be opened from the inside, and lowered into a grave carpeted and lined with evergreens, on which the clouds were heaped of flowers to be built. The steel case weighs three tons.

Immediately after the steel box and contents were lowered into the grave, electrical connections were made and the straining so that an immediate alarm will be given if any attempt is made to tamper with the remains. The extraordinary efforts to thwart attempts by grave robbers was sanctioned by Mrs. Sage and by her closest advisers.

The expenditure for this protection and for the coffin and accessories will be greater, so far as known, than any sum expended in the burial of any other private citizen in the United States, and is in striking contrast with the rigid economy practiced during the long lifetime of Mr. Sage.

The coffin alone, of solid mahogany, with its copper inside envelope, trimmings and mahogany handles, cost approximately \$1000. The steel case and its patent unbreakable lock cost \$22,000. It is called the burglar-proof coffin, and it is asserted that even without the added precaution of electrical protection or guards, it would be impossible for the most expert grave robber to get at the body. Mrs. Sage, it is said, has had a dread of a violation of the sepulcher, since the stealing of the body of her husband. She readily consented to the proposal for safeguarding the grave of her husband.

The steel case is of such hardness that it would take two safe experts one day to break the outer shell, and then only by the employment of specially constructed tools. There is no visible lock to be picked. Once the lid is closed down, a self-locked mechanism clamps it inside at 20 points, and not the slightest opening is left for the insertion of a wedge. The corners are all rounded.

The will of the dead financier will be offered for probate tomorrow, and then, if Mrs. Sage consents, its contents will be made public.

BURIAL OF RUSSELL SAGE.

Brief Services Are Held at Family
Lot at Oakwood.

TROY, N. Y., July 25.—The body of Russell Sage was brought here from New York today and buried in Oakwood Cemetery beside the body of his first wife. The body of Mr. Sage arrived in a private car attached to a regular train from New York. Another private coach contained the mourners and members of the funeral party, numbering 20 persons.

But two floral pieces were brought from New York to this city, one an immense wreath sent by the late banker's office staff, the other a cluster of lilies of the valley from the Sage summer home at Lawrence, L. I. The funeral cortege proceeded from the railroad station to Oakwood, where a large number of persons had gathered at the Sage family lot.

After a brief service, read by Rev. Dr. Andrew Hageman of New York, the body was committed to the grave. The words which are to be engraved on the Sage monument are:

"I have done the best that I could by the light of the day."

CANNON AT CONEY ISLAND

Speaker of House Shoots the Chutes
and Sees Other Sights.

NEW YORK, July 25.—"Uncle Joe" Cannon, of Illinois, speaker of the House of Representatives, went to Coney Island last night, saw all the sights, and insisted on being "one of the people," standing in line, taking his turn with the rest of the crowds there. He declared that the big show place would have no more enthusiastic "booster" than himself hereafter, and entertained his friends by many droll speeches.

Mr. Cannon and his companions first

headed for the scene of a thrilling melodrama. Their guide started through a private gate with the visitors to get in ahead of a crowd at the ticket booth, but Mr. Cannon stopped him. "No," he said, "I am one of the people. Let us take our turn with the rest," and he cheerfully waited till his turn came to pass through the gate. The deep-voiced youth who tells the tale of a train robbery before the curtain rises interested Mr. Cannon by his rounded periods, and when he wound up with "The wages of sin is death," Mr. Cannon remarked that the truth of the words and settled back to see the bandits do their work.

When the Speaker and his party shot the chutes, Mr. Cannon held on to his hat with a death-grip, and once ashore exclaimed:

"That loosened me up. Now let's see the whole thing." He had his picture taken, and exacted from the photographer a promise to make one apiece and then destroy the plate. Whirling down the mountain current of the devil's gorge, Mr. Cannon threw dignity aside, and, catching hold of Senator Penrose, of Pennsylvania, who is a big man, said:

FIELD GREAT TAX-DOOGER

ESTATE MUST PAY BACK TAXES
TO TOTAL OF \$2,500,000.

Chicago Property Worth \$180,000,
000, of Which Nearly All Must
Pay Seven Years' Arrears.

CHICAGO, July 25.—(Special.)—Marshall Field's executors will be asked to pay taxes amounting to about \$2,500,000. This will be by far the greatest sum ever levied upon the property of an individual taxpayer, and is practically the result of a decision by the Board of Review today fixing the value of personal property on which the Field estate must pay taxes at \$30,000,000. The real estate is worth about \$30,000,000 additional, making the total amount of property on which the estate will have to pay taxes approximately \$180,000,000.

The larger portion of the assessment against the Field estate is for back taxes on property upon which the late Mr. Field is held by the Board of Review to have avoided paying taxes. The board has gone back for seven years and levied back taxes against the Field estate for the entire period of the existence of the present taxing machinery, which was created in 1899.

ATTACK WOMAN'S VERACITY

Hartie's Witnesses Say Mrs. Ashby
Admitted Telling Falsehood.

PITTSBURGH, July 25.—Counsel for Augustus Hartie today renewed attempts to discredit the testimony of one Mrs. Mary Scott Hartie's witnesses, Mrs. Blanch Ashby, the colored domestic who lived in the Hartie home, and to prove that she had admitted that she had been promised \$300 if she would make the deposition to the effect that Clifford Hooe, the negro coachman, never had slept in the spare room at the Hartie house when Mrs. Hartie was away.

Several witnesses testified that Mrs. Ashby told them that she had lied in her deposition, and that she had been promised money for doing so. All these witnesses were put on the stand in cross-examination by Mrs. Hartie's chief counsel, Attorney John M. Freeman, and some of them contradicted themselves in several instances.

HESITATE TO STRIKE

Russian Rebels Still Hold Off
From Revolt.

WAIT TILL AFTER HARVEST

Premier Reaches Out for Support of
Moderates and Throws Jonahs
Overboard—Urgent Need of
Money to Relieve Famine.

ST. PETERSBURG, July 25.—Though it is difficult to obtain a true picture of the conditions in the interior owing to the embargo that has been put upon press dispatches, all indications point more and more to the postponement of the threatened strike until the government shall be less, and the country more, prepared for such an event; until the harvest is finished and the revolutionary movement develops spontaneously among the idle peasantry.

What news has been received from the provinces today indicates that conditions are scarcely ripe, except in the famine districts, for an upheaval. The strategists of the revolutionary council are laboring with the hotheds to induce them to postpone the call for a general strike until it can come as a supplement to the movement already under way. A definite decision will be reached within a day or so, in the re-organized Council of Workmen.

Democratic Party Dead.

The remnants of the Constitutional Democratic Deputies, many of whom, after having collected the arrears of salary and mileage due them, have started homeward, are caucusing industriously; but their importance has gone, neither the government nor the revolutionists paying much attention to the former dominant party in the lower house of Parliament.

The government, indeed, has not abandoned its efforts to enlist moderates in the Cabinet. Professor Mourmoutseff, the president of the dissolved house, for whom Premier Stolypin was vainly searching with an invitation to go to Peterhof while the former was presiding over the outlay Parliament, was, however, again appointed today; but there is not the slightest prospect that he can be awayed, even by imperial command, to take office.

Cabinet Unloads Jonahs.

No further changes in the Cabinet have been decided upon, but M. Gourko, who was assistant to M. Stolypin in the Ministry of the Interior, who was mentioned as M. Stechnsky's successor as Minister of Agriculture, and whose character may be judged by the fact that he was high in favor among both Mr. Fyodor and Prince Sviatopolk-Mirsky, probably will be jettisoned altogether by Premier Stolypin, his name alone being sufficient to damn the new government. The same fate may overtake Military Procurator Pavlov, who is now engaged in organizing the League of Estate-Owners to educate the peasantry up to his ideas before the new elections.

Money Needed for Relief.

The most urgent problem before the government in case of an immediate outbreak is the relief of the distress in the interior. The Cabinet meeting Tuesday evening was devoted to this subject, and it was voted to extend relief works in the famine districts. A commission was appointed to decide where the budget could best be cut, and the \$7,500,000 could be used for famine relief. It will be necessary also to provide more cash for the settlement of claims for damages to estate during the peasant excesses, the commission for Yekaterinburg province alone demanding \$100,000, in addition to the \$250,000 already expended, but this is capable of being deferred.

Square Deal for Black Sea Sailors.

Premier Stolypin announced to the Council of the Empire today that he had obtained from Emperor Nicholas special powers for Admiral Skrydloff in restoring and maintaining order and discipline in the Black Sea fleet. The Admiral, who departed today for Sevastopol, told the Associated Press his first task would be to investigate the arrests of sailors of the fleet and liberate those who were unjustly sent to prison. He intimated that he considered the officers largely to blame for the mutinous spirit of the various crews. The Admiral took with him a new naval procurator to see that justice is done in future court-martials. Admiral Skrydloff said he had learned that Admiral Rojensky and Captain Clado probably will be restored to the roster of the navy.

MANIFESTO OF CONSERVATIVES

Three Members of Douma Advise
People to Submit.

ST. PETERSBURG, July 25.—Count Heyden, Prince Ivoff and M. Stakovich, the three members of Parliament who refused to sign the Parliamentary address to the country issued at Viborg, July 23, today issued a separate address appealing to the people to quietly submit to the imperial decree dissolving Parliament, and to prepare for the elections of members to the new Parliament. The address points out that the Emperor acted within his constitutional rights under the fundamental law, and says that the signers of the address in offering the advice act from the profound conviction that it would be a crime in the midst of the present dangers to attempt to shake the power of the sovereign.

After firmly setting forth the views of the signers of the address regarding the solution of the agrarian and other questions, they declared that the government programme, which made co-operation between Parliament and the Ministry impossible, the address says the Emperor only exercised his legal prerogative in submitting the issue again to the people to decide whether the views of Parliament actually coincided with the sentiment of the nation.

It appeals to the people to prove by their calmness that they are fitted for self-government, at the same time to show the monarch by representatives whom "they consciously elect" what they desire, and advises them not to attempt to use force, which would be criminal madness, as surely would provoke severe measures.

SHRINK BEFORE BAYONETS

Workmen Hesitate to Strike Until
Outbreak Comes in South.

ST. PETERSBURG, July 25.—The Social Democrats have already given their vote in favor of calling a general strike not later than Monday, but some of the workmen's unions considering how limited are their resources, shrink from facing an ordeal of starvation and bayonets. Anticipating an immediate and extensive movement among the peasants in the South, they urge delay until the tide of revolt sweeps northward. The political leaders are feverishly meeting and conferring in secret, like conspirators.

Every club in St. Petersburg, except the gambling institutions, is closed. Prince Dolgoroukoff's permanent Parliament colleagues held several sessions today, but the greatest secrecy is observed to prevent the government from getting wind of the decisions. In the meantime, government notes, inspired by Premier Stolypin, are being busily issued assuring the purpose of the government's honorable intentions to continue the "liberal regime," but the fair words fall on deaf ears. The Reich scoffs at the idea that an era of liberal reforms can be inaugurated by the wholesale suppression of papers, the restoration of the censorship, persecutions, arrests, the prohibition of meetings, etc.

No word of the military disorders is now permitted to be published. Discussing the financial situation, the Reich today says that the quotations of Russian securities here and abroad are not a true barometer. The paper says that a financial crash is impending, as the government is resorting to Count Witte's system by which millions are used in Berlin and Paris as well as in St. Petersburg to bolster up Russian bonds. This is the only indirect reference made

by the press to the Parliamentary appeal to the country to cut off the government's supplies by refusing to pay taxes.

In the provinces the suppression of newspapers and the arrest of agitators continues unabated. Up to the present time there is no evidence of a general uprising of the peasantry, but news travels slowly in the country. The only sudden growth of disorder among the peasants has far reported is at Kostroma, 200 miles northeast of Moscow. A recrudescence of the revolution is also reported in the Baltic Provinces near Dittirovsk. In Orel Province the peasants on the crown estates are also reported to be in eruption.

The refusal of the authorities to send troops to save the estate of Baron Prodericks, aide de camp to the Emperor, 40 miles from the capital, which was plundered by peasants yesterday, seems to indicate that until the danger is passed it is the intention of the War Office to keep the troops concentrated in the cities and protect the lines of communication between here and Moscow and St. Petersburg and the frontier, so that in the event of serious troubles in the army becoming apparent troops can retire on St. Petersburg, where the last stand will be made.

The papers of all the political and workmen's clubs have been seized and the lodgings of a number of members of Parliament have been searched. M. Salomoff, a member of the outlawed Parliament, and editor of the "Mishin," whom the police intended to arrest, has fled to Finland.

Before the Emperor finally signed the ukase ordering the dissolution of Parliament, War Minister Rudiger and Count Palatseyn, Chief of the General Staff, each submitted a written opinion that the army could be relied upon.
