

RUSSIAN STRIKE

UNIONED TO FAIL

Fatal Lack of Union Among Leaders of Proletariat Organizations.

RAILROAD MEN AT WORK

Success of Entire Movement Depends on Their Joining It, but the Leaders Dare Not Call Them Out.

ST. PETERSBURG, Aug. 6.—The fate of the general strike, which, although it has affected close to 50,000 men in St. Petersburg, has met with only slight response in other sections of Russia, probably will be decided today, with an adverse expression of public opinion. The lack of union among the leaders of the proletariat organizations is playing against the success of the movement.

The railroad men, upon whom the success of the entire movement depends, are still working full time. The leaders of the railroad organizations are hesitating about issuing a call for a tieup. They fear being deserted and discredited by their materialistic followers, who are no more responsive to the avowed pretext of the strike, namely, sympathy with the mutineers of Sveaborg, Cronstadt and Revel, than they were to the similar reasons given for the abortive strike of last November.

Railroad Men Intimidated.

The railroad men have been intimidated by the recent law making of strikes affecting communications a penal offense. The law providing for severe punishment was enacted with direct reference to general strikes. The Council of Workmen's deputies, which met secretly at Terzoli, Finland, continued its sessions until a late hour yesterday morning. The deputies were so incensed at the timidity displayed by the railroad men that they decided to resort, if necessary, to the blowing up of bridges and the destruction of the roadbeds, etc., to bring the transportation service to a standstill.

The telegraph lines have been appealed to in vain. The final meeting of the council is being held at 1:30 this morning.

The first break in the ranks of the St. Petersburg strikers occurred yesterday, when the printers decided to return to work. The employees of several street-car lines and river ferries have resumed work.

A steady downpour of rain all day long prevented the open-air gatherings scheduled for the day in St. Petersburg, and the consequent possibility of collisions and disorders. The day was without incident. There was a number of drunken men among the soldiers.

Telegram from the interior throw little light on the manner in which the country may be expected to respond to the day's call for a strike. There has been no cessation in the number of robberies and murders in the interior.

Government's Great Hope.

The government attaches much importance to the declaration of the Poles in the Minsk Congress against the principle of expropriation and in favor of acquiescing in the dissolution of the lower house and preparing for new elections. This action is regarded in administrative circles as almost equivalent to a withdrawal of support from the revolutionary class of Poland from the revolutionist movement.

Novos Vremya's Wild Dream.

The Novos Vremya, which is the only newspaper appearing except in dodger form, devoted a large portion of its space this morning to an article in which it was endeavoring to paint a picture of the United States, and predicting a sure and speedy victory for the Japanese, the seizure of the Philippines, Hawaii, Guam, and the occupation by the Japanese of California.

APPREHENSION AT ODESSA.

Cossacks Again in Streets—No News From Sevastopol.

ODESSA, Aug. 6.—Telegraphic communication between here and Sevastopol has been interrupted for the last 48 hours. Governor-General Kaibler has not yet returned from Sevastopol. Flashlight signals were exchanged at midnight last night between the roof of the commandant's residence here and a torchboat a few miles off.

There is a certain apprehension of impending events. For the first time in two weeks Cossacks appeared in town last night, forming double guard at the residence of the Governor, the prefects and the commandants and at public buildings.

Persistent reports are circulating concerning conditions at the garrison. The French Consul here has been instructed by his government in case of necessity, to give refuge to all fugitives irrespective of nationality.

WHIP MINERS TO DEATH.

Cossacks Fail to Prevent Spread of Strike at Usovka.

UZOVKA, Aug. 6.—In spite of the proclamation of the Governor-General to take "extraordinary measures" in case the workmen still laboring in the mines should cease work, the summons from St. Petersburg for a general strike has met with the approval of workmen here. The postal, telegraph and telephone employees today expressed to the Associated Press their willingness to strike, and even an officer of the Cossacks said he viewed the strike with satisfaction.

Now Favor Expropriation.

Baltic Nobles Change Front on the Land Question.

RIGA, Aug. 6.—At a congress of Baltic landowners, held here today, a resolution was passed in favor of the sale of crown and church lands and the gradual expropriation of estates in excess of the established maximum. No peasant family owning more than 50 acres may obtain land under this system.

Revolutionists Avow the Crime.

SAMARA, Aug. 5.—The fighting organization of the revolutionists has issued a

proclamation avowing responsibility for the assassination August 3 of Governor Block, of this city. Many arrests have been made. The Governor's body was torn to fragments by a bomb.

Fatal Riot in St. Petersburg.

ST. PETERSBURG, Aug. 5.—A collision between strikers and policemen occurred at the railroad station at a suburb of St. Petersburg at 4 o'clock Saturday night. One policeman was killed.

Vistula Railroad Tied Up.

BROMBERG, Prussia, Aug. 5.—The German railroad authorities announce that they will not accept freight for points on the line of the Russian Vistula Railroad, as the latter has refused to forward it.

Arrested for Reading News.

YEKATERINOSLAV, Aug. 5.—The conductor of a street car was arrested here today for reading to his passengers, among whom were several soldiers, accounts of the mutiny at Sveaborg.

Torch Applied at Poltava.

POLTAVA, Aug. 6.—The torch has been applied to the stables, granaries and other buildings on the estate of Princess Chaplinsky. A flour mill also was destroyed. The incendiaries are not known.

Propagandists Under Arrest.

MINSK, Aug. 5.—Two workmen have been arrested at the barracks for distributing revolutionary proclamations among the troops.

MANY TO MEET AT BOISE

WASHINGTON HOPES TO CAPTURE NEXT CONVENTION.

Interest High in Districts Where Arid Lands Have Been Transformed Into Garden Spots.

NORTH YAKIMA, Wash., Aug. 5.—(Special).—During the first week of September the National Irrigation Congress will be in session at Boise, Idaho, with an attendance of several thousand delegates. Exhibits of fruit and honey are being prepared by different localities and states. The premiums are liberal. It is expected that the Governor of Washington will appoint 50 delegates, that each commercial club will appoint ten, and that each Board of County Commissioners will appoint five. It is believed that if a full delegation attends the convention it will be able to secure the next National congress at some point in this state. It is hoped that the various fruitgrowers' associations and the State Beekeepers' Association will have on exhibition products of the orchard and apiary which will take silver cups and other premiums. The Yakima County Horticultural Union is arranging to send a delegation of fruit and honey. The delegation from that county will ask the convention to pass a resolution memorializing Congress to appropriate \$500,000 for reclamation of arid lands in the West.

The State Beekeepers' Association has secured a Bigelow observatory hive, stocked with pure Italian bees, for the purpose of giving object lessons in the apiary. It will be used at the monthly meetings of the association to teach farmers and the high-school classes. It will be one of the interesting features of the display at the Washington State Fair. The secretary of the fair has agreed to set apart one of the prominent corners in the main pavilion for the exhibit, and \$200 has been appropriated for premiums in that division.

The three days' midwinter convention of the State Beekeepers' Association will be held at the Agricultural College at Pullman next January, and the observatory hive will be in full operation to instruct the students of that college. The students of the Idaho Agricultural College, which is only nine miles from Pullman, are also invited to be present at that meeting.

The business of beekeeping is an adjunct of the orchard, bees being the best friend of the fruitgrower, for the reason that these insects cross pollinate the blossoms and increase the yield. These two industries go hand in hand, and are rapidly becoming valuable sources of income.

As an example of what organization does, a few years ago the Yakima County Horticultural Union incorporated and sold its shares of stock at \$10; the past year the dividends were 75 per cent. A warehouse 60x100 feet has just been completed, its material being stone and the structure of steel and concrete. The front being on the Northern Pacific, the warehouse and the other on the North Coast road. The shares are now selling at \$30, and it is anticipated that the capital stock will have to be increased in order to accommodate the demand.

Fruit Inspector Brown, of Yakima County, says that in five years from now, he calculates that 12,000 cars per year will be shipped from the warehouse at North Yakima.

TROLLEY CARS COLLIDE

Seventeen Persons Injured In Wreck In Massachusetts.

WORCESTER, Mass., Aug. 5.—Two cars met in a collision on the Worcester & Holden trolley line, five miles from Worcester, today, and 17 persons were injured. The cars were seriously damaged. Miss Campbell, 29, of Boston, fractured skull, may die; Miss Florence Johnson, Worcester, broken knee cap, shock, condition serious; Miss Bertha Royce, Worcester, face injured about lower lip; Roland Johnson, Worcester, abdominal injuries, condition critical.

OVATION AT CAMPINAS.

Brazilians Greet Secretary Root—Inspects Model Plantation.

SAO PAULO, Brazil, Aug. 5.—Elizhu Root, United States Secretary of State, today visited the model plantation of Senhor Elio de Chaves. In passing through Campinas, he was greeted with ovation from the populace. He and his party returned here this evening.

Crank Arrested at Oyster Bay.

OYSTER BAY, Aug. 5.—Karl Cook, who said he was a lawyer from Washington, was arrested last night by secret service men while attempting to climb Sagamore Hill. Today Cook was sentenced to five days in the county jail at Minola on a charge of vagrancy.

WASHINGTON, Aug. 5.—Nothing is known here of Karl Cook, arrested at Oyster Bay today by Secret Service officials.

Captured Cruiser at Hakodate.

LONDON, Aug. 5.—The Daily Mail's Hakodate, Japan, correspondent says that the Russian cruiser Novik, which was sunk by two Japanese cruisers at Korsakovsk, Sakhalin, in August, 1904, after the battle of Port Arthur, and which subsequently was floated, has arrived there.

UNION OBEYS INJUNCTION

Chicago Federation Bows to Order Issued by Hostile Firm.

CHICAGO, Aug. 6.—(Special).—For the first time in the history of organized labor, the Chicago Federation of Labor today authorized members of that body to obey an injunction issued against labor unions. The injunction was issued some time ago against the Bakers Union No. 2 in favor of the Heuser Baking Company, and denied union men the right of interfering in any way with the Heuser Baking Company's employees and denying union men the right of loitering around the building occupied by the baking company, talking to any employee, or entering any place where bread made by the complainant was sold. The federation interpreted this order today as meaning that any union man who entered any bakery, grocery store or any other place where Heuser bread was sold was liable to arrest. Heuser instructed the delegates present to keep out of every store that handled that company's bread.
