After the affray the men called at police headquarters to seek a warrant for McGahan's arrest, but they declined to swear to a complaint. The police then acted in order to enforce the ordinance against the indiscriminate discharge of firearms in the city limits.

TALKS OF THREE WOES

Large Audience Hears Evangelist Gell at White Temple.

A large audience attended the services at the White Temple last night. This was the last special service of William Edgar Gell, for he will give tonight and Friday night his famous "Travelogue" entitled "Cannibals: Before and After," and "Through Pagan Land," to which the general admission will be free.

Mr. Gell spoke forcefully and convincingly on a much-neglected subject—"The Three Woes of the Book of Revelation." Taking for his text Revelation 1:12, "One woe is past, but behold there come two woes hereafter. He spoke, partly, as follows:

There are four great points in the unconscious theology of Homer-dod, the Atonement and Future Life. Everybody has a theology of some kind. It may be an unconscious theology, but it is there. I have spent five years and thousands in money trying to find a race or a nation or a tribe, a family or an individual without a religion. I have not been able to find one. The whole human race, to say the least, possesses an unconscious theology. Even the 250 islands of Fiji all together acknowledge one supreme God.

The first woe mentioned in Revelation is the hour of death to the sinner, because of the activity of man's sin in his time. Our memory retains everything, but we cannot always recollect things. Those who have been snatched from the very brink of death say that at that moment the panorama of the whole past life, passed before them, and events stood out like mountain peaks upon a landscape. Our memory will retain the things that we have in the coffin beneath the sod, but our memory will live forever, and that hour of death to the unsaved man will be an awful thing because of the activity of the memory.

The "second woe" is the judgment, "when every man shall give an account of the deeds that he has done." This is when men will really get their deserts. I see the wicked prosper here. I see the good man die and had men die. There will be a judgment, but this judgment will be a "woe" to the unsaved man, to the one who has contributed so much to the world's misery, that it has crystallized him into a sin.

The third and last "woe," and the most terrible of the three, is the extinction of the sentence passed upon the unrighteous—let them go into the mist of darkness.
