

MORE FURNITURE TRUST MEN FINED

Score of Members of Combine Plead Guilty Before Judge Wolverton.

OTHERS SOON TO APPEAR

Furniture Exchange Members Pay \$25, and Second-Hand Dealers \$10 Each—Fifty-seven Will Plead on July 10.

Twenty more members of the Pacific Coast furniture trust pleaded guilty of being in the combine, before Judge Wolverton, in the United States District Court yesterday morning, and as many more are expected to do so today.

Seventeen of the smaller concerns and three members of the Furniture Exchange were in the party. In several cases the guilty persons were fined \$25, while the second-hand dealers were assessed \$10.

Fifty-seven firms appeared and were given until July 10 to plead to the charge of violating the anti-trust law. This accounts for 27 members of the trust, and leaves 88 firms still to come forward and state their cases.

Assistant Secretary Frank F. Freeman, lawyer, presented the names of about 40 clients who will appear in court on July 10. Five of them later decided to enter pleas of guilty.

When asked yesterday if the bench warrants would be issued to those failing to appear shortly, Assistant District Attorney Cole stated that he doubted that this would be necessary. Nearly all named in the indictments, he said, had communicated with him by telephone, letter, or by attorney, and he did not look forward to any further being required to have the remainder come forward. He is weeding out the smaller fry as rapidly as possible and it will be with the leaders of the combine that the law will grapple here.

The Furniture Exchange is looked upon as the forcible element in the monopoly.

JUROR CALLS FOR A HALT

Confesses to Court That Lawyer's Speech Is All Greek.

That he was muddled to begin with and grew more muddled as Lawyer Minor talked was the complaint made yesterday afternoon by William Stanton, who rose in the jury box to explain his mental tangle to Circuit Judge Fraser. The case being heard by the jury is the condemnation suit entered by the Oregon Electric Railway Company against the Terwilliger Land Company and the South Portland Improvement Company to obtain right of way through land the defendants value at \$50,000.

"I am muddled," said the juror, "and get more muddled as the learned gentlemen talk. I can't tell you now whether they want a streetcar to go through that land or a freight train." Judge Fraser informed the juror that the remarks of the attorney were germane to the subject, and the trial continued.

Laborer's Suit on Trial.

Before Circuit Judge Sears is being tried the case of Harold F. Wilde, who sues Robert Wakefield, the contractor who erected the Wells-Pargo building for \$15,000 damages, alleging the defendant is responsible for an accident to the plaintiff while the latter was working as a derrick hand. Wilde contends that he was injured through the carelessness of Wakefield in permitting the operation of a derrick with manila rope instead of steel cables. Wakefield says Wilde sustained the injury through his own carelessness.

Wild Sent to Penitentiary.

For embezzling \$40 from the Crystal Ice & Storage Company, A. R. Wild was sentenced to serve an indeterminate sentence of from one to ten years in the Penitentiary yesterday by Circuit Judge Cleland. Wild was a salesman for the ice company and fled to Los Angeles with the money. Judge Cleland also sentenced Sam Nelson, a cook, to three months' imprisonment for assault and battery on a 6-year-old child. Nelson was employed at a sanitarium in the vicinity of Mount Taber.

Given Time to Plead.

Before Circuit Judge Cleland yesterday four suspects were arraigned, all of the prisoners being given until next Saturday to plead. The prisoners arraigned were Frank Kelly, charged with robbery of the Graham bank; Malcolm McCauley, accused of embezzling \$3000 from the Oregon & Washington Lumber Company; Guy P. Ritter, held for obtaining \$20 under false pretenses; and Harry Montrose, charged with a statutory crime.

Syrian Husband in Tolls.

Accused of wilfully refusing to support his wife and baby, Najib Khury, a Syrian, is confined in the County Jail in default of \$200 bonds, awaiting a hearing before County Judge Webster. Mrs. Louise Khury, who is American, swore to the complaint charging her husband with non-support. Previous to this complaint she had had him arrested for assault and battery.

Three Years Her Sentence.

Three years in the Penitentiary was the sentence pronounced yesterday by Circuit Judge Fraser upon Beatrice Lewis, the colored woman convicted last week of grand larceny. Beatrice Lewis was the accomplice of another colored woman, Grace Reed, in robbing Andrew Johnson in a Flanders-street resort last April. The Reed woman is a fugitive from justice.

Kamm's Executor Discharged.

Reporting that the 39 claimants against the estate of Charles T. Kamm had been paid 24 per cent of their claims, a pro rata approved by the County Court, C. P. Adams, the executor, was discharged yesterday by County Judge Webster and relieved from further responsibility, none of the claimants having entered protests.

Predicts Douma's Dissolution.

LONDON, June 12.—A dispatch from St. Petersburg quotes M. Furshkevitch, the conservative leader, as declaring that the dissolution of the Douma is eminent, at the most within a fortnight.

Police Court Places Restraint on Mrs. Slight's Too Energetic Tongue

Neighbors of Kearney Street Matron Testify That She Is a Most Uncommon Scold—Judge Makes Peace \$50 to Close Incident.

Legal restraint was placed upon the energetic tongue of Mrs. E. Slight, of 488 Kearney street, yesterday forenoon. She relinquished all claim to the title of neighborhood scold, and promised that hereafter she will be the most pleasant and neighborly of women. As an evidence of good faith she posted \$50 as a forfeit with Municipal Judge Cameron.

Pretty much the whole neighborhood was on hand yesterday in the Municipal Court, to tell of grievances against the voluble Mrs. Slight. From the witness stand she was charged with profane vituperation such as would make the blood of a cavalry non-com run cold. Only last Sunday, she was declared, she abused Mrs. Driscoll until that matron swooned under the harangue. Denied the privilege of helping revive her victim, Mrs. Slight is said to have turned her vocal batteries on Mr. Driscoll.

Back in the good old Puritan days an ample remedy was prescribed for neighborhood scolds, but people have grown more tolerant since then, and the worst scolds get nowdays a small fine. Not wishing to have a fine imposed, the neighbors held off until, as they say, Mrs. Slight's habits became unbearable.

Then the Driscolls had her arrested on a charge of using abusive language. Jack Day, a private detective, who lives in the Slight household, described one of his experiences with the defendant. He and a friend placed a tent in an adjoining lot for physical culture purposes, while they were in gymnasium costume, and engaged in bag-punching. Mrs. Slight leaned over the rear fence of her yard, pulled back the flap of the tent, turned a garden hose on the

two men, and gave them a soaking. In explanation, she said the sides of the tent touched her fence, and that she could not permit any such infringement on her property rights.

It was said that Mrs. Slight has another bad habit, too, of giving Comanche yells that are likely to break even the middle of the night awaking the whole neighborhood. These yells are invariably accompanied by her appearance on the street in various extraordinary attitudes. It was said.

Mrs. Slight protested her innocence, and denied ever having abused anyone. To prove it she had on hand a diminutive, elderly little woman who lives in the same neighborhood. He said he never heard Mrs. Slight use profanity. Judge Cameron took it that the evidence was questionable. While believing the case to be one of an aggravated nature, the court said he would impose no fine since he thought a peace bond would be far more effective. "You will deposit \$50 bail with the court," said he, "and you do not become a better neighbor you lose your fifty."

Mrs. Slight gave assurance that there would be no possible cause for complaint concerning her conduct in the future.

Russia Will Borrow Again.

NEW YORK, June 12.—A Paris dispatch to the Times states that arrangements are being made by European financiers to supply Russia with \$30,000,000 in gold, of which sum the United States is to furnish \$12,000,000. The understanding is that the money is to be applied exclusively to domestic needs.

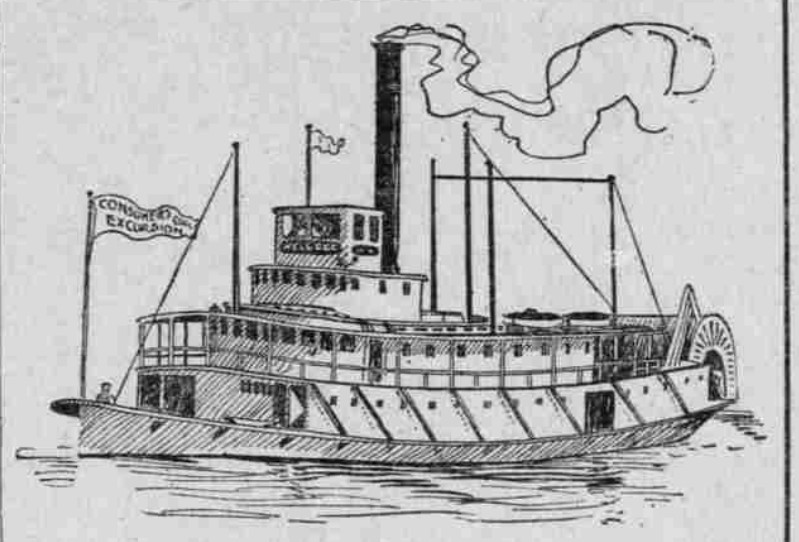

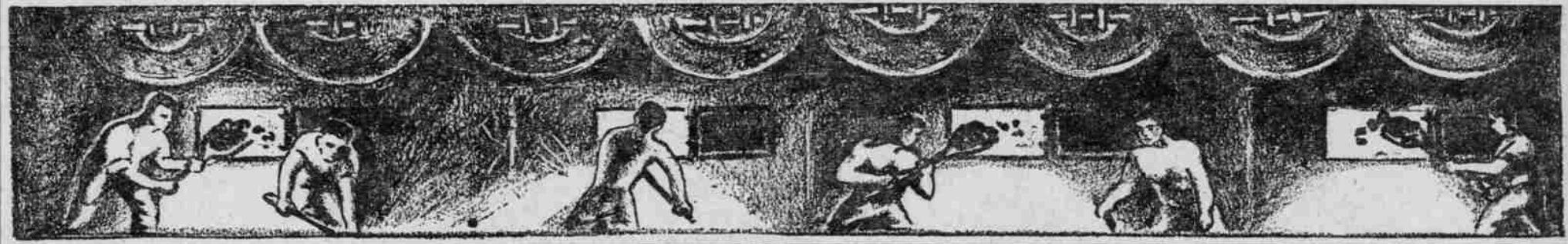

TELLS OF THE TRIAL

Witness From Boise Discusses Harry Orchard.

THINKS HE TELLS TRUTH

Rev. James Russell, Who Is Returning From Idaho, Says Dynamiter Was Really Convinced and Is Doing His Duty.

Rev. James Russell, a member of the Presbyterian synod of California, was in Portland yesterday on his return to Southern California from the Haywood murder trial at Boise, he having been subpoenaed as a witness. Rev. Mr. Russell was in Caldwell at the time Governor Steunenberg was murdered, and occupied a room at the hotel, directly over the one which Orchard occupied while he was making his infernal machine for the assassination of the ex-Governor. At the time he met Orchard, shortly before the murder, Orchard represented himself to be a sheep buyer, Mr. Russell says. In an interview last night Mr. Russell said: "Orchard had with him a fellow going under the name of J. L. Simpkins. When I was on the witness stand, I identified him as the man from photographs which were shown me. They have not yet succeeded in locating Simpkins, as he left the country just before the murder occurred. When I knew him Orchard was going under the name of Hogan, and was introduced to me under that name by Mr. Dempsey, the hotel proprietor."

"Right after the murder, Orchard came near giving himself away when he was cleaning himself up by spilling a bottle of cologne on his hand in his pocket. He also had in his pocket a giant cap, and this exploded when the acid reached it. He was burned a little, but the excitement was so great at that time that

those who heard the explosion did not think of it connected with the murder, and very few heard it. Before the murder was committed, Orchard had changed his boarding place, and gone to the other hotel in the town, as I had told him that I had been doing evangelistic work in Cripple Creek.

"Orchard had experimented with his infernal machine so that he was dead sure it would work. How well it did work you know.

Did Not Look a Criminal.

"On the night of Orchard's arrest I went up to him, and was about to speak to him, as I had no thought of what had happened. The detectives kept me away. I always supposed him to be a man of good habits. He did not look to me like a criminal. Immediately after the deed was committed all avenues of escape from the town were closely guarded. Knowing he could not escape he tried to run a bluff on the detectives by saying to them, 'I am a stranger in the town. Why don't you arrest me?' They took it as a bluff, and let him go for three days at least, when they finally took him into custody. On searching his room they found the remnants of powder caps and acid he had been using in the manufacture of the bomb.

"There is now an undercurrent of feeling in Boise against the Federation of Fields. At the trial Darrow is showing his littleness of character. Richardson being a superior man in every way. But even he is beginning to wear under the strain and to lose his patience at times. It is perhaps because he feels the hopelessness of the case for the defense.

"Everybody who has heard Orchard's statements believes them to be absolutely true, because of the straightforward way in which they have been told, and because some of them have been verified. It is, of course, believed that the real reason for Orchard's confession is that he has been converted to Christianity.

Thinks Orchard Converted.

"I was talking with Dean Hinks, of the Episcopal Cathedral in Boise, the other day. He has been Orchard's spiritual adviser, and believes the man is truly converted. He told me that Orchard is a changed man. Mr. Hawley said that when the trial was first talked of Orchard wanted to tell the whole story, but he told Mr. Hawley that if he told all he would be compelled to give his true name, and that would bring sorrow and suffering to his relatives. He did not want to do that. A few months before that, however, he did not care

how much suffering he caused anybody, relatives or otherwise.

"There is another thing that makes me believe that Orchard is all that he professes to be, and that is his attitude on the witness stand. He never becomes angry, no matter how provoking the questions may be. Some of them are almost personal thrusts. Both the lawyers for the prosecution and for the defense become angry over things which come up at the trial, but Orchard remains serene and calm, like a rock in the tempest. Richardson, a master in asking questions, has not succeeded in one instance in tripping the witness, though he has done his best.

Try to Kill Orchard.

"There have been attempts on the life of Orchard. Two men found in the city with explosives in their possession were arrested a short time ago. Orchard is guarded with jealous care. Few know when he leaves the courthouse in the cab, and it is not safe for anyone to follow the cab if they do see him leave, as the building is guarded both inside and out with a great many guards.

"One day while there was the weather was stormy, so many of the spectators brought umbrellas with them. They were all compelled to lift the umbrellas above their heads and open them in order to expose any hidden packages there might be there. One man was ejected from the room because he carried a package, but this was discovered to be a bundle of papers.

"I think it almost certain that if Hawley is convicted the other men implicated will be also."
