APPLES ON DISPLAY

Farmers of Old Yamhill Make Fine Showing.

MERCHANTS OFFER PRIZES

Splendid Display Will Be Moved to Portland and Entered in Contest Here—Walnut Exhibit Feature of the Show.

McMINNVILLE, Or., Oct. 31.—(Special.)—Today marked the opening of the Yamhill Apple Fair here. Every degree of apple is on display, from the carefully tended pet of the orchard down to the shapely seedling without a name that grows prolific in the fence corners along the highways. There are more than 100 entries of fruit so far, besides some that could not reach here for the opening day.

Millard O. Lowndale, of Lafayette, has a magnificent collection of apples in which three-tiered Baldwin and four-tier Spitzbergs vie with the Ben Davis, Rome Beauty, Monmouth Pipin, Belle-fleur, King, Northern Spy and Rhode Island Greening for supremacy. Mr. Lowndale's collection is invaluable to the amateur horticulturist, for he has demonstrated the different systems of wrapping, packing and handling apples to the best commercial advantage to the grower. Besides being by far the largest collection here, Mr. Lowndale also exhibits the greatest number of varieties of apples.

S. C. Van Dorn, of Dayton, is exhibiting some fine Baldwins, Ben Davis, Arkansas Black and Northern Spies. His booth also contains Macintosh walnuts, soft-shell almonds and Italian chestnuts. F. W. Wallace shows a nice lot of three-tier Kings and four-tier Rome Beauties. While the exhibitors named have the largest individual collections, they don't assume to be "the whole show." In the large number of plate exhibits that can be seen in any part of the world, it is to be expected that some of the apples of the nine silver cups will be given as premiums by the business men of McMinnville.

In the English walnut display Prince & Son, of Dundee, are in the lead with a large collection of the different varieties that by actual demonstration they have found to be adapted to the soil and climate of old Yamhill.

Morrison, Myers and Greer, also of Dundee, and Harrington and Barnett, of North Yamhill, are among the walnut exhibitors, besides Mrs. R. Leath, Mrs. Jones and others, of McMinnville, who are exhibiting the fruit from a few trees. Walnuts, almonds and chestnuts are plentifully represented, and there will be glory and a premium for all. The fair will continue for three days. The exhibits in nearly every instance will be taken to the Portland Apple Fair and entered in the name of Yamhill County.

Figures Out Net Income.
OLYMPIA, Wash., Oct. 31.—(Special.)—Because the bondholders of the Port-

Townsend Southern waived payment of \$4,720 annual interest on the \$212,000 outstanding mortgage bonds, the company was able to show a net income for the year ending June 30, 1907, of \$507 and was able to cut down the deficit from previous years' operations that amount. The company rates 41.2 miles of track, 15 miles being from Olympia to Tenino and the remainder being between Port Townsend and Quilcene. The company is controlled by the Northwestern Improvement Company (Northern Pacific).

PRISONER SWALLOWS SPOON

Insane Man Gulps Utensil Down With Food Handed Him in Jail.
TACOMA, Oct. 31.—(Special.)—Joseph Carbons, who is in the County Jail awaiting removal to the ward for the criminal insane at Walla Walla, last night devoured a tin spoon which had been handed him along with some food. When Deputy Sheriff Desmond gave the prisoner the spoon, the latter immediately began to tear and twist it between his teeth and then swallowed it.

PRUNE MARKET HARD HIT

Growers Who Have Not Shipped Get Notice Fruit Can't Be Handled.

SALEM, Or., Oct. 31.—(Special.)—The financial stringency has affected the Oregon prune market about as much as it has affected anything. Because of the scarcity of money the market has become absolutely dead. The packers are now shipping the crop, but have been requested by some of the Eastern buyers to delay shipments as payments cannot be made.

Packers have contracted for more prunes than they have sold and now there is absolutely no sale for the fruit. In consequence of this the few growers who have not yet sold are unable to get any kind of an offer. It takes a large amount of money to buy, pack and ship a prime crop and the financial crisis came just at the time when packers had to have the money in order to handle the crop promptly. No permanent loss is anticipated, unless some of the packers may have bought too heavily at the top of the market and may not be able to make their contracts good.

Was Once Well Known Here.

ASTORIA, Or., Oct. 31.—(Special.)—A letter was received today from Shelbyville, Ky., stating that Major George W. Logan, at one time a well-known resident of Oregon, died at the former place on October 6, aged 75 years. He was born in Kentucky on October 12, 1832, and in the early 50's came to the Pacific Coast, where he remained for about six years. A portion of that time he spent in Portland and Astoria and he was one of the men in charge of the party which, in 1855, cut a Government trail from Young's Bay over the mountains to the Willamette Valley. On returning East, Mr. Logan enlisted as a private in the Confederate army, serving through the Civil War, in which he was promoted to the rank of Major. After the war, he engaged in the manufacture of flour at Shelbyville, establishing the Logan & Logan Company, of which he was president at the time of his death.

Golden Eagle Changes Hands.

The Golden Eagle department store has been disposed of by the assignee to I. L. Schlitt, a merchant of Vancouver, Wash. After adding to the depleted stocks left by the sales conducted by the assignee, Mr. Schlitt will conduct the place under the same name. Mr. Schlitt's assistant in the management of the place.

STEAL TO SHIELD WALSH

RECORDS AGAINST BANKER HAVE DISAPPEARED.

Young Woman Employed in District Attorney's Office and Male Companion Arrested for Theft.

CHICAGO, Nov. 1.—The Inter-Ocean says: Secret Service operatives yesterday reported that some official correspondence between Attorney-General Bonaparte and District Attorney Edwin W. Sims, containing Government secrets relating to the case of John R. Walsh, formerly president of the Chicago National Bank, now defunct, awaiting trial in connection with the failure of the bank, had been stolen from the files in the Federal building.

Miss Etta L. McLean, who has been employed in Mr. Sims' office for three months, was arrested in company with a woman, charged with "conspiracy to steal from the records." Miss McLean, who is a graduate of an Eastern college, is alleged to have procured possession of the records and given them to Gordie, who lived in the same building with her on the North Side. The records are believed to have contained information to be used in the forthcoming prosecution of Mr. Walsh.

Miss McLean and Gordie were taken before United States Commissioner Foote yesterday and hearing of the case was continued until Friday. Miss McLean was released upon giving her word to appear at the hearing, while Gordie was taken to the County Jail. Both maintain their innocence.

MASTS TOUCH THE WATER

Sealing-Schooner Markland Has an Exciting Experience in Gale.

VICTORIA, B. C., Oct. 31.—The sealing schooner Markland, which has arrived at Nanaimo, was almost capsized in a heavy gale in Bering Sea, and Captain Heater had a narrow escape from drowning. The schooner heeled over so much that the masts touched the water. Captain Heater clung to the vessel's side while she slowly righted herself.

The gale blew suddenly September 30 and carried away the schooner's trysail, then she heeled down and almost turned turtle, there being some minutes of agonizing suspense for the crew until she slowly righted. The bulwarks and all canoes and boats were utterly wrecked, being scattered in splinters about the deck. None of the schooner's buffeting was brought in by the steamer Tees, which arrived tonight from Vancouver Island Coast. The schooner Allie L. Algar has also arrived on the coast and the sealers report all vessels with low catches.

BOTH SURE OF VICTORY

Columbia and West Side High Play Football Today.

"We will do things to that Columbia bunch tomorrow," said Coach Henderson of the West Side High School football team yesterday, speaking of the game with Columbia tomorrow afternoon, but Frank Loneragan, who has charge of the Columbia squad doubts Henderson's statement. "Columbia will win tomorrow's game," said Loneragan, "and will win it by one touchdown." Judging from the statements of the

coaches, the game tomorrow could be doped out as another of those scoreless contests like the four others played this season by the league teams.

Tomorrow's game in a way will decide the championship. It is admitted by all the followers of the game, that the championship lies between Columbia, Hill and West Side High. Should the game tomorrow be a tie, the teams would stand in exactly the same place, but if one of the teams can score, then the defeated team will be out of the championship race.

Columbia has been strengthened for the game, and will go on the field with a much better team than that played in the previous games. John Quinn, a big guard who has played on the Varsity for the past three years, will be out in uniform, to help defeat the High School lads.

The High School will send out the same bunch that played in the Hill and Portland Academy games. Paul Rader will probably referee tomorrow. Professor Thorne, of Portland Academy, will act as umpire. The game will be called at 3:30 o'clock.

JAPANESE TO CELEBRATE

Will Observe Emperor's Birthday at Y. M. C. A. Sunday Night.

Next Sunday will be the birthday of the Japanese Emperor, Mutsuhito, and his subjects in Portland have planned a grand rally, to be held in the Y. M. C. A. auditorium at 7:30 o'clock Sunday night in his honor. Mayor Lane will speak and Vice-Consul Thunell Alta will read the Imperial Japanese edict on education, being the moral code issued by the Emperor, 17 years ago. It will be followed by all the public schools of Japan. Every Japanese child must be educated according to the principles embodied in the code.

All Americans who desire to participate in the festivities are invited by the Japanese to attend the rally. Sunday morning, between 10 and 12 o'clock, many of the local Japanese will repair to the Consulate to pay their respects to the Emperor through his representative, and to worship images of the Emperor, the Empress Haruko, and the Crown Prince Yoshihito, according to their custom.

Between the hours of 5 and 8 on Saturday evening, a reception will be given by Vice-Consul Alta, at the Consulate, 447 Fifth street, to which all Japanese and their American friends are invited.

HOLDEN WILL BE FARMER

East Side Battalion Chief to Quit Fire Department in January.

Battalion Chief Lee Holden, of the East Side, is making preparations to leave the Portland Fire Department and become a farmer some time in January. He has just returned from the 150-acre farm on the Mount Hood road, 50 miles from Portland, which he and H. S. Rowe bought last Summer. He spent some time on the farm and dug the potatoes from one acre, which produced 211 sacks of prime late rose variety. It was a remarkable yield. He found other vegetables in the same proportion. He brought home two heads of cabbage, the smallest weighing 12 pounds. Mr. Holden says he is more than satisfied with the farm, and that the fertility of the soil is even

better than expected. He will begin sending out tools and other articles that he will need, and will move probably in January with his family. He and Mr. Rowe will put up a small sawmill on the place in the Spring and lumber will be cut on the place for the buildings they will need.

Mr. Holden has been in the fire department for a long term of years, beginning with the old volunteer fire company of East Portland before con-nan as battalion chief on the East Side. He is a skillful architect and builder, and practically all the new engine-houses in the city were built from plans and specifications which he prepared.
