

JAPANESE INFLEXION

Fifteen Hundred Are Coming From Honolulu Within Next Month.

THREE HUNDRED AT ONCE

All Are Armed and No Steps Taken to Disarm Them—Lodging-House Keepers Have a Hard Time to Find Accommodations.

VANCOUVER, B. C., Jan. 3.—(Special.)

FINDS WALSWORTH IS GUILTY

Coroner's Jury in Mankins Killing Affair Returns Verdict.

JACKSONVILLE, Or., Jan. 3.—(Special.)—After two days' investigation the coroner's jury returned a verdict in the case of the death of James W. Mankins.

The case seems to be very complicated owing to the number of witnesses and the general confusion. In all, 12 witnesses were queried, and 45 closely typewritten pages of testimony were taken.

EARTH SHAKES IN ARCTIC

SEVERE SHOCK SUNDAY ON CAPE PRINCE OF WALES.

Disturbance Recorded in Maryland and Also by Instruments on Isle of Wight—Heaviest of Year.

SEATTLE, Jan. 3.—A special telegram to the Times says: Reports just reaching Nome are to the effect that a severe earthquake visited Cape Prince of Wales Sunday, lasting two minutes.

The whole section shook and immense quantities of rock were loosened from the nearby cliffs. The natives and white people were frightened by the severity of the quake.

Cape Prince of Wales is northwest of Nome, at the entrance of the Behring Straits. The Alaskan Coast has been visited by many seismic convulsions in the past year, but that coming at the close of the year is regarded as the most severe.

At the same time, the seismological instruments at Slide Hill Observatory, on the Isle of Wight, gave evidence of something unusual stirring within the bowels of the earth somewhere.

Professor John Milne, well known earthquake authority, said at the time that it was one of the greatest disturbances he had ever observed.

WENT TO GOLDFIELDS IN 1830.

THE LATE ANDREW J. BROWN, of Baker City.

BAKER CITY, Or., Jan. 3.—(Special.)—Andrew J. Brown, whose death occurred here recently, was 84 years old and had been a resident of Baker County since 1867.

Mr. Brown was born in Nashville, Tenn., January 29, 1824. At an early age he went with his father to Illinois, later removing to Iowa.

In 1850 Mr. Brown crossed the plains to California, where he remained three years during which time he engaged in mining. On account of ill health he was obliged to return to Iowa, where he took up farming.

SENTIMENT AT HOQUIAM

Comparatively few business men signed the petition. Many have condemned the cause of resignation with the fact that there has been a well defined movement among saloon men to have the Marshal and City Attorney removed in order that the city may be thrown open. The true facts in the case have been appreciated by the parties interested.

Councilman Richardson opposed the resignation of McKenney and plainly stated his reasons therefor. Senator Polson advocated re-instatement.

The belief that the signers of the petition were misinformed was so strong that a motion prevailed to refer the matter to the Police Committee, supplemented by a statement by the Mayor that if the petition stood as presented at the next meeting he would reappoint McKenney to his former position.

McKenney is a leading candidate for Sheriff and politics enter largely into the effort for his reinstatement.

of which McKenney's resignation was demanded, he tells an untruth. "The facts are that some time before McKenney was formally charged with conduct unbecoming an officer, Mrs. Regan, in the presence of Mayor McIntyre, Judge W. Hodgson and myself, voluntarily made a statement in which she accused McKenney of having had undue intimacy with her on a number of occasions. This statement did not satisfy Mayor McIntyre, who demanded that McKenney be reduced to writing. This Mrs. Regan agreed to do, but when the time came to make the written confession her physical condition was such that she could not do so, and at her request I wrote the confession out at her dictation, she afterward signing it. But this did not suffice for the Mayor afterward sent Mrs. Regan, who went to his office and reiterated her first statement.

"The demand for McKenney's resignation was then taken up by the Council before McKenney's resignation was read and when McKenney was asked what he had to say he replied by saying that while he had some honor left he had been unable to resist the advances made by the woman. He then sought to place all of the blame on Mrs. Regan, and knowing that she called him a liar, McKenney then assaulted me, tearing part of my clothes from my back and striking me, from the effects of which I was confined to several days at the Hoquiam hospital.

"This man McKenney invaded my home and destroyed it, and now that he has been called to account, he has undertaken, cowardly, to place all of the blame on me. I am a married man of fact, McKenney has for some time been groomed as a candidate for Sheriff and political associates are standing by him at this time because should he be deposed in disgrace as City Marshal, the schemes of his political supporters would be all the more easily carried out.

"From the beginning of this trouble I have sought to prevent any undue publicity in this disgraceful affair and I would not submit this statement to the public but for the fact that I want a square deal. McKenney, after running his home in a disgraceful manner, has sought to place all of the blame on me, and I have sought to protect his own skirts in the hope of gaining further political favors, by shifting all of the blame on the woman who has been a victim of his conduct.

"As for me, I am through with Hoquiam. I had a good business and was doing well, but I have been driven out of all at a great sacrifice and will locate elsewhere."
