

JORDAN STANDS BY THE FACULTY

Calls Stanford Students' Demonstration Organized Revolt.

RADICALS LOSING GROUND

President Says Faculty Aims to Stop Drunkenness—Trustee Advises Students to Seek Change in University Rules.

STANFORD UNIVERSITY, CAL., March 27.—The most important development of the day in the student situation was the issuance of a statement by President Jordan, in which he declares the parade was an organized revolt against the authority of the university. He upholds the action of the committee, which he says no president can change. Dr. Jordan's statement is as follows:

The present difficulty at Stanford University has had its origin in the effort of the university authorities, trustees and faculty, to rid the institution of the "burden and disgrace of student drunkenness." The student affairs committee in the regularly constituted disciplinary committee having charge of these matters and its actions are in accordance with definite instructions from the academic council.

Calls Parade a Revolt.

The demonstration of March 26 was an organized expression of revolt, primarily against the committee, but actually against the university itself. It was necessary that the offense should be met squarely and definitely. This the committee has done, and the university will continue to carry out its policy without reference to opposition or protest.

It is a matter of regret that so many of the young men have been drawn into this matter by a false idea of college spirit and undercurrents in the affair not appearing on the surface and the moral issue being obscured by sympathy for their fellows.

The president's statement has not yet been made public, but when it becomes known it will have the effect of stopping any appeal for a reconsideration of the cases of the students dismissed. Dr. Jordan looks at the affair from an entirely different viewpoint from the students, so there is no possibility of conciliation.

A committee of San Francisco alumni consisting of P. B. Downing, Dr. A. R. Spaulding, C. M. Fleckert and L. S. Heady, all of '98, visited Dr. Jordan today and later interviewed Chairman Clark of the student committee. Dr. Jordan, who left tonight for Helena, Mont., where he will remain until April 7, said that the alumni merely sought the facts in the case.

Has Not 250 Signers Yet.

In regard to an organized movement on the part of the students to leave the university, there were no further steps taken, as this move was not to be carried out unless 250 students agreed upon it. The requisite number have not yet signed the agreement.

The following telegram was received by President A. A. Murphy today from G. E. Crothers of San Francisco, one of the university trustees:

Should Get Rules Revised.

I confirm the statement that I advised students at Stanford that there was no appeal in individual or special cases to the trustees. This was merely a statement of fact made in view of the fact that at the time that the boys would direct all efforts toward a reconciliation with the student affairs committee.

The faculty is getting under a written constitution and articles of incorporation of the faculty. If it is effective, the trustees and faculty will doubtless be as anxious to remedy it as you, but in the past the trustees have refused to violate it in individual cases, however important. As an alumnus I urge you as one who sincerely believes you are right, to remain and direct your efforts toward the accomplishment of any purpose you may have at heart in an orderly way and not to sacrifice yourselves to no advantage to any one. The trust constituting the character of the university provides that rules of discipline shall be just and equitable. If they are not, and I do not know anything in which they are not, so the trustees are expressly required to see they are made so. I refer you to the articles of organization for the proper procedure in such matters.

May Abandon Walkout.

This telegram, together with Dr. Jordan's statement, shows that appeal or protest is equally useless in getting the 41 men reinstated. In view of this the abandonment of the plan of the walkout seems wise. What the students will do to carry out Mr. Crothers' suggestion is unknown. Already more than 200 students have pledged themselves to leave the university, but since the meeting yesterday there has been a distinct change of sentiment and the radical element is in a minority. Many believe a promise to support the signers of the parade petition involves a moral obligation to go out with them, but it is no longer believed that this will influence the faculty.

Fenton Stands Firm.

Kenneth Fenton and his followers still declare they feel they must leave whether the 250 others agree to go or

not, but there is an ever increasing number believing that a promise to support parades does not extend to walking out, if such action will accomplish no good to those dismissed or to Stanford. This faction is winning adherents by the argument that more can be done to better conditions by remaining in the college and keeping up the attempt to secure another student affairs committee.

The feature of overwhelming significance is the deep-rooted feeling expressed that the point has been reached where all hope of fair treatment at the hands of the university authorities is at an end.

Portland Alumni Intercede.

The Stanford Club, of Portland, composed of former graduates of that institution, held two meetings recently and finally adopted a set of resolutions on the present strife existing between the student body and the faculty. The resolutions adopted and sent to the university were as follows:—Chairman of Student Affairs Committee, Stanford University, California—Portland alumni have with deep regret read with condemnation of organized insubordination. Stanford Club of Portland requests a reconsideration of punishments imposed and asks that leniency be extended leading to reinstatement.

CHESTER G. MURPHY, President, Stanford Club, University, California.—The members of the Alumni of Portland is that the students should subordinate themselves to the university regulations. That organized rebellion against such rules with disapproval of the alumni. We have urged the faculty committee similarly and requested that the punishments imposed be reviewed and leniency be extended leading to reinstatement.

FIGHTS SMELTING TRUST

PANHANDLE SMELTER TO BE OPENED AT PEND D'OREILLE.

Montana Mineowners' Association Takes Over Property and Will Soon Be Smelting Ore.

HELENA, Mont., March 27.—Officials of the Montana Mineowners' Association announced today that they have completed arrangements to take over the Panhandle smelter at Pend d'Oreille, Idaho, near Sand Point. The association expects to be smelting ore within 30 days.

In their determination to secure lower rates for smelting and refining than those offered by the American Smelting & Refining Company, the independent operators decided that better and quicker results could be secured by today's deal than by waiting to construct a new smelter. The Pend d'Oreille smelter was erected five years ago, but was soon forced to close because of lack of tonnage. For shipping facilities it has the Great Northern, the Northern Pacific and the Spokane & International, the latter of which connects with the Canadian Pacific. Officials of these roads promise low rates, providing shipments can be secured.

WIFE ALSO A SUICIDE

Reported Dwight's Helmet Could Not Stand His Extravagance.

LOS ANGELES, March 27.—According to statements made today by friends of Henry Hyde Dwight, the Pasadena architect who ended his life with poison last evening just as he was placed under arrest for passing worthless checks, Dwight's wife, who died on March 17, was also a suicide, although it was explained at the time of her death that she had succumbed to an attack of nephritis, aggravated by wandering through the canyons near Pasadena. Those who appear best informed declare today that Mrs. Dwight had taken bicarbonate of mercury after learning that her husband was deeply involved in financial transactions wherein he had raised money by uttering worthless checks and borrowing money from friends and clients. Dwight, who was a Harvard graduate and a member of the Boston Society of Architects, is said to have dissipated his wife's fortune of \$100,000 and all the money he had earned since their marriage.

KILLED BY AUTO CRASH

John McLeod, Wealthy San Francisco Contractor, Is Dead.

SAN FRANCISCO, March 27.—As the result of a collision between automobiles on the great highway along the ocean beach, shortly after 1:30 o'clock this morning, John McLeod, a wealthy contractor and one of the best known men in the building industry in this city, lies dead in the morgue and Charles Bowman, who was at the wheel of the machine with which the dead contractor's automobile came in collision, is accused of manslaughter. Bowman declares that the accident was caused by McLeod, whose machine crashed into the rear of the one he was driving before he was aware of impending danger. Although badly shaken up, none of the occupants of the cars was badly hurt, except McLeod, who died this morning without regaining consciousness.

PAYS FOR HIS TALE

Chinaman Killed for Turning State's Evidence.

SHOT DOWN IN THE STREET

Eng Mow, Lieutenant of Notorious Mack Duck, Murdered as Result of Recent Convictions Obtained in Philadelphia and Boston.

NEW YORK, March 27.—A street murder, which is believed to have been an outgrowth of recent trials of Chinamen for the murders in Boston and Philadelphia, threw the local Chinese here into intense excitement this afternoon. The victim was Eng Mow, who, in the troublous times of two years ago, was known as a lieutenant of Mack Duck, leader of the Hep Sing tong, and who since the retirement of Mack Duck has been looked upon by many Chinamen as the real leader of his faction.

Ever since the successful prosecution of the Chinese murder trials in Boston and Philadelphia there have been rumors around Chinatown that some member of the New York colony had inspired the evidence which resulted in the convictions. When the shooting occurred today because of a worthless check, Mow was one of the men who had been under suspicion in this connection.

Mow was walking down Mott street when three Chinamen coming in the other direction blocked his way. There was a sharp, short argument, the flash and report of a shot, and as Mow collapsed and fell dead to the sidewalk the three assailants fled.

A line of police was immediately stretched around the entire district and a house-to-house search for the murderers was made. As a result of this search, Moy Don Yuk and Wan Yon, both of whom live in Mott street, were taken into custody.

INSANITY THE DEFENSE

STAY IN PROCEEDINGS AGAINST STEVENS' SLAYER.

Accomplice Will Recover—Sister Wires to Hold Body—Japanese Consul Showing His Esteem.

SAN FRANCISCO, March 27.—I. W. Chang, the Korean who shot and killed D. W. Stevens, the American adviser to the Korean Council of State, was arraigned before Police Judge Conlan today on a charge of murder. He was represented by Nat Coghlan, who asked for and was granted a continuance for preliminary hearing until next Friday morning at 10 o'clock. His attorney intimates that no defense will be offered in the Police Court, but that when the case reaches a higher tribunal the battle will be fought and an effort made to save the accused Korean on the ground of insanity.

Ming Woon Chun, the accomplice of the accused man, is still in a critical condition at the Lane hospital, but it is believed he will recover.

JAPAN MOURNS STEVENS.

TOKIO, March 27.—The Foreign Office in arranging a programme for funeral services for Durham W. Stevens in this city, simultaneous with the obsequies in America, there was undoubtedly a larger attendance at these services than at any former funeral in Japan. The entire imperial, diplomatic and foreign contingents, it is expected, will be present upon the occasion, together with thousands of Japanese. All the Koreans in Japan, including the Crown Prince, will attend. Bishop Harris will probably return from Seoul to deliver the eulogy.

CARRY ON ILLEGAL BANKS

Statement of Immigration to New York State Given Out.

ALBANY, N. Y., March 27.—According to the State Department of Agriculture immigrants to the number of 1,978,481 took up their residence in New York state, for the time being at least, during the past three years. A large portion of them came from Southern Europe, where illiteracy is prevalent. It is claimed that during 1907 they sent to their native homes savings estimated at \$399,000,000, which had they been informed of conditions in this country, would have remained and been invested here.

Through this traffic, the statement says, about 300 illegal banks are being operated in Greater New York, a large proportion of them in direct violation of the state banking laws.

It is claimed in the statement that 35,000 former immigrants were induced to emigrate from this country during the last few months, carrying with them sums variously estimated at from \$100,000 to \$200,000. It is contended that many of them are now returning to this country penniless to become public charges.
