

GOVERNOR'S NAME OUT OF BALLET Friends Will Give Chamberlain Nomination for Senator by Writing Name In. FAILS TO FILE PETITION

In Announcing Candidacy for Senator, Governor Said He Would Leave Matter of Nominating Him to Voters of Party.

The name of Governor Chamberlain will not be printed on the Democratic primary nominating ballot as a candidate for United States Senator. In order for the Governor to have his name printed on the official primary ballot, the law requires that a nominating petition must be prepared and circulated and filed with the necessary number of signatures in the office of the Secretary of State within the time specified for filing nominating petitions for state offices.

Failure to comply with these provisions of the primary law does not disqualify Governor Chamberlain as a candidate for the Democratic nomination for United States Senator. The members of his party will tender him the nomination by writing his name on the official ballot.

In announcing his candidacy for Senator, Governor Chamberlain said he would leave the matter of nominating him for that office to the voters of his party throughout the state. If nominated, however, he assured the members of his party that he would actively canvass the state and appeal to the voters of the state for their endorsement of his candidacy at the general election in June.

As to the matter of nominating him in the First and Second Districts, the Democrats have no aspirants for nomination in any state office. However, in the arrangement for the primary ballot, space is reserved so that the voter may indicate in writing the name of the candidate he desires nominated for each office. County Clerk Fields yesterday said the courts have held that merely writing the name of the candidate on the ballot in such cases does not constitute a legal vote. The elector must also mark a cross before the written name, and without the cross the vote cannot be counted.

It was under similar conditions that Mayor Lane was nominated for the second term at the municipal primary nominating election last Spring. When he failed to solicit the nomination from the party, the Democratic organization ignored Mayor Lane and nominated G. H. Thomas for Mayor. In the primary election which followed, more Democrats registered as Republicans in the process of assisting in the nomination of a Republican than in the nomination of a Democrat. In the absence of any other Democratic candidate for the office of Mayor, the voters will be sufficient to give Governor Chamberlain the Senatorial nomination. Two Tickets at St. John. MUNICIPAL ELECTION TO BE HELD NEXT MONDAY. Ballot Completed by Recorder and Will Be Printed Today—Registration Expected to Reach 800.

Recorder A. M. Eason has prepared the official ballot for the municipal election in St. John, which will be held next Monday, and it will be printed today. There are two tickets, known as the "Taxpayers" and "Good Government" tickets. The following: Taxpayers—Mayor, J. F. Hendricks; Recorder, A. M. Eason; City Attorney, George J. Perkins; Treasurer, C. S. Thompson; Councilmen-at-large, A. W. Davis, S. L. Fisher, and C. L. Thompson; First Ward, George L. Egan and A. W. Jones; Second Ward, H. W. Busham, H. C. Hunter.

Good Government—Mayor, H. W. Brien; Recorder, A. M. Eason; City Attorney, H. E. Culler; Treasurer, W. L. Churchill; Councilmen-at-large, J. Miller, A. W. Davis and E. C. Hurlburt; First Ward, E. J. Tyson and W. W. Winder; Second Ward, John W. Crook and I. H. Smith; T. T. Parker is an independent candidate for City Attorney. G. L. Perrine is the Socialist candidate for Councilman-at-large.

It is a straight issue between the Taxpayers and Good Government tickets. The only difference between the platforms of the two tickets is that the platform of the Good Government ticket calls for Sunday closing of pool rooms, skating rinks and all places of amusement. Both platforms declare for reduction of taxes and against granting franchises free to corporations. H. W. Brien, candidate for Mayor on the Good Government ticket, is an old and well-known resident. He served one term as Councilman. Mr. Hendricks, candidate for Mayor on the Taxpayers

ticket, is a business man and property owner who has identified himself with the growth of St. John. He is a member of the Commercial Club. The registration of votes yesterday afternoon had reached 778, and Recorder Eason thought it might reach 800 by tonight. He estimates that 200 votes will be polled. There were 625 votes cast at the municipal election. Besides electing officers, the voters will vote on the proposal to issue \$75,000 in bonds for erection of a public dock and purchase of a public park. The question of enlarging the territory of the city will also be voted on.

DEFENDANTS NEAR DEATH Goodwin and Stearns May Never Face Land-Fraud Jury.

LOS ANGELES, April 3.—Miss Shell, stenographer for the Pacific Furtinger Lumber Company, was on the stand in the Oregon land fraud hearing today and identified numerous letters and telegrams that have been exchanged between agents of the company, Los Angeles and Oregon. One of these was a letter from R. D. Jones, at Port Orford, Or., to Dr. A. H. Hedderly in Los Angeles, under date of July 14, 1907.

Jones called for \$125, "to make final payments" on 600 acres of land. He urged Hedderly to send the money at once, as the hands were valuable and should not be allowed to lapse. Hedderly in reply informed Jones that there were no funds on hand and that time would have to be granted if the money was to be forwarded.

Another letter of July 17, 1907, from W. H. Smith, of Los Angeles, to R. D. Jones informed him that \$100 of the amount asked for had been transmitted to the bank at Myrtle Point, Or., to apply on the payments.

On cross-examination Miss Shell said that she had seen W. D. Goodwin, one of the defendants, and former attorney for the company, only occasionally at the office. She did not know that he ever had any direct business transactions with the company.

It is feared that two of the defendants may not live to be tried. Dr. W. D. GERMAN SOCIETIES MEET Large Attendance in Mass Meeting at Arion Hall.

A mass meeting of the German-speaking citizens of Portland was held last night at Arion Hall, under the auspices of the consolidated German-Speaking Societies of Portland. More than 200 members of the societies and their families were present and enjoyed the speech and the musical programme.

The principal speaker was Rabbi Jacob Bloch, who delivered a masterly speech in German which was enthusiastically applauded. He condemned in the most emphatic manner the practices of secret societies, whose efforts are devoted toward curtailing the personal and religious liberty of those not in harmony with their expressed beliefs.

The meeting was followed by Sig Sichel, who asked permission to speak in English. Mr. Sichel spoke of his former efforts to stand up against oppressive laws and to follow the policy in the event that he is again elected to the Legislature. Ernest Faculty, editor of the Nachrichten, concluded the speeches with a resume of what the organization has accomplished. The principal musical number was the appearance of the Franz Reiner troupe of Tyrolean singers, who are now appearing at a local theater. They were encored repeatedly.

DEAF TO MOTHER'S TEARS Girl Would Rather Live Bad Life Than Go Home.

TACOMA, Wash., April 3.—(Special.)—Kneeling on the floor at her daughter's feet, her carerom face convulsed with emotion and her eyes streaming with downy, wrinkled cheeks, Mrs. Schulz, whose husband is a well-known real estate man, owned the property in both Tacoma and Seattle yesterday, begged her 13-year-old daughter, Clara, to give up the life she had chosen and to return home, promising her the most beautiful home and all the love a parent could bestow upon an only child. The girl said she was 18 years old yesterday, but the mother said her child's birthday was in Seattle. Justice Arnston exerted all his influence to persuade the girl to change her course, and failing, bound her over to the Superior Court. The girl is deaf, but M. J. Dorsey, who is sent to the State Training School.

SAYLOR TO STAND TRIAL Pleads Not Guilty of Fraudulent Use of the Mails.

J. N. Saylor, one of the men indicted by the Federal grand jury for using the mails to defraud, entered a plea of not guilty yesterday morning. Saylor, together with R. N. Wells, who has pleaded guilty to the same charge, Frank Caviness, J. A. Sheehan and M. J. Dorsey, was indicted for using the mails for the purpose of obtaining Confederate money. They are charged with buying the Confederate money from the Hon. Charles F. Smith, a passing it as legal tender. The Government could not arrest them for counterfeiting, because the bills were not counterfeit, so they were held for illegal use of the mails. Dorsey and Sheehan have until Monday to enter their plea.

LEADS ITS SUPPORT Municipal Association Backs Up Certain Candidates.

OTHERS WILL BE NAMED Approval Given Original Statement No. 1 Senators, James Cole, B. D. Sigler, C. B. Atchison, J. W. Bailey and Others.

Candidates for several state, legislative and county nominations, to be voted at the April primary election, were endorsed by the Municipal Association at a meeting last night. The original Statement No. 1 Senatorial ticket, headed by Ben Selling was approved, but the association did not decide on the 12 candidates for State Representative that will be supported. At another meeting to be held early next week, the association will conclude its consideration of the Representative ticket and will recommend the support of a dozen county to state nominees taken last night towards endorsing candidates for United States Senator or for Congressman from the Second Congressional District. It was also decided by the association not to endorse for nomination candidates who had no opponent.

James Cole, ex-Assistant United States Attorney, was endorsed as the proper man for District Attorney of the Fourth Judicial District, while Assessor B. D. Sigler and Clyde R. Atchison, who seeks re-nomination as assessor, were endorsed as the proper men for assessor. Commissioner, also came up to the requirements of this organization and will receive its support at the primary election. Another officer to be endorsed by the association was J. W. Bailey, Dairy and Food Commissioner, who would retain the office for another term.

"We were unable to complete an impartial review of the many candidates and their qualifications for the different offices they are seeking," said John Bain, secretary of the association, when the meeting had adjourned last night, "and we shall not complete our endorsements until we can hold another meeting early next week. At that time we shall take up the consideration of the Representative ticket, and from the list of 35 Republican candidates select the 12 that will be recommended for the support of our organization."

Judge Bronough said there was no evidence to show that Peabody had ever made complaint to Mr. or Mrs. Meader regarding the treatment which he received. "Judge, I never quarrel with a woman."

ARRESTED AT TILLAMOOK W. F. RIBHORN WANTED ON A CHARGE OF NON-SUPPORT. Authorities Trying to Find Sufficient Ground to Bring Charge of Bigamy.

W. F. Ribhorn, well known in Portland real estate circles, was arrested at Tillamook yesterday at 1 P. M. by Sheriff Henry Crenshaw, who is being held by the Tillamook County Sheriff until District Attorney Manning sends a deputy to bring him to Portland, which he will do today, in a charge of non-support, but the authorities are seeking ground for a bigamy charge against him.

At 12:30 yesterday afternoon Sheriff Crenshaw telephoned to Deputy Sheriff Hollingsworth, in Portland, saying he had read a description of Ribhorn in the Portland papers and saying if he was still wanted, he would send the man, he did so. Ribhorn confessed that he was the man for whom search was being made, and he had been shown his published photograph.

The non-support complaint was sworn to by Mrs. Pearl B. Williams. She was not sure, however, whether she ought to sign her name Williams, or Ribhorn, or Sanderson. Before she married Ribhorn she taught school at Pueblo, Colo. While visiting friends at Denver she met Ribhorn and commenced correspondence with him, which resulted in their marriage. The nuptials were celebrated at Columbia River, near Queen, a Methodist minister performing the ceremony. Quietly enough, however, Ribhorn's name does not appear on the marriage certificate.

During the course of the correspondence between the couple, Ribhorn informed his sweetheart that he had discovered that she was adopted when he was very young, and that his real name was Williams. This seemed to satisfy the unsophisticated girl, and she accepted it as a fact. Mrs. Ribhorn told her she was not a man of wealth, she was not surprised at the plainness of the wedding. She was surprised, however, when she came to Portland and he took her to a quiet quarters on First street, giving her no money. Her surprise increased when he failed to introduce her to any of his friends and left her for two days to attend to real estate business. When he returned to stay a short time, and again to leave her.

At this juncture a friend interfered and took Mrs. Williams to see the District Attorney. She told her story and admitted that she did not know much of the ways of the world, and of men in particular. Ribhorn was called in and promised to pay his wife \$50 a month for her support.

The next day Mrs. Williams received a letter from Ribhorn saying he cared nothing for her. Then he suddenly dropped from view, and although the District Attorney and Sheriff Stevens had gone over the city with a line-toothed comb, they have been unable to learn his whereabouts.

Mrs. Williams had learned that Ribhorn had divorced her from G. H. Riley, of Virginia, April 2, 1907. But it was a surprise to her to learn that Ribhorn had a second wife, Mrs. Cora Ribhorn, of Portland, O. Ribhorn sought, through Attorney L. B. Reeder, to secure a divorce from Mrs. Cora Ribhorn in the Oregon City court, and although the decree was granted, it was found to contain technical errors, and was dismissed. Mrs. Williams has been residing at 431 West Park street.

FISHERIES OF WASHINGTON COMMISSIONER RISELAND FILES ANNUAL REPORT. Value of Output of Puget Sound District, \$3,386,001, and of State, \$6,816,700.

The annual report of John L. Rise-land, State Fish Commissioner of Washington, which has been filed with Governor Mead, is made up largely of statistics showing the receipts and disbursements of the office and the number of fish hatched and distributed.

The tabulated report of the industry in the Columbia River district shows canneries, factories and appliances in operation of a total value of \$1,188,000. The men employed in the district number 2059, and their total earnings for the season are placed at \$445,100. The pack of the Columbia River canneries in the year ending March 31, 1908, follows:

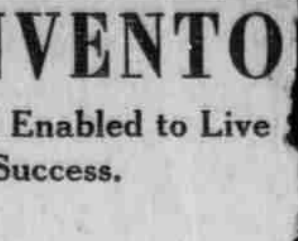

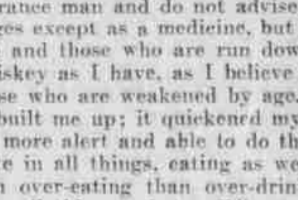
