It was contended it fortunate for the people of the state that the crimes of Melidrum were exposed by his conviction before his death. My experience teaches me that he is a crooked man."

A man elected to public office is a servant of the people and a violation of duty makes him a traitor just as much as the man who sells the secret of the army. Alleged dishonorable methods in securing his election to the Senate are charged against United States Senator Fulton in an affidavit executed yesterday by H. A. ## Political Indorsement by Lumbermen Is Protested.

### BY OWNERS OF BIG MILL

#### Eastern & Western Co. Calls on Manufacturers' Association to Nullify Step in Behalf of Attention for Commissioner.

Discreet threatens the Oregon & Washington Lumber Manufacturers' Association as the result of that organization having indorsed the Commission for re-election to the office of Railroad Commissioner. Some members of the association deplore the tendency to take any part in the politics of the state and contend that this is not one of the purposes of the lumbermen in organizing and that under no circumstances should candidates for office be indorsed.

The objection that has been made to Mr. Atchison's indorsement is not dictated by opposition to him as Railroad Commissioner or to his re-election, but because it is contended the lumbermen should not play any part in politics as organized by the state.

Members of the Oregon & Washington Lumbermen's Association who protested against any political indorsements are the Eastern & Western Lumber Company of Portland, and the Smith Lumber Company of Hood River. The following letter was written by President Ayer, of the Eastern & Western Lumber Company, upon the printing of the resolution adopted by the association indorsing Mr. Atchison a few weeks ago and was directed to A. R. Wastell, secretary of the association:

Dear Sir: We notice in The Sunday Oregonian, and again The Oregonian of this morning, that your association is proposing on Saturday had indorsed certain candidates for Railroad Commissioner.

We wish to enter a strong protest against the association's entering politics in any manner at all. The organization is not for that purpose, and we must express our condemnation of proceedings that put the association back of any political candidate. With the many interests that are associated with the lumber industry and advancement of the state, a great responsibility is placed upon the lumbermen. Within our association, individuals should be at liberty to exercise their own will in regard to politics and candidates for office.

We object most strongly to contributing money to our association to further the interests of any political candidate; and that is exactly what we are doing when we contribute to the maintenance of the Lumber Manufacturers' Association and then have used indorsement for any candidate. Kindly advise what, if any, action will be taken to nullify the association's indorsement of political candidates. Yours very truly,

# DISHWASHER'S PROMOTION CAUSES SMALL RIOT ON FIRST STREET

## Angry Laborers Threaten Eclipse of Sunshine Restaurant When Nonunion Man Is Appointed Helper to Chief Cook.

PROMOTION of the dishwasher of the Sunshine Restaurant, at First and Madison streets, to the exalted position of assistant to the chief cook, caused a labor riot at noon yesterday. Serious trouble seemed in prospect for a time but the prompt dispatch of a squad of five policemen to the scene prevented anything more serious than a couple of fist fights and the tearing to shreds of Kelly's banner. But one great victory was made. Fully 300 union men and sympathizers gathered in front of the restaurant and remained until dispersed by the squad of police. The union men, however, were not the only ones who were not satisfied. The largest portion of the crowd was made up of longshoremen, although many other unions were unofficially represented, their members being attracted by a union banner which declared a boycott on the restaurant was in effect.

The trouble originally was between the Waters' Union and the Sunshine Restaurant. The union had objected to the hiring of a nonunion man in the kitchen in the important position of dishwasher. During the forenoon the union sent J. W. Sheerer, proprietor of the place, full warning that his card would be removed unless he discharged the "scab" forthwith.

"You will never take my card away," said the message Sheerer sent the union. When they unwrapped a neatly tied package that accompanied the message they saw he was speaking the truth. His card was enclosed.

# PLANS BIG SEWER SYSTEM

## Mount Tabor Club Launches Project for Large District.

The Mount Tabor Improvement Association initiated a movement for the laying out last night for the construction of an extensive sewer system to serve the territory north of Belmont street, including Mount Tabor, Rose City Park and Montavilla.
