

PORTLAND DOGS HAVE THEIR DAY

High-Bred Canines Are Placed on Parade at Kennel Show

EXHIBIT LARGER THAN EVER

Big Attendance Shows Interest of Animal Lovers in Annual Event. List of Awards Made Yesterday.

The ninth annual bench show of the Portland Kennel Club opened at the Crow-Graham garage, Fifteenth and Washington streets, yesterday afternoon, with a most flattering attendance and a larger exhibit of well-bred dogs than ever before in the history of the club.

Some inconvenience was caused at the start by the delay of several exhibitors in having their entries on hand, but this was more than offset by the expeditious manner in which Judge George S. Thomas handled the judging of each class.

The keenest competition was between the entries in the setter and pointer divisions. Many handsome dogs were classified in these classes and while many of the owners were disappointed in failing to secure ribbons or favorable mention, they were satisfied that the awarding of the prizes was in accordance with the merits of the dogs.

Herman M. Papst's handsome pointer, Mason's King, proved the classiest canine in that division and was awarded the first in such class colored and is therefore the champion pointer dog of the Portland show.

J. E. Chilton's Irish water spaniel, Bessie, carried all the prizes in that division. M. V. Dickinson's Gordon setter, Freda T., was declared the best dog in that class and captured enough first prizes to fill a basket.

Wesley Ladd's cocker spaniel, Red Queen, was a winner in several classes, and may be a prominent contender for honors in the contest for the best dog or bitch in the show.

The doors of the show will be opened this morning at 10 o'clock, when the judging will be resumed. The big events scheduled for today will be the competition in such classes as terriers and the fox terriers. Yesterday's complete list of awards is as follows:

ALASKA CANNERS WARNED BY BUREAU OF FISHERIES.

Preserving of Salmon Bellies Ordered Stopped on Ground That Practice Involves Waste.

Alaskan canners have been notified that after January 1, 1909, the practice of preserving salmon bellies must be stopped. The Bureau of Fisheries at Washington has taken the matter up and has issued an order on the subject.

Horses Bring an Average of \$230 Each

MUCH INTEREST IN SALE

Fifty-seven Animals Are Sold, the Highest-Priced Horse Being Mary Mims, Who Is Bought for \$1400.

Fifty-seven horses, selling at an average of \$230 each, was the record established at the second day's sale of the Portland Horse Sale Company, held at the Exposition grounds. Men who have attended horse sales all over the country were surprised at the way the sale went on the opening day, but it was nothing compared with that of yesterday.

The feature of the sale, of course, was Mary Mims, 2:20. This mare, like a number of other speed marvels that will be sold today, has attracted widespread attention because she is every inch a horse. She was knocked down to W. E. Clemans of Moscow, Idaho, for \$1400, but not before a number of prominent Portland business men, who wanted the handsome mare as a roadster, had bid as high as \$1250 for her.

The next horse to bring a fancy price was General Jones, a black McKinney stallion, who was knocked down to McDaniel & Ferguson, of Newberg, for \$1200. This horse, like a number of other well-known men kept the bidding on the mare very lively. Mr. Clemans, of the firm of Clemans & Lody, finally bid \$1000 and got the mare.

Splendid Animals Yet to Be Sold. Some of the best stuff yet remains to be sold, and the sales today in many ways will be the cream of the three-day sale. Among the lot there will be a number of clever light harness performers, and the chances are that still another record is to be cracked in the sale of Henry Gary, 2:18. A number of light harness men have been waiting for a chance to bid on this horse, because he has the making of a fine racing tool. He would also make a speedy roadster. STEEL INDICTMENT DELAYED

MANNING PROBES FURTHER INTO TITLE BANK.

Expect to Be Able to Prove Complicity of State Treasurer and Ross.

Aside from a conference between District Attorney Manning and J. W. Ferguson, one of the experts employed by the state to examine the books of the Title Guarantee & Trust Company, there were no developments yesterday in the threatened indictment against State Treasurer Steel for his alleged complicity in the conversion by the bank of the educational funds of the state. It is inferred from the fact of the indictment that a further investigation will be made into the affairs of the defendant institution. State Treasurer Steel is confined to his home, East Twentieth street, by a slight illness, from which he expects to recover sufficiently in a few days to resume his official duties at Salem.

The unexpected illness of Mr. Steel and the absence of Secretary of State Benson in California has caused Governor Chamberlain to defer his departure for Eastern Oregon on his Senatorial campaign until Sunday. He left for Salem yesterday to look after the duties of the State Board and on Saturday will assist in the official canvass of the primary election returns.

Leaving Portland Sunday, he expects to reach Malheur County in time to open his campaign in Eastern Oregon Monday afternoon and night, respectively.

District Attorney Manning maintains that his promised indictment of State Treasurer Steel is warranted under the instructions of Judge Burnett to the jury in the Ross trial aside from any other consideration or evidence of Steel's complicity in the illegal conversion of the state's funds. According to the interpretation of the statutes, as presented to the jury in the Ross case, Judge Burnett held substantially that if Steel loaned the educational funds to Ross, the State Treasurer is equally guilty with Ross for their conversion by the bank. This view is accepted by the District Attorney and he believes that the State Treasurer could not delegate authority to the bank which he himself did not possess.

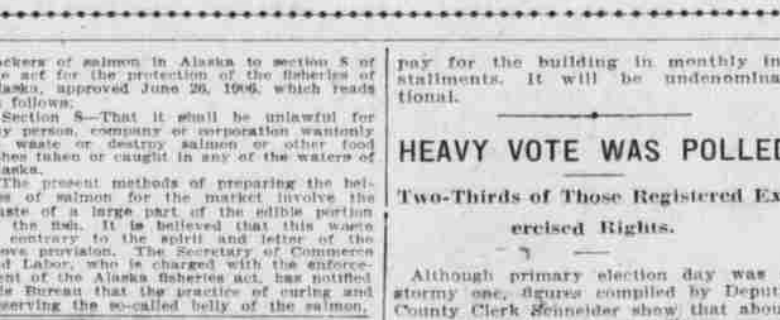
Council Committee to Probe Purchase of Cables.

MAYOR LANE, the members of the first committee of the executive board, and others will be called upon to give testimony tomorrow night, when the second session of the committee on judiciary of the Council will occur at the City Hall. The subject under investigation is the recent purchase of \$20,700 worth of cables and conductors for the Fire Department, which should have been supplied free of cost by the Home Telephone Company. The purpose of the probing is to fix responsibility for the needless expenditure.

City Attorney Kavanaugh yesterday ruled on a point of law, upon which information was sought by the investigating committee, by holding that the Pacific Telephone & Telegraph Company is not obliged to furnish any supplies for the city, under the terms of its franchise, until official notification is given by the Council. Thus, it could not be sued for the sum spent for the cables and conductors already purchased by the city.
