LOS ANGELES, Cal., May 26.—Rudolph Spreckels, of San Francisco, who is in Los Angeles today, was a guest of the executive committee of the Lincoln-Roosevelt League and made a brief address in which he referred to the continuation of the graft prosecution in the following language:
