

FIND DYNAMITE IN OPERA HOUSE

Effort to Kill and Mangle Hundreds Fails Because Fuse Burns Out.

FIRE CLOSE TO POWDER

Smoke Blackens Contents of Can. Glendale People Startled by Sensational Discovery by Manager of the Opera House.

GLENDAL, Or., June 3.—(Special.)—A most dastardly attempt at wholesale murder was revealed here today when T. G. Sonnenman, merchant and owner of the Operahouse, found an infernal machine at his new auditorium.

The infernal machine was placed in the vestibule of the operahouse on the night of March 7, while the home talent play, "The Blue and the Gray," was in progress.

When the play was over, Mr. Sonnenman, upon being asked by the crowd to file out, noticed a gummy sack containing a can about the size of a five-gallon oil can, and supposing that it was a can of oil that someone had forgotten, he placed it to one side.

The next morning the can was still there, and he put it away until somebody should claim it.
