Refusal of Supreme Court to Review Case Removes Last Hope of Land Conspirators.

Just as soon as the mandate of United States Supreme Court, denying to Willard N. Jones and Thaddeus S. Potter the writ of review, reaches Portland, the two local lawyers who were convicted in connection with Oregon land-frauds, will have to begin serving the sentences imposed upon them by Judge Hunt. Jones and Potter fought their case through the United States Court of Appeals and the decision went against them and now that the United States Supreme Court has, by refusing to review the case, affirmed the decisions of the courts below, there is nothing left but to serve out the sentence and pay the fine.

Effect of Cellars Law.

"There is no sane reason why a man's wife should be compelled to consume a full meal at an aristocratic restaurant in order that she may be served with a glass of beer, and yet this is what the Cellars ordinance requires. The woman may want only a light lunch with the beer and imported delicacies. The delicacies are not served at all the fashionable hotels and grills, the beneficiaries of the ordinance, and may only be obtained at lunch houses like the Cellars. Why should we force the people to pay for what they do not want to eat, yet that is what we should be compelling them to do under the Cellars ordinance.
