## AIRS REALTY DEAL

Wemme Answers Charge of Fraud With Accusations.

A. F. SWENSSON IS SCORED

Broker Is Declared in Affidavit to Have Misappropriated Funds From Sale of Lots for Overlook Land Company.

A. F. Swenson, a young real estate broker who brought proceedings days ago against the Overlook Land Company charging that a conspiracy to defraud him existed among the directors, was in turn accused of dishonest practices and of milking the concern, when the case was presented in the State Circuit Court, yesterday afternoon.

Although the officers of the corporation, E. Henry Wemmer, George W. Joseph and A. N. Moore, were represented in court in response to appear and show cause why a receiver should not be appointed, Swenson was the one in court to answer to the charges. He was accordingly set for Friday afternoon at 2 o'clock.

In a voluminous affidavit, Mr. Wemme, head of the Overlook Land Company, laid bare secrets of the corporation, explaining its organization, purposes and Swenson's connection with the concern. He directly accuses Swenson of having withheld and misappropriated corporation money and of having really caused the extensive improvement work which has been undertaken at Overlook, the addition that is being boosted by the company.

The affidavit set up that in 1898 Gustaf Swenson, since deceased, proposed the taking over of a tract now known as Overlook. He asked Wemme to put up \$10,000 saying he would complete the purchase price of \$20,000 from other sources. The remainder of the sum not being raised Wemme says he put up another \$10,000 in order to protect his original \$10,000 which had been advanced on the deal to bind the bargain. Then a corporation was formed with a capitalization of \$125,000 at which point Mr. Moore stepped in and got a block of the stock. Mr. Wemme was to receive \$125,000 for the land of which \$25,000 was to be cash payment, \$40,000 in shares of stock, and the rest in a note for \$60,000 payable in two years with interest at 6 per cent per annum. Sixteen shares were given of the Wemme stock to Gustaf Swenson as promotion stock, this passing into the hands of his son, A. F. Swenson, upon Gustaf Swenson's death.

It was the Swensons who insisted upon an extensive course of improvement work, the affidavit says, it being their contention that Overlook could not compete with the other land boosting companies unless a showing was made. After the death of the elder Swenson, Mr. Wemme says he began to suspect that the money received for the sale of lots in Overlook was not being turned in. He caused Swenson's books to be checked over and discovered a shortage of \$121,362. He ascertained, as soon as the Swenson contract for the sale of lots had expired he

proceeded, with the other directors to refuse a renewal of contract, deeming such a thing unsafe. After that, the affidavit goes on to say, Swenson made numerous threats of his intention of suing the company and causing embarrassment.

This affidavit is accompanied by supporting affidavits from Mr. Moore, George W. Joseph and Eva Joseph. An answer to Swenson's complaint asks the dismissal of the suit and gives assurance that far from being near the shoals of bankruptcy, the Overlook Land Company is on the highroad of prosperity.

### FAILS TO SHARE IN ESTATE

Court Decides Tacoma Woman Who Contested Will Was Mistaken.

Claims of Mrs. Christina Egan, of Tacoma, to the \$10,000 estate of George W. Peterson, from Mr. Moore, yesterday when County Judge Webster dismissed her action for an interest in the estate. The court said he was satisfied the woman had made a mistake.

It is not believed the woman has been acting the part of an adventuress in the matter, however. Her conduct would indicate that she really believed she had a claim to the estate, and the father of her son, Carl Oscar Peterson, whom she has been putting forth as the rightful heir of the estate. It seems she was deserted ten years ago by a man named Charles Peterson, then her husband. On the death of the Portland Peterson, several months ago, she read the death notice, made inquiry and later identified photographs of the dead man, saying he was the man who deserted her and that she could not be mistaken. Her claim was contested by O. W. Nelson, executor of the estate, who insisted that Peterson's only relatives live in Sweden.

### DALY WILL CARRY UP CASE

Condemned Murderer Hopes to Secure Stay of Execution.

Harry Daly, whose death on the gallows is set for the morning of January 29, will appeal to the Supreme Court and thus gain a new lease of life. Notices of this appeal was filed with the Circuit Court yesterday by Daly's lawyers, L. W. Humphreys and John H. Stevenson, who have been untiring in trying to save their client from the gallows, believing him insane.

Daly shot and killed Harry Kenney, a saloonkeeper, who had been boasting him. At the time of the shooting Kenney had his hands in air daring Daly to fire. Daly is now in the death cell of the Penitentiary at Salem and had begun preparations to die on schedule time.

### Mrs. Church Charges Cruelty.

Mrs. Jessie Osborne Church has filed suit for divorce in the Circuit Court against Delbert Church. She says he has been cruel to her, forced her to work in a restaurant at Bandon, Or., and had a habit of getting up at midnight and sitting out on the beach until morning. She asks to be restored to her name by a former marriage, Osborne, and to be awarded the four children of the former marriage. The Churches were married at Bandon in March last.

## NEW RATING LATE

Class A A Will Not Help McCredie This Year.

DISCUSS LEAGUE'S FUTURE

Task of Signing Up Players for Portland's Two Teams Is Requiring Much Attention.

Gossip of Diamond.

"So we're in class AA now," mused Walter McCredie, yesterday, when informed that the National Commission had advanced the classification of the three principal minor leagues in the country. "Well, I only wish it had occurred sooner, for there are several players in the Southern and Western Leagues that I would like very much to have in my Coast League club this season. However, I'll get 'em shot at 'em next year and we shall try to get along as best we can this year."

With the above remarks, McCredie turned to his desk and resumed writing letters to the many ball tossers he will have to line up in the near future, while Pearl Casey, Ote Johnson and President Lucas became involved in a discussion of the merits of certain players and rules. Casey tried hard to nail the chief executive of the Northwestern League for an opinion of Mike Lynch's Seattle team, but the wily Lucas refused to commit himself. However, he quietly informed Casey that he will do well to mend all the holes in his fences and to protect himself, at every point likely to prove vulnerable.

After the discussion had lasted several minutes, McCredie turned around and queried: "By the way, Lucas, four clubs won't do in a double A class league, don't you think we ought to have eight clubs?" "I most certainly do, and I believe the Pacific Coast States are capable of supporting such a league which could be made to equal the major leagues in the class of baseball furnished."

Continuing on the subject, Lucas said: "This subject is one that will have to be thoroughly digested and figured out to a fine point, for there are many things standing in the way of such a move at present. Eventually possibly in 1910, but I look for it later, there will be an all-Pacific Coast League which will come from a trimmivrate with the major leagues. It is bound to come for the coast cities are growing faster than the cities of the East, and as they grow they will demand higher class baseball. By this I do not mean such a great difference in style of play, for a class D city enjoys its baseball just as much as does a major league town, and it often happens that there are good teams in the lower classes. If the problem of railway transportation along the Pacific Coast is ever solved satisfactorily, such a league will thrive."

However, continued Mr. Lucas, "the Northwestern League will show Portland some classy baseball during the coming season, and I am pleased to see McCredie and Casey gathering such a good team for the new league."

Ote Johnson yesterday recommended a pitcher to McCredie, and the manager immediately announced that he would endeavor to secure his services. The new man is Earl Zook, of Muncie, Ind., who was formerly with Vicksburg, in the Cotton States League. While playing in that league, Zook contracted malarial fever and on that account asked for his release and got it. He is said to be free to sign now, and Johnson recommended him so strongly to McCredie that the young fellow will be signed for the Pacific Coast League club, providing his terms are reasonable.

According to a Spokane paper, the Spokane Traction Company has agreed to erect a reinforced concrete grandstand and new bleachers for the Spokane baseball park, and on the strength of this the Spokane fans are claiming superiority over the other Northwestern cities in the matter of accommodations. Portland might profit by this and get together for the benefit of the Portland fans.

Manager Rowland, the new helmsman of the Aberdeen club, is said to have been given permission to purchase and bring five new players to the Grays Harbor team next season. Rowland is said to be a clever manager and if he is as good as he is rated, Aberdeen may prove a dark horse in the coming race.

President Lucas expects to be installed in his new office, in the Back building, Seventh and Oak streets, today, after which he will be at home to his many friends and any of the fans who desire to call.

## WRESTLERS MEET TONIGHT

TERRIBLE SWEDIE HERE FOR BOUT WITH O'CONNELL.

St. Louis Man Toughest Looking Proposition Yet—Has Beaten Some of the Best.

Jack Peterson, of St. Louis, who wreathes O'Connell tonight, reached Portland yesterday morning. Peterson looks every inch the wrestler he is cracked up to be. He is more of a swarthy complexion than the blond Swede that was expected and his general appearance, including closely cropped hair, makes him about as tough a looking proposition as has struck the burg in six months. He worked out at the club last night and told some of those who saw him that he was going to throw O'Connell twice in 30 minutes.

Peterson has been going after the best ones in the Middle West and none of the top-notch heavyweights have been able to beat him in handicap matches. Monogoff, the Terrible Turk, only threw him once in 45 minutes, although he was matched for two falls in an hour. His last match before coming West was with Lundeen, the Swedish heavyweight champion. Lundeen was to throw him once in 15 minutes and failed. He secured his fall on Dwyer at Springfield a week ago last Wednesday in 16 minutes. It was a mixed match and Dwyer won the other two falls, Cornish style.

The preliminary between Parker and Abernathy will start at 8:30 o'clock and is a handicap in which Parker is to throw Abernathy twice in 30 minutes. He was very confident of winning the side bet until a lot of money was offered yesterday to back the supposed "ringer" and now he wishes it was for three times in an hour. He is from 15 to 20 pounds the heavier and will make up in weight what he may lack in speed. Joe Acton will referee the matches.

The steaming plant of the Exposition Rink was overhauled completely yesterday and will be kept booming from 10 o'clock today until the match is over to night. Up to yesterday the wrestling fans of the city were worried about one thing as much as the other and as both have made good and the weather man promises to do his share a record crowd is expected at the match tonight. Carpenters have been busy a couple of days elevating the benches that were flat on the floor at the last match.

### FINAL TERMS OF AGREEMENT

Privileges Granted Class A A Leagues by National Commission.

CINCINNATI, Jan. 6.—The final settlement of the minor league troubles that threatened a baseball war was ratified at the session of the National Baseball Commission today. The American Association, Eastern League and Pacific Coast League hereafter are to be in Class "AA," with the right to draft players from the Southern and Western leagues, now in Class "A," as well as from all the lower classes. All players drafted by the major league clubs from the smaller leagues cannot be sent back to such leagues without first passing through the "AA" leagues. The "AA" leagues are to be permitted to draft territory from the minors under certain conditions and the number of players carried by reserve by major league clubs shall be limited.

It was agreed that all internal affairs of the Class "AA" clubs shall be de-

ided by themselves without reference to the present National board and that disputes between "AA" clubs and other minor league clubs shall go to the board of arbitrators, with right of appeal to the commission in every case. This makes it impossible for any dispute to be absolutely decided by the minor league board before it involves any Class "AA" club.

The American Association decided to open its championship season April 14, for five and a half months, instead of four months, as heretofore.

### CASE OF TOO MANY HYLANDS

Arkansas Sports Find False Alarm in Their Midst.

LITTLE ROCK, Ark., Jan. 6.—The Hyland-Mowatt bout scheduled for January 14, has been cancelled by the Arkansas Athletic Club on account of a controversy as to the identity of a fighter who is in New Orleans and who has been corresponding with local promoters under the name of "Fighting Dick Hyland, who is on the Pacific Coast."

## KETCHELL SEEKS HONORS

WOULD FIGHT NEW NEGRO HOLDER OF CHAMPIONSHIP.

Johnson Reported Willing to Have Mill and to Be Ready to Sign Terms.

GRAND RAPIDS, Mich., Jan. 6.—(Special.)—Stanley Ketchell, middleweight champion of the world, and looked upon as a dangerous factor in the heavyweight class, is secure in his desire to meet Jack Johnson for the title the colored man recently attained by his victory over Tommy Burns. Stanley today renewed his statement that he was ready to fight Johnson, and he has already wired Jimmy Coffroth to make all necessary arrangements for the battle. Willis Britt, who is here with Ketchell and who is urging Stanley on, today received a cablegram from Johnson accepting a fight with Ketchell and informing Britt he will get in communication with Coffroth.

### Many Want Racing Restored.

NEW ORLEANS, Jan. 6.—A meeting attended by about 1200 citizens, including a large number of leading business men, was held in New Orleans last night for the purpose of inaugurating a movement to restore winter racing and to protest against the enactment of the so-called "blue laws" in Louisiana.

### Butte Will Not "Open."

BUTTE, Mont., Jan. 6.—The hope that Butte would be "open" for boxing and gambling, entertained by the liberal element, which elected Sheriff O'Rourke, was disappointed today when that officer, who took his seat last Monday, announced that he meant to enforce the statutes.

### Seattle-Portland Basketball Game.

The Portland Young Men's Christian Association basketball five has thoroughly recovered from the defeat at the hands of the Multnomah Amateur Athletic Club last Saturday night, and is looking forward eagerly to the coming game with the Seattle Association team, which is scheduled to play here Saturday night. The game will be

played on the floor of the Association gym and should prove one of the best of the season. The old-time rivalry between the members of the Seattle and Portland Associations will be in evidence and this alone assures the spectators of a hustling game.
