

APPEAL SCHEMES TO BE ASSAILED

Signs Apparent That Fight Will Be Renewed With Increased Bitterness.

SCHOOLS WANT \$321,660

One Bill Proposes Consolidation of All Normals into One and That It Shall Have Its Location at Portland.

STATE CAPITOL, Salem, Jan. 20.—(Special.)—The fight over normal schools will be renewed in the Oregon Legislature with old bitterness.

Drain Has Deficiency Bill. Drain came forth today in the House with a bill for \$7000 appropriation to meet deficiencies at that institution between January 1, 1907, and June 30, 1908.

\$321,660 for Normals.

The hungry appetite of the normal schools was indicated today, when two bills appeared in the House appropriating \$321,660 for their benefit.

Bill for Consolidation.

In the Senate, Senator Smith, of Marion, has introduced a bill for one normal school in Portland and for the disposal of all the present normal school buildings at other places in such manner as the Normal Board may deem best.

Jones Has Another Scheme.

Representative Jones, of Douglas, has presented a bill to move the Ashland Normal to Drain, continue the school at Weston and abolish that at Monmouth.

CHECK ON APPROPRIATIONS

For Soldiers' Burial Plot. House committee on military affairs today reported favorably on Mahone's bill for an appropriation of \$6000, with which to purchase a tract in Riverview Cemetery, Portland, as a burial ground for honorably discharged soldiers and marines who served in the Spanish-American War.

Soldiers' Home Board. A bill to take the soldiers' home away from the management of the Governor and give it to a Republican board has been presented by Representative Campbell, of Clackamas.

Bill to Tax Roads. To stop cutting up of county roads by heavy traffic Representative Dimick, of Clackamas, has introduced a bill to give County Courts authority to regulate all loads of cordwood, saw logs, lumber, ties, timbers, piling or heavy merchandise hauled in any vehicle.

To Investigate Portage. Davis of Multnomah has offered a resolution calling for the appointment of a joint committee to investigate and report on the Cascade Locks and portage railroad.

To Draft Auditing Bill. Speaker McArthur today appointed Clemens, Mahoney and Buchanan as the House members of the joint committee, provided by S. J. R. 2, reported by temporary committee on resolutions, to prepare and report a bill creating a permanent system of auditing the various state institutions and commissions.

These for Seattle Junkie. Greer, Eaton and Hawley were today announced by Speaker McArthur as the House members of the joint committee that will examine the bill introduced by the Oregon Commission to the Alaska-Yukon-Pacific Exposition at Seattle.

MANY NEW BILLS OFFERED

Flood of Measures Turned Loose on House Yesterday. SALEM, Or., Jan. 20.—(Special.)—Bills were introduced in the House today as follows:

- H. B. 94, Lane County delegation—Increases salary of Deputy District Attorney Grant, of Lane County, from \$2000 to \$2500, and authorizes a deputy for the District Attorney of that district for his own county at a salary of \$4000 per annum.
- H. B. 95, Bean (by request)—Providing for insurance department and creating insurance commissioner at a salary of \$4000 per annum.
- H. B. 96, Farrell—Requiring that doors to buildings used for public purposes open outward.
- H. B. 97, Farrell—Regulating use of halpines and limiting their length to ten inches.
- H. B. 98, Reynolds—Taxing all beehives of 2000 or more inherited by indirect beneficiaries and graduated increase on all legacies.
- H. B. 99, Husk (by request)—Appropriating \$100 to reimburse E. R. Bosby, of Wallawa, for expenses incurred in establishing title to land acquired from State of Oregon.
- H. B. 100, Callahan—Providing for service of summonses in suits against railroad and other corporations on their accredited agent in county in which suit is brought.
- H. B. 101, Richardson—Fixing salary of Deputy Recorder of Union County at \$900 per annum.
- H. B. 102, Richardson—Fixing salary of Sheriff of Union County at \$1200 and expenses with two deputies at \$1200 and \$900.
- H. B. 103, Richardson—Denying channel of Grand Ronde River and appropriating \$15,000.
- H. B. 104, Bonbrake—Appropriating \$100,000 for additional buildings at the State Agricultural College.
- H. B. 105, Brooks and Bean—Prohibiting any candidate for office from making any pre-election pledge, the fulfillment of which would be in violation of the Constitution.
- H. B. 106, Campbell—Codifying the game laws of the state.
- H. B. 107, Reddell—Fixing salary of Assessor of Coos at \$1800 per annum.
- H. B. 108, Reddell—Providing for Deputy County Assessor in Coos at \$1200 and other necessary clerical help on order of County Court.
- H. B. 109, Jackson—Fixing salary County School Superintendent of Sherman County at \$1000 per annum.
- H. B. 110, Farrell—Making stockholders in savings and state banks individually liable for an amount double that of the amount of his stock, and holding directors in such banks liable for treble the amount of their stock for all liabilities accruing while they are such officers.
- H. B. 111, McCue—Extending powers of Board of Pilotage Commissioners and authorizing them to maintain a sufficient number of capable pilots on the bar and river pilot grounds.
- H. B. 112, McCue—Providing that executors and administrators three months after making final report shall pay into court all unpaid legacies; if persons entitled to same do not call and receive it within a year, all such sums shall be paid into the state treasury.
- H. B. 113, Mahone—Authorizing the Governor to dismiss a pending suit against H. E. W. Smith et al to eject them from a state tract of 24 acres in Multnomah County.
- H. B. 114, McCue—Appropriating \$152,000 for land and dormitories normal schools at Weston, Monmouth and Ashland.
- H. B. 115, McCue—Appropriating \$188,000 for the payment of salaries of teachers, maintenance and contingent expenses of Weston, Monmouth and Ashland Normal Schools.
- H. B. 116, Lehmanweber—To prevent discrimination in passenger rates by transportation companies.
- H. B. 117, Lehmanweber—Authorizing Deputy Assessor in Clatsop at salary of \$1200.
- H. B. 118, Mahone—For two commissioners of the Oregon County.

New Measures Pour Into Senate in Steady Stream.

STATE CAPITOL, Salem, Jan. 20.—(Special.)—Bills were introduced in the Senate today as follows:

- S. B. 63, Bowerman, to give consent for United States to acquire property for sites for Federal building at another.
- S. B. 64, Bowerman—Authorizing Supreme Court to assign Circuit Judges from one county to another where business is congested.
- S. B. 65, Cole—That secret societies be prohibited in public schools.
- S. B. 66, Barrett—To amend Section 2016 of the game laws by making it unlawful to use any sink box, sink boat, snipe boat on any waters of the state for the purpose of shooting water fowl therefrom.
- S. B. 67, Johnson—To increase the appropriation of the State Agricultural College to \$100,000.
- S. B. 68, Coffey—That all criminal insane, rapists and criminals twice convicted be sterilized.
- S. B. 69, Sellings—Making it a misdemeanor for a purchaser of personal property on installment plan to injure same before said property is sold.
- S. B. 70, Sellings—Providing that depositions may be taken in a special proceeding after a question of fact has arisen therein.
- S. B. 71, Abraham—To divide the state into five normal school districts.
- S. B. 72, Abraham—To require the Secretary of State to furnish copies of the election laws to all state, county and precinct officers.
- S. B. 73, Abraham—To make killing a human being by mistake for a man a manslaughter.

SENATE CLASHES ON CLERK

SENATOR MILLER SPRINGS SURPRISE ON PARRISH.

Denies Counties Committee Is Overburdened With Work and Offers Use of Private Clerk.

STATE CAPITOL, Salem, Or., Jan. 20.—(Special.)—The clerkship question in the Senate, which was believed to be settled last week, came up again today and will be threshed out by the Senate again tomorrow. It was Senator Parrish, chairman of the committee on state and county offices, who sprung the question. He introduced a resolution authorizing his committee to employ an expert stenographer, and he wanted the rules suspended and the resolution adopted at once. Albee, of Multnomah, Smith, of Unatilla, Sellings, of Multnomah and Kay, of Marion, objected, calling attention to the fact that when the resolution was passed on the first day of the session, authorizing each Senator to appoint a private stenographer, it was provided in that resolution that where practicable these stenographers should serve as clerks for the committees of which the Senators are members.

State Cares for Consumptives.

Senator Kay has introduced, by request, a bill providing an appropriation of \$50,000 for the establishment of tuberculosis sanatoria where the tubercular poor may receive treatment. The bill provides for a board of four persons for the management of such institutions, with power to employ a medical director at \$200 per month, as many assistant directors as may be deemed necessary at \$100 per month, a business manager at \$150 per month, a matron at \$100 per month, and such other employes as may be needed at not to exceed \$75 per month each. The bill provides that not to exceed \$5000 shall be spent for land in any one year nor more than \$10,000 for buildings in any one year.

Move to Keep Judges Busy.

President Bowerman has introduced a bill authorizing the Supreme Court to assign a Circuit Judge of one district for service in another district whenever the work of such district is congested. In such a case the traveling expenses and hotel bills of the judge thus assigned must be paid by the county in which the judge sits for the trial of cases.

Ban on School Fraternities.

Secret societies in the public schools, including local or county high schools, are forbidden by a bill introduced today by Senator Cole. The bill does not apply to the State University or State Agricultural College.

To Increase O. A. C. Appropriation.

The bill to increase the appropriation for the State Agricultural College from \$50,000 to \$100,000 a year was introduced in the Senate today by Senator Johnson, of Benton. The bill provides that the appropriation shall be a continuing one, so that if part of the money be not expended in one year it will remain available in the succeeding year.

Dr. Owens-Adair's Bill Up Again.
