Fund Will Be Used to Relieve Sufferers and to Safeguard Pub-

lie Against Malady.

The committee of the Visiting Nurses' Association which had charge of the recent Red Cross Stamp sale held a moeting yesterday afternoon, at the Medical building, and rendered final re-Medical building, and rendered fipal re-ports as to the result of the campaign for funds to be devoted to the war against tuberculosis which is being waged in all parts of the country. The total amount realized from the sale of the stamps in Portland is \$152x15, Com-plete returns from over the state are not in as yet, but it is believed that the results will be gratifying. results will be gratifying.

results will be gratifying. Locally the sale was somewhat of a disappointment as it had been hoped that a larger sum would be neited. It had been planned to establish an open air camp for tubercular patients. The amount derived, however, will be in-sufficient for this purpose and that por-tion of the plan will have to be aban-doned. The money will be used to re-lleve the sufferers from the white plague who are unable to provide funds for who are unable to provide funds for proper care and treatment.

A portion of the money will also be used to conduct a campaign of educa-tion as to ways and means of preventing inoculation and as to the proper course to be pursued in caring for tuberculosis cases. Meetings will be held later at which a final disposition of the fund will
