

STUDENTS REOLT AGAINST PRESIDENT

Daughter of Head of Board of Trustees of Whitworth Circulates Petition.

ASKS POWER GIVEN DEAN

President of Institution Says Action Is Inspired by Two "Soreheads" in Faculty and Withholds Recommendation of Signers.

TACOMA, Wash., April 7.—(Special.)—The student body of Whitworth College, located here, is all torn up over the agitation against the president of the institution, B. H. Kroeze. At the instigation of two members of the faculty, it is said, a petition has been circulated by Miss Longstreth, a daughter of the president of the board of trustees, urging that the power vested in the president of the college be transferred to the dean, D. D. McKay.

This was signed by over 60 of the most prominent members of the student body and was presented to Mr. Longstreth by his daughter. While the petition does not ask for the president's resignation, it is construed so as to make him but a figurehead, with the object of forcing his resignation. He has refused to give recommendation to graduating students who have signed the petition.

HOQUIAM WANTS BRIDGE

Petitions War Department Again for Permission to Build.

HOQUIAM, Wash., April 7.—(Special.)—Following the satisfactory replies from the electric company and the Union Pacific, which were expected to join with the city in the construction of an elaborate steel drawbridge spanning the Hoquiam River, this city has renewed its application to the War Department at Washington for permission to build such a structure and also submitted plans and specifications to the Board of County Commissioners for approval and permission.

A former communication to the War Department elicited the reply that the Union Pacific had made prior request and therefore took precedence. The railroad, however, having apparently made no progress, the city will agitate the matter of a new bridge vigorously until some satisfaction can be had. A new bridge will cost approximately \$30,000.

"HONOR WOMEN AND FLAG"

Admiral Evans Gives Advice to Californians in Passing.

MERCED, Cal., April 7.—Admiral Robley D. Evans and party arrived here and proceeded to the Union Pacific Valley today. The citizens of Merced took advantage of the Admiral's half-hour stay, and more than 1000 persons, accompanied by the Mayor, gathered to see him. He addressed the crowd and the Admiral responded with a speech from the rear of his car. He said a word to the boys, telling them to buck the line hard in their life battle, but always to fight fair. "Never spike the man on second base," he said. "Obey the law, honor women and the flag, and when you hear either of them insulted, thrash the offender on the spot."

Salem Postoffice Grows.

SALEM, Or., April 7.—(Special.)—In six years the receipts of the Salem postoffice have more than doubled. At the end of the quarter ending April 1, 1908, the postal receipts of the Salem office were \$548.46; for the same quarter in 1909 the receipts had grown to \$1,053.73. The total business done for the quarter ending April 1, 1909, was \$18,655.67, entitling the Salem postoffice to a place in the list of first-class offices, the only first-class office in the state outside of Portland.

RAYMOND AND SOUTH BEND UNITE FOR DEEPER RIVER CAMPAIGN.

RAYMOND, Wash., April 5.—(Special.)—South Bend and Raymond are lining up for a strong pull and a pull altogether for a greater Willapa harbor. At the banquet given in honor of Major C. W. Kutz, of the Corps of Engineers, U. S. A., Seattle, in the Hotel Alber, South Bend, Friday night, a representative body of progressive citizens of the two municipalities was present. PORTER NEARLY FREEZES

ROBBERS LOCK HIM IN ICEBOX OF SALOON.

While They Rifle Till He Burns Matches and Cigarette Papers and Almost Suffocates.

SPOKANE, Wash., April 7.—(Special.)—After locking Bill Brown, the porter, in an icebox in the basement, where he was held for two hours and shivering prisoner, two armed and masked burglars rifled the cash register in the Tavern saloon, 111 Howard street, of \$178 at an early hour this morning.

Shaking from head to foot and so chilled and stiff he was unable to speak, the porter was released from his prison when the door bartender came on duty at 6 o'clock. The burglars entered the room through the basement and surprised and overpowered Brown, who was cleaning up the saloon. At the point of a revolver they drove him to the basement and locked him in the big refrigerator, which was filled with ice. Had he not been discovered he would have succumbed to the cold within a short time. He kept himself warm by burning matches and cigarette papers, but the smoke from these nearly smothered him.

GIRL'S LETTERS FOUND

Coroner's Jury Awaits Analysis of Miss Barnes' Stomach.

MARSHFIELD, Or., April 7.—(Special.)—The Coroner's jury in the case of Miss Mable L. Barnes, the young woman who dropped dead at the home of her parents in North Bend, has adjourned until April 15. The jury is awaiting the verdict of the State Chemist as to whether or not poison was found in the stomach. Letters written by the young woman to a man friend who formerly lived here, and which have been returned as undelivered, have fallen into the hands of the Coroner. In these letters reference is made to medicine taken by Miss Barnes, but there is nothing definite enough to ascertain from where the medicine was obtained. The decision of the Coroner's jury will determine entirely upon the report of the State Chemist. The parents of Miss Barnes are almost prostrated with grief over her death and the publicity which has attended the misfortune.

MANY VISITORS EXPECTED AT U. OF O. CELEBRATION.

Work to Be Done on Campus, Big Athletic Meet Arranged and Junior Prom at End.

UNIVERSITY OF OREGON, Eugene, Or., April 7.—(Special.)—Oregon plans to make this year's junior week-end festivities greater than ever before. This year the University is the result of evolution from the former custom of using some day in May for a class rush between the juniors and sophomores. The class of 1906 decided this day could be used better in beautifying and improving the campus. The succeeding classes have followed the precedent established and great improvements to the campus have been the result. The girls have come to take an active part in this day's exercises by serving an elaborate luncheon for the workers. There has generally been some track meet or baseball game in the afternoon and the evening has been devoted to junior orations. Gradually the celebration has been extended until it now consists of three days. Last year the work done by the students consisted in building 50 feet of cement sidewalk, the erection of 100 feet of bleachers on the football field, and the construction of a big oval "O" on Skinner Butte, which can be seen from miles around. After justice had been done to the ample dinner provided by the girls a dual track meet with O. A. C. was held. The orations were given in the evening and the next day, Saturday, the Oregon and O. A. C. crossed bats twice. The grand finale was the junior prom on Saturday evening. Many people who visit the University at this time and many more are expected this year. The junior prom has come to be the one big dance of the year, which is open to friends of the university. Manager Bean has already arranged two big athletic features for this year's celebration, which comes in the middle of May. One is the big triangular meet between the Universities of Oregon, Washington and Idaho, and the other consists of two baseball games with O. A. C. Thomas R. SAFEGUARD FOR AGENTS

NEED NOT REDEEM PARTIALLY USED TICKETS.

Attorney-General Renders Opinion Saying Unused Tickets Must Be Taken Up.

SALEM, Or., April 7.—(Special.)—Attorney-General A. M. Crawford has rendered an opinion to the effect that local agents of railroads should not be compelled to redeem partially used tickets. The state law provides that the road "shall redeem, upon presentation by the local holder thereof, to any of its ticket agents in this state, the whole or any part of any railroad ticket, no part of which has been used." The Southern Pacific officials say it is impracticable for local agents to redeem partially used tickets, for the reason that the local agents are not supplied with the necessary information regarding the price at which the tickets were sold. However, local agents are empowered to refund tickets, no part of which has been used. The others are sent in to the Portland office for computation. The attorney-general coincides with the Southern Pacific in that it would not be possible for local agents to redeem partially used tickets without making mistakes and laying the company open to penalty for violation of the railroad commission act.

DEER ISLAND WANTS STOCKPEN.

SALEM, Or., April 7.—(Special.)—Elmer T. Connell, of Deer Island, Or., has made complaint to the Railroad Commission that the Oregon Railway and Navigation Company does not maintain a stock pen or loading chute for stock at Deer Island, and that therefore the service is unreasonable and unjustly discriminatory.

TWO STRIKES IN DAY

Foreigners Working on Lytle Road Revolt.

GET INCREASE, WANT MORE

Demand Raise from \$1.85 to \$2. After This Is Granted They Strike for \$2.25, Which Is Refused. Sheriff Quells Riot.

TILLAMOOK, Or., April 7.—(Special.)—Not satisfied with a raise of 15 cents a day from \$1.85 to \$2, the foreigners working on the new road of the Pacific Railway & Navigation Company, near here, went on another strike today. Their first strike was successful, and they got the increase demanded. Then, flushed with victory and some of their red wine, they demanded \$2.25 a day, which was promptly refused. Infuriated at this, and being by this time ripe for revolt, the foreigners organized, armed themselves and proceeded down the track from the Miami to the Wilson River. On the way they compelled everybody, including the surveyors, to quit work. The strikers were in such a threatening mood that to avoid trouble, the steam shovel and bridge crew quit also, till they had gone by. Sheriff Crenshaw swore in some extra deputies, and with ten men proceeded to the scene of the disturbance. Although some of the more violent of the strikers were inclined to show fight, the Sheriff quickly gave them to understand no resistance would be tolerated and arrested four of the ringleaders and brought them to town, where they were locked up in the County Jail.

The rest of the gang then dispersed, but none of them returned to their work. Sheriff Crenshaw swore in some extra deputies, and with ten men proceeded to the scene of the disturbance. Although some of the more violent of the strikers were inclined to show fight, the Sheriff quickly gave them to understand no resistance would be tolerated and arrested four of the ringleaders and brought them to town, where they were locked up in the County Jail.
