

MRS. SCOTT WINS BY SLIM MAJORITY

Honors Divided in Election of
Officers by Daughters
of Revolution.

CONTEST BITTER TO END

Opposition Gains Second Place, Re-
fuses to Make Election of Mrs.
Scott Unanimous, but Gives
Mrs. Story Ovation.

WASHINGTON, April 23.—After 24 hours devoted to counting and recounting the ballots cast yesterday, the Daughters of the American Revolution found today the honors of the biennial election of their society divided between the administration and anti-administration forces.

The big fight was won by the administration in the election of Mrs. Matthew T. Scott, of Illinois, to be president-general. The second office in point of honor, that of vice-president-general, in charge of organizations, went to the anti-administration followers by the election of Mrs. Miranda B. Tulloch, of this city. Mrs. Scott obtained a majority over Mrs. William Cummings Story, of New York, of only eight votes out of 873 ballots cast.

Refuse to Make It Unanimous.
The election was characterized by a bitterness that prevented the adoption without dissent of the motion of Mrs. Story to make the election of her rival unanimous.

When the convention met today the count had not been completed. Toward noon Mrs. McElroy Avery, chairman of the tellers' committee, announced 873 ballots had been cast. "The number necessary for election is 437," said Mrs. Avery. "Mrs. Matthew T. Scott received 436."

Pandemonium followed. Gray-haired women waved whatever they could seize and some of the Daughters even shouted. Scarcely had Mrs. Avery announced that Mrs. Story had received 428 votes before the New York candidate found her way to the platform. She thanked those who had voted for her, asked that support be given Mrs. Scott and moved that the election be made unanimous. Cries of "No!" greeted her, but Mrs. McLean put the question. Although a majority voted in the affirmative, several answered in the negative.

Mrs. Scott was introduced as the next president-general and said:

Mrs. Scott Makes Speech.

I shall be content if only one fold of the mantle of my great predecessors falls upon me, but I am glad to be enveloped with another mantle—the mantle of your charity and your devotion to the cause of the oppressed. I am glad to be able to say that the character of the Daughters of the American Revolution is such that it is a privilege to be called to sit in the exalted chair of president-general.

Our beloved and magnificent organization without partisanship, without sectionalism, with ever-broadening outlook and ever-growing ideals, moves with a platform broad as fatherland, tender as motherland, hand in hand and shoulder to shoulder in its grand work for home and country, for God and native land.

Ovation to Mrs. Story.

Half an hour later another dramatic feature of the session occurred. Mrs. Story, as stated, received 428 votes, while the report over which one of the clashes of the congress had taken place earlier in the week. As she fired the assembly her followers vied with one another in impressing on the meeting that Mrs. Story had fallen short of the presidential majority by only five votes. In her report, Mrs. Story spoke of the loyalty of New York to the organization.

On motion of Mrs. Murphy of Ohio a resolution was added making Mrs. Donald C. McLean, the retiring president-general, an honorary president-general. The congress approved the election of the various state regents. They include the following:

Idaho—Mrs. David H. Tarr.

Montana—Mrs. Emil H. Renisch.

Washington—Mrs. D. A. Gove.

Insurgents Win Minor Offices.

The insurgent candidates for office below that of president-general made virtually a clean sweep, capturing almost all of the more important places. The tellers reported tonight that the following had been elected:

Vice-president-general in charge of organizations, Mrs. Miranda B. Tulloch (insurgent), of the District of Columbia; recording secretary-general, Mrs. Mary R. Wilcox (insurgent), of Tennessee; registrar-general, Miss Grace M. Pierce (insurgent), of New York; librarian-general, Mrs. Short A. Willis (insurgent), of the District of Columbia; treasurer-general, Mrs. W. D. Hoover (administration), of Washington; historian-general, Mrs. Gertrude Darwin (insurgent), of the District of Columbia.

Mrs. John F. Swift, of California, was among the ten vice-presidents-general elected.

expressed his gratitude and delight at the hospitality shown him by the Acting Governor and by Mrs. Jackson.

At the conclusion of the visit with Sir Alfred Pease, Mr. Roosevelt probably will go to the Juba ranch and be the guest of George MacMillan. After this he will shoot buffalo at Hugh Heatley's Kamit ranch, 35 miles from Nairobi, on the Fort Hall road.

Before leaving Mombasa, Mr. Roosevelt received an address of welcome from the American missionaries. He will visit at least three mission stations while in the protectorate.

Arrest of Writer Explains Disappearance of Young Cabanne.

ST. LOUIS, April 24.—The boy found in the company of Broughton Brandenburg in San Francisco, who gave the name of Cabanne, is James S. Cabanne, of this city, who disappeared from the home of his grandmother, Mrs. Julia C. Cabanne, here April 15. The boy's disappearance was made known to his grandmother by a man who told her over the telephone not to worry, as the boy would be returned to her safely. The grandmother has always maintained the boy was with his mother, who now says she is the wife of Broughton Brandenburg.

Several letters demanding money for the return of the boy have been received here.

REAL MARVEL EFFECTED

RATES ON FRUIT SO LOW IT'S
CHEAPER IN CHICAGO.

Virtues of System Used Against Him
at Hearing on Lumber Rate
Injunction.

CHICAGO, April 23.—(Special).—The fact that the Union Pacific Railroad presents a marvel of operating economy

was one of the virtues of the Harriman road that its critics sought to turn against it today. That oranges and other Coast fruits are marketed cheaper in Chicago than on their native Pacific Coast was one of the telling points raised in the road's defense.

This marshaling of evidence took place in the hearing of an injunction suit brought by the Hill and Harriman railroads against the Interstate Commerce Commission. The scene of the contest was shifted to Chicago this morning from St. Paul, where the first steps were taken. The issue is a 10-cent advance in rail traffic on lumber, which the Northwestern roads put into effect on shipments to points east of the Missouri river, but which the Interstate Commerce Commission frowned upon and then prohibited. The Commission ordered the roads to put in effect a lower tariff and the roads seek to enjoin the Commission from putting this order in effect.

J. A. Munroe, freight traffic manager for the Union Pacific, testified in effect that although the Union Pacific made a profit on freight handled, a proper portion did not come from lumber. He thought the railroads were entitled to an advance in the rate on this commodity.

REVOLVERS INJURE TWO

Accidental Discharge of Weapons
Causes Slight Wounds.

By the accidental discharge of revolvers, two victims were injured last night in this city. In both cases the injured persons knew the weapons were loaded, but did not exercise the proper precaution in handling them.

Harry Greenleaf, night watchman at the Medical building, shot himself through the hand while cleaning his revolver. The accident occurred at the National Hotel, where he lives with his wife. Mrs. Greenleaf had expressed the desire to have a weapon in her apartment during the absence of her husband, so he took one from the building for his wife's use. While handing it to her, and it accidentally exploded. The bullet penetrated his hand. Dr. Young dressed his wound.

The other victim was W. F. Belcher, of 687 Davis street, a member of the Order of Hoo-Hoo. The order initiated a large number of candidates last night at Arion Hall, corner of Second and Oak streets. Mr. Belcher was one of the riding, and in one part of the ceremony was required to use a revolver. The weapon prematurely exploded, inflicting a slight flesh wound in the calf of Mr. Belcher's leg. He was taken to the Good Samaritan Hospital, where his injury was dressed.

Change Missouri Rate Ruling.

ST. LOUIS, April 23.—The temporary passenger rate injunction against the Missouri railroads limiting the rate to two cents a mile, will be so modified that it will apply only to discriminatory rates. The change was announced today, following a postponement of the hearing of the case to April 26.
