

FURTHER CARNAGE FEARED IN TURKEY

Moslem Fanatics Under but Slight Restraint in Dis- turbed Regions.

REFUGEES IN DIRE STRAITS

Many Ecclesiastical Schools Are De- stroyed and Financial Loss Will Be Great—Change in Rule Well Received.

BEIRUT, April 27.—Later advices received here show little improvement in conditions throughout the disturbed regions of Asiatic Turkey. Every day adds to the sufferings of the refugees and to the death list.

A dispatch from Adana says that the fires have been extinguished, but there is a fear of further incendiarism. The American mission buildings, the Catholic school and one Gregorian church have been saved.

Many Thousands Destitute.

The Jesuit and Armenian Catholic and Protestant churches and schools have been burned. Twenty thousand persons are destitute and there are few supplies of any kind.

Hadjin is still besieged. It has withstood several attacks made upon it from the mountain tops. All of the American missionaries in that town were safe up to last night. No direct word has been received from them today.

Refugees in Fear.

Thousands of refugees have arrived from Latakia, and the Governor, with the few old soldiers at his command, is doing his utmost to prevent disorders, but the Moslem community is strong and he is meeting with much opposition. The British warship Diana will arrive at Latakia tomorrow, as the presence of a ship at that place is absolutely necessary.

Beirut is quiet and the announcement of the succession of Mehemmed Rehad Effendi as Sultan was well received tonight. Aintab is apprehensive and unsettled. Unless the disturbances are immediately checked they will extend into the interior of Mesopotamia, which section is bitterly reactionary.

MISSIONARY TELLS OF HORROR

Connecticut Minister Gives Account of Massacres.

ADANA, April 27, via Constantinople.—The Rev. Herbert C. Adams, of Hartford, Conn., a missionary of the American Board of Foreign Missions, stationed here and at Tarsus, was an eyewitness of the scenes of horror and destruction at the center of the Moslem uprising. He gives as follows the first graphic story of the series of massacre, rape and incendiarism.

"Early last Wednesday morning, while I was in the market, I noticed that the Armenians were closing their shops and hurrying to their homes. An Armenian and a Turk had been killed during the night and the corpses were paraded through the respective quarters. The sight of the dead terrified the Armenians and crowds at once began to gather in the streets armed with sticks, axes and knives. A few Armenian men assembled in the center of the covered market and began firing revolvers into the air. By 10 o'clock in the morning the crowd had begun the looting of shops.

"The military commander of Adana was by my side in the market when the firing commenced. He had not the courage to endeavor to disperse the mob; he returned to his residence and did not venture out for two days.

"William Chambers, field secretary of the Young Men's Christian Association, and myself proceeded to the Konak and found a howling mob demanding arms with which to kill the Armenians. We then proceeded to the telegraph office to summon the British Consul. On the steps of the building we saw three Armenians, who had been massacred before our eyes, had been mutilated. While we were in the telegraph office a mob burst into the room where we were and killed two Armenians before our eyes. The telegraph operators were supplicating the protection of the Vah when they were struck down.

"We managed to make our way into the next room, where we made representations to the Vah. This official said he could do nothing. He was afraid for his own life and he made no attempt to protect us. Somehow we managed to get into the interior of the Konak, where we remained at the side of the government officials for the next 48 hours.

"That afternoon the situation grew distinctly worse. The Armenians withdrew to their quarters of Adana, which is situated on a hill, and converted their houses that held advantageous positions into fortresses. Here the fighting went on for two days, during which time the Armenians succeeded in driving off their Turkish assailants.

"Adana was a hell. The bazaars were looted and set on fire. There was continued and unceasing shooting and killing in every part of the town and fires raged in many grounds.

"Moslems from the neighborhood began pouring into the city, and notwithstanding our vehement protests, the Vah distributed arms to these men, alleging that they were Turkish reserves.

"Major Daughy-Wyke, at the head of troops which he compelled the Vah to supply, went to the rear end of the town and was successful in preventing the villagers from coming to Adana. Later, while the Major was attempting to pacify the town, he was shot and disabled.

"Missionaries of the Central Turkish Mission had assembled for a district conference in the center of Adana on the day of the outbreak.

"They received and protected hundreds of refugees in the American missionary girls, and courageously endeavored to pacify the warring elements.

"On Thursday, Daniel Miner Rogers and Henry Maurer, American missionaries, were killed under treacherous circumstances.

"On Friday the Armenians yielded, since when there has been little murdering.

"Adana is in a pitiable condition. The town has been pillaged and destroyed, and there are thousands of homeless people here without means of livelihood. It is impossible to estimate the number of killed. The corpses lie scattered through the streets.

LET FOREIGNERS ESCAPE

Fanatics Only Kill by Accident.

Hadjin Still Besieged.

CONSTANTINOPLE, April 27.—There is a total of 32 American missionaries in Syria and the Galician dis-

trict of the vilayet at Adana, where the conflicts between Mohammedans and Armenians are raging most ferociously, but, with the exception of D. M. Rogers and Henry Maurer, who were killed at Adana, no one of them, so far as is known, has been injured.

The Mohammedans indulging in massacres and incendiarism evidently are careful to avoid killing foreigners. The missionaries appear to be in danger only from accident.

The Christian refugees by the thousands have massed at Hadjin and for ten days now the town has been threatened by Mohammedans, whose camps completely encircle it.

SMALLPOX ADDS TO HORRORS

Dread Plague Breaks Out Among Refugees at Latakia.

LATAKIA, Syria, April 27.—Five thousand refugees are quartered here, having come in from Kersal and other points in the district north of Latakia, where several thousand Turks from surrounding villages have burned towns and killed many Armenians.

Several smallpox cases have already been reported among the refugees. There are no soldiers at Latakia.

Miss Edie Chambers, one of the missionaries at Kersal, is safe, news of this having been received by Dr. J. M. Baskin, who is in charge of the missions at Latakia and Lodi.

SUSPECT NAN PATTERSON

WASHINGTON POLICE THINK SHE KNEW OF CRIME.

Bank Teller, Close Friend of Former Chorus Girl, Is Shot Under Queer Circumstances.

WASHINGTON, April 27.—(Special.)—Nan Patterson's name is connected with the shooting of the bank teller, Fred Shapana, who was shot Saturday night while in the bank with J. M. Baker, Jr.

Nan Patterson, who came into notoriety in connection with the shooting of Caesar Young, is now Mrs. A. Martin, the wife of a race-track man. She is living here with her parents, which in a few yards of the bank, where the shooting occurred, and Stevens had been living with the Pattersons also. He is said often to have been seen in company with Mrs. Martin.

Stevens stated after the shooting that he had been attacked by a negro, but no one can be found who saw any negro running away. The police are conducting a careful inquiry, but nothing of importance has been developed. Officers of the bank say that the cash was found to be all right. Mrs. Martin is reported to have visited Stevens in the hospital. His injury is not considered serious.

BOAT ROCKED BY FOOL

LAUNCH OVERTURNED, THREE EXCURSIONISTS DROWN.

Tragedy Ends California Pleasure Trip—Two Sleeping Fishermen Run Down.

OAKLAND, Cal., April 27.—Information has just been received here of the death by drowning of five persons late Sunday night in the Little town of Black Diamond, Contra Costa County. Three men died by the overturning of the launch, while two were sent to watery graves by being run down by a tugboat.

The dead: Steve Cripps, 25 years old, cigar dealer; Jack Latimore, aged 23, lawyer; Fred Shapana, engineer of the launch; Louis Grilla, Salvador Grilla.

The first tragedy occurred on Sunday night. A party of 25 pleasure-seekers from Black Diamond was returning after fishing in the river and fell asleep near dark from a near-by resort. When close to shore one of the excursionists began rocking the launch, which overturned, throwing the occupants into the water. All were saved except Cripps, Latimore and Shapana.

Later Louis and Salvador Grilla were out fishing in the river and fell asleep. Their boat was run down by a tugboat in the darkness and the men were drowned.

HAINS JURY COMPLETED

Eleven Married Men and Young Man of 27 Will Try Case.

FLUSHING, N. Y., April 27.—The jury to try Peter F. Hains for the murder of William F. Annis was completed today. It took seven days to select the 12 men. The state will try the case tomorrow. The juryman are married, except Otto Nicholas, who is 27 years old.

The defense has fought all along for married men and prominently challenged the few bachelors who qualified. The idea that a lunacy commission will be appointed to pass upon the Captain's mental condition is gaining ground.

25,000 SHEEP ARE SOLD

Arlington Stockmen Receive Big Advance in Prices.

PENDLETON, Or., April 27.—(Special.) Mixed yearling sheep to the number of nearly 25,000 have been shipped from Arlington within the past two weeks. The prices paid ranged from \$1 to \$4 per head, while the same grade of sheep sold last season for from \$2.75 to \$3.25 per head.

Most of these were purchased by Eastern Washington and Southern Idaho buyers, and were shipped into those states.

FIGHTING WORDS AMONG LAWYERS

Heney and Rogers Agree to Settle Disputes After Cal- houn Case Ends.

EXCHANGED HOT EPITHETS

"Cur" and "Dog" Among Cooling Words of Endearment—Heney's Theory of Conspiracy Called Myth by Opponents.

SAN FRANCISCO, April 27.—Francis J. Heney and Earl Rogers, of counsel in the trial of Patrick Calhoun, agreed today that their private differences, arising out of a clash over the admission of testimony, shall be settled at the first opportunity following the end of the trial. An exchange of threats, made in tones that escaped the shorthand reporter, nev-

ertheless caught the attention of Superior Judge William P. Lawlor, who demanded to know what the warring attorneys had said. Ignoring the court, they proceeded with their examination of Daniel G. Coleman, the third member of the former Board of Supervisors, summoned as a witness against the president of the Union Pacific.

For the first time during the pending trial Mr. Rogers appeared to take offense at a remark made by the Assistant District Attorney, advancing to the edge of the table reserved for Mr. Calhoun's attorneys, he said:

Sounds Like Dueling Talk.

"Don't you talk to me in that manner, Mr. Heney."

"I'll meet you at any time you say," replied the prosecutor, and while the court was endeavoring to learn the substance of the debate, which was conducted in the lowest of tones, Mr. Rogers said: "All right, Mr. Heney, that is agreed, but we will settle this matter after we have ended our duties to our respective clients."

Mr. Heney departed from the courtroom under the escort of his customary bodyguard, and the adjournment marked the end of a stormy session of court, where in Mr. Heney addressed Lewis F. Byington, of the defense, who was opposed by Mr. Byington retorted by addressing Mr. Heney as "a trailing dog." Between the quarrels, the re-cross-examination of James T. Gallagher, who has occupied the witness-stand since last Tuesday, was concluded, and Coleman, an ex-Superintendent, was called in his place.

Heney Warns Assailants.

When Mr. Heney and Mr. Byington indulged in their exchange of compliments, Judge Lawlor warned them that such language would not be tolerated, whereupon Mr. Heney, addressing at once the defense side of the room, said:

"I have heretofore notified the court that I do not intend to be assailed by any person engaged in this cause. I stood it for months when I was opposed by Henry Aehl, but, so help me God, I will not stand for it again. I shall not play the baby and appeal to the court for protection, because I conceive it to be the court's duty to intervene when these attacks are instituted. I serve notice again that my character must not be assailed when we come to the argument to the jury, when you are at liberty to say anything you please."

The outburst marked the end of a long argument relating to admission of testimony given by Gallagher. As the attorneys alternated in their appeals to the court, the remarks gradually became bitter, and Mr. Byington, finally interrupting Mr. Heney in the course of an address to the court, said:

"That statement is not true, and that man knows it is not true. Mr. Heney's face turned as he ceased speaking, and there was silence for a period of 10 seconds. Then, speaking very slowly and distinctly, the prosecutor addressed to his opponent the remark about "a barking cur."

Dispute About Conspiracy.

No issue in the trial has been more bitterly contested than the effort on the part of the prosecution to show the relations tending to show conspiracy between Gallagher and Abraham Ruef prior to installation of the Schmitz Board of Supervisors. Mr. Heney charged that the defense was attempting to destroy or minimize the value of Gallagher's testimony by attempting to show an organized conspiracy for the purpose of holding up all corporations that were reached.

"The closest, most iniquitous and rascally scheme ever conceived was this bond of interest between Gallagher and Ruef," said A. A. Moore.

It was Mr. Heney's intention to bring out, through Gallagher's testimony, an allegation that Ruef and Gallagher had

agreed upon the acceptance of bribes before Gallagher spoke of prospective bribes to other members of the board. In the course of his argument he referred to a conspiracy and cited problematical situations wherein a defendant might not be directly connected, but nevertheless implicated.

Judge Lawlor, after nearly two hours of argument, decided the point in favor of the prosecution, and Gallagher, renewing his narrative, stated that he discussed possible bribery with Ruef before he ever spoke to a Supervisor. Gallagher also declared that he never knew where Ruef obtained the money paid him in any of the alleged deals.

LANGFORD, BADLY MAULED
