Horrible Scenes During Adana Massacres Described in Letter.

FIRES SURROUNDED SCHOOL

Miss Elizabeth H. Webb Describes How Missionaries, Rogers and Maurer, Met Death—Guards Deserted, Flame and Pillage.

EPIDEMIC OF SMALLPOX ADDS TO MISERY OF STRIPPEN CITY OF ADANA.

ADANA, May 2.—Smallpox has broken out in epidemic form. There are always cases of this as well as other virulent diseases in Adana because of the poor sanitary conditions. It is impossible to estimate the number of cases, but during the last two weeks the spread of disease has been frightful, and the homeless element roaming the city.

ADANA, Asiatic Turkey, May 1, via Constantinople, May 2.—Miss Elizabeth H. Webb, a missionary of the American Board from Bunker Hill, Ill., has written for the Mission Board a narrative of her experiences during the first days of the massacre in Adana, when the girls' school, to which she was attached, was in the greatest danger and the lives of the students were threatened from all sides. She says:

"Our friends came to school as usual on Wednesday (April 21), although we heard there was a great deal of unrest in the city. Soon firing began and before noon things were in such a disturbed condition we were afraid to send the day scholars home. The girls were too excited to study. We ourselves tried to go on with our annual meeting, but the reading of the reports was interrupted by the screaming and the shooting. Two of our Turkish children were present, and we thought it would be possible to send word of our danger by a Turk who had come to take them home. According to the reports written by their father and to the governor were written, but there were no responses.

FIRES ARE STARTED.

"As night came on fires began to flare up in all directions, and we were fearful that the school would be burned. The school, finally, about 9 o'clock, to our relief, the English Consul arrived. He had heard of the disturbances and had come from Mersin to investigate. The Consul is Major Daugherty-Wylye. He could stay only a moment, but he left three of his own guards of Turkish soldiers to take care of us.

"All through the night we actually seemed to be in a state of siege. The three soldiers kept firing their rifles, and the fire was returned from the minaret houses near by. In the morning our guard discovered that the men in the minaret houses, whose fire they had been returning, were Turkish soldiers and that others who had been firing upon us were friends whom we knew by name. PORTION OF OLD GUARD RETIRES

Last Stand Made by Turkish Marines, Who Refuse to Embark for Stations.

OBTAIN CONTROL QUICKLY

General Shekhet Offers Submission or Death and White Flag Is Hoisted—Ringleaders to Be Sorted Out and Tried.

CONSTANTINOPLE, May 2.—The marines in the Kasim barracks, situated behind the American Embassy, mutinied last night. They refused to embark for distribution to various ports.

The marines belong to the old disaffected garrison and although they had nominally surrendered, this was in an ugly mood. They were easily persuaded by agitators to make an armed protest against the new government.

When the American Ambassador, Mr. Leishman, looked out of his bedroom window this morning, he observed a battery of mounted howitzers occupying a position on a terrace near the Embassy. Further up, field pieces had been stationed, while the barracks of infantry were spread out through the Turkish cemetery and on the slopes overlooking the Golden Horn. General Shekhet, commanding, lost no time in bringing the mutineers to terms. After they had surrendered, he said:

"It was the last flicker of resistance. After we had dispersed several battalions of troops and some batteries within easy range of the barracks, we inquired who it was to be, obedience to order or the rule of their comrades in the Kasim arsenal. The white flag was then hoisted on the barracks.

"The mutiny," added General Shekhet, "was the work of a few ringleaders. We are now sorting them out for court-martial."

SEARCH ON FOR ABDUL'S CASH

Reported to Have Kept Much Money Hidden in Palace.

CONSTANTINOPLE, May 2.—The treasures of the Palace of Yildiz are being inventoried by a parliamentary commission.

Abdul Hamid took the opportunity 30 years ago, gradually transformed them into gardens, among which he constructed pavilions for himself, his wives, his children and the palace favorites. He gathered there an immense variety of objects of art and luxury, services of silver and gold, French and Oriental carpets, Greek sculptures taken from the museums of Constantinople, presents of most of the sovereigns of Europe and gifts from wealthy subjects.

Search is being made for the hoards of cash which Abdul Hamid is reported always to have had on hand. He has also great sums hidden abroad. None, however, has been found as yet, although the ex-sultan must have had at least a few thousand pounds in the domestic exchequer.

MORE EXECUTIONS ARE COMING

Example to Be Set by Public Hangings in Constantinople.

LONDON, May 3.—A dispatch to the Daily Telegraph from Constantinople says that in an interview, Enver Bey, one of the leaders of the Young Turks, declared they had proofs that a massacre of all Turks suspected of treason had been projected in Constantinople and was prevented only by General Shekhet hastening to the scene.

Enver Bey said he now had no fear that Abdul Hamid would become the center of new revolts. He believed as much of the court-martial of the would be an additional 100 executions and as many persons more would be sentenced to imprisonment at hard labor.

SQUADRON NEARS GIBRALTAR

North Carolina and Montana Are Heading to Turkey.

WASHINGTON, May 2.—The American armored cruiser squadron, composed of the North Carolina and Montana, which left Guantanamo, Cuba, at 10 o'clock under orders from the Navy Department to hurry to Alexandria, Turkey, to protect Americans there, was 110 miles west of Gibraltar last night, according to a cablegram received by the Navy Department.

The vessels are traveling at the rate of 15 to 16 knots an hour and at this speed officials of the Bureau of Navigation say the squadron should reach Gibraltar on Tuesday or Wednesday next. They will receive orders to continue to Eastern Mediterranean waters.

STATUE TO BE UNVEILED

The statue, which is located at the intersection of Connecticut avenue and M street, is one of heroic size and of pure white marble. William Couper, of New York, is the sculptor. The statue will be presented to the city by Brainerd H. Warner, treasurer of the Longfellow National Memorial Association, and will be accepted by President Taft. The dedication will be pronounced by Dr. Edward Everett Hale.
