

SEEKS EVIDENCE CAMP OF CALHOUN

Heney Calls United Railroads
Employees to Testify
Against Chief.

CAUSES HOT SKIRMISHING

Calhoun's Detective Attributes Gallagher
Explosion to Burns.
Agents—Receipt of Stolen
Evidence Is Admitted.

SAN FRANCISCO, May 24.—(Special.)—Francis J. Heney, prosecutor in the trial of Patrick Calhoun, president of the United Railroads, today entered into the defense for several of his witnesses today, and in consequence the proceedings were embittered by strife between counsel and continual skirmishes between Mr. Heney and the reluctant and hostile subjects of interrogation. Another fortnight may end the trial, which entered today upon its twentieth week.

The afternoon's session, which produced virtually all of the important testimony of the day, was devoted to examination of Thomas B. Gibson, a detective in the employ of the United Railroads; George R. Francis, secretary of the company's legal department, and Luther Brown, a Los Angeles attorney who has been active in behalf of the defense.

Says Burns Incited Dynamiting.
Mr. Heney asked Gibson to explain his part in the dynamiting which wrecked the home of J. H. Gallagher, one of the witnesses for the prosecution, and imperiled the lives of Gallagher and several other inmates of the house. Mr. Heney's questions carried many charges that Gibson denied, but the witness admitted he had been directed to look into the affair by Theron Mullaly, assistant to Calhoun. When asked what he had discovered, Gibson said:

"I discovered that two men were arrested and held in Oakland for a couple of weeks, and that two other men had bought ten pounds of dynamite. My name was Wilhelm, and I supposed he was working for William J. Burns."

"What reports of the dynamite did you make to William J. Abbott?" asked Mr. Heney.

"I told him that I thought Burns and Wilhelm had a hand in it, and that the explosion was brought about to create a feeling against Mr. Calhoun in his trial," said the witness.

"Did you think Burns wanted to kill Gallagher?" asked the prosecutor.

"I did not," replied Gibson. "I had reason to believe that the people who lived in the house were all to be killed by arrangement when the explosion occurred."

Attempt to Kill Gallagher.
Mr. Heney then asked Gibson if he had not attempted to interfere with Burns when the latter returned from the East and attempted an investigation of the dynamiting. The defense interposed an objection, and Mr. Heney charged that an attempt was made to assassinate Gallagher by the dynamite, and that the agents of the United Railroads were instrumental in the effort to suppress evidence of the crime.

Secretary Francis, who followed him on the stand, admitted having received from John Helms, formerly connected with the United Railroads, a filing cabinet and a quantity of documents, which, Helms alleged, were reports on jurors and other matters abstracted from the office of Burns. He testified that he had received money from Abbott to pay Helms and other men engaged in similar work.

Luther Brown's Evidence.
The witness declared that he had never arranged for Alexander Lathan, chauffeur of Abraham Ruef, to enter the employ of his (Brown's) father-in-law, and that he never knew of his employment, which was regarded as a new employment issue because Lathan is now awaiting trial on a charge of perjury alleged to have been committed in the Ruef trial.

Brown admitted acquaintance or relations with several men designated by Mr. Heney as agents of the United Railroads. One of them was J. C. Brown, who, Mr. Heney charged, had spent much of his time shadowing Burns.

The examination of the witness had not been concluded when the session ended.

Heney Calls for Vouchers.
Adam Dahler, acting treasurer of the company, testified that he had no recollection of money paid to T. L. Ford, chief counsel, and William J. Abbott, general attorney, for which no explanatory vouchers were given. Heney then asked the court to order the presentation of the vouchers. The defense protested vehemently and long argument ensued between Heney and Alexander King for the defense.

Intimating that he would not produce the vouchers, Judge Lawlor directed that the witness be furnished with a list of the persons by whom they are alleged to have been given. Among the individuals named by Mr. Heney are all the men named by Helms as shadowers of J. W. Burns—Felix Pauzeval, accused in the case of the dynamiting of James Gallagher's home, Thomas Gibson and Luther Brown, detectives, and Attorney W. H. Metson, Nathan Coghlan, Louis M. Hoefler and Charles Peery.

HUGE COMET IS VISITING
Astronomers at Hobart College See
Terrestrial Visitor Near Dawn.

GENEVA, N. Y., May 24.—An unusual astronomical phenomenon which had the appearance of a comet close to the horizon was observed early today at the Smith Observatory by Dr. William R. Brooks, professor of astronomy at Hobart College.

"The object was visible in the eastern sky from 2 to 3 o'clock," he said. "It had the appearance of a 'gigantic' naked eye comet, with a large head and a tail of enormous proportions. When first seen the head was in the great square of Pegasus, and the tail structure upward toward the North Star, at one time reaching the chair of Cassiopeia. The motion was rapidly eastward."

"At 2:30 A. M. the head enveloped the star Algenib, and by 2 o'clock had reached the horizon. Soon after the tail was lost in the rapidly advancing dawn."

Mrs. Sully's attorneys claim that the bill was not contracted by her, but by her husband, who was unable to pay it after he had lost his position with a brokerage house after his reverses in the market.

CHATAQUA READY FOR NEW SESSION

Assembly at Gladstone Park
During July to Have Several
New Features.

FINE MUSIC IS ARRANGED

Many Prominent Speakers Will Address
Gathering, and Men of
Note Will Instruct Classes
on Various Subjects.

OREGON CITY, Or., May 24.—(Special.)—The sixteenth annual session of the Willamette Valley Chautauqua Assembly will be held at Gladstone Park, near Oregon City, July 6 to July 18, inclusive. The programme for the 12 days' session has just been arranged, and it is expected thousands of people from Portland and every part of the Willamette Valley will attend the session.

The Chautauqua Association was reorganized three years ago and is now on a firm financial basis. This year's programme will be an especially entertaining one. The one figure that stands out above the rest is Dr. Frank G. Smith, of Chicago, Dr. Smith was in Seattle two years ago in attendance at the National Christian Endeavor Convention, and on his way home stopped for an afternoon at Gladstone Park and lectured once. He will lecture on Wednesday evening, July 7, on "The Hero of the Age," and the following afternoon will speak on "Our Nation—Her Mission, Her Hopes, Her Perils."

Other lecturers of more or less renown are Dr. Elmer L. Goshen, of Salt Lake City, Utah; Sylvester A. Long, of Dayton, O.; Dr. Eugene May, of Washington, D. C.; Hon. Henry Albert McLean, president of the Washington Commission for the Alaska-Yukon-Pacific Exposition; Dr. Matt S. Hughes, of Kansas City, Mo.; and Dr. Eli McClish, of Los Angeles.

Indian Band to Play.
The Chautauqua Indian School band, ever a favorite in Gladstone Park, will return this year and give two concerts daily. The music will, as usual, be one of the strong features of the programme. Alvin E. Gillett, baritone soloist of the Washington Presbyterian Church of Seattle, is coming to direct the music of Chautauqua, and will be assisted by Miss Grace Keller, soprano, of Cincinnati, O., and her sister, Miss Luella Keller, who is a brilliant pianist.

During the last week of Chautauqua there will be heard the Knickerbocker Quartet of San Francisco. This organization has been prominent for years in the musical world of the Bay City. The Chautauqua management tried to get them last year, but the negotiations fell through.

Mrs. Eva Emery Dye, the well-known author, will have charge of the Chautauqua Forum. This comes at 11 o'clock every morning and some attractive days have been provided for. On Sunday, July 12, Alexis Abdullah Ben Kori, who has the chair of modern languages in Indiana University, will talk on "The Recent Upheaval in Turkey." The Congress of Mothers will be held on Women's Day, July 13.

Many Special Days.
Special days have been arranged. W. C. T. U. day comes on the Wednesday of the session, July 17, is Patriotic day, when the Forum hour will be given over to the members of the G. A. R. and their friends. Dr. McClish will lecture on "Rights and Scenes of War" in the afternoon.

Some changes will be made this year in the athletic arena. The baseball team will all be local men; that is, they will come from such points as Canby, Eagle Creek, Hillsboro, Oregon City, and so on. It is expected to materially increase attendance. There will be a ball game at 8:30 o'clock every afternoon except Sunday. On the evening of Friday, July 16, there will be an athletic entertainment by the Y. M. C. A. of Portland, under Physical Director A. M. Griley.

Many changes are not made this year among the instructors of the Chautauqua Summer Normal. Congressman Hawley, president of the Chautauqua Assembly, will have the United States history classes, and Professor Albert R. Sweetzer, of the University of Oregon, will direct the classes in biology. Nearly all of the other studies, however, are in charge of new people.
