## Hotelman Discusses Regulation of

## Liquor Trade in Home City.

Declaring that he would not care to conduct a hotel in Portland under the provisions of the proposed Excise Board law, E. H. Hess, manager of the Occi-dental and Broadway Hotels, Los An-geles, yesterday in an interview urged the voters of Portland to support the Oregon State Hotel Association in its fight against the amendment. Mr. Hess has been spending three or four days hooking over the city of Portland and renewing acquaintances with old friends. renewing acquaintances with old friends. For five years he was manager of the Rosslyn Hotel at Los Angeles. In regard to the laws governing the sale of liquors in hotels in Los An-geles, Mr. Hess said;

geles, Mr. Hoss suld: Hotels must have two licenses there. We have the bar license, which permits hotels to serve liquors in public rooms and private rooms, where no meals are served. The res-taurant license is good only for cafes and restaurants. We have to be closed at 1 o'clock A. M., both har and restaurants. Sundays we can only use bottled goods, no mixed drinks. All other days in the week including election, in the dining-rooms and grill rooms of hotels, any kind of drink may be served, other mixed or otherwise in elesired hy the guesta, it being necessary that such hotel has merely a restaurant license.

I have familiarized myself with the Mc-Kenna amendment and I am frank to say that I would not ears to conduct a hotel in Portland under such restrictions I be-lieve this measure, if adopted, will make ledging-houses out of your principal hotels, as I do not believe it will be possible for any first-class hotel to conduct a dining-room under the provisions of the McKenna set.




