

WAY CLEAR FOR DESCHUTES ROAD

Ballinger Gives Right of Way to Harriman and Oregon Trunk.

ROADS REACH AGREEMENT

Protest of Power Company Falls and Harriman Has Accepted Condition About Dam Site for Irrigation.

OREGONIAN NEWS BUREAU, Washington, June 18.—Secretary Ballinger will not reconsider his recent decision dismissing the protest of the Deschutes Power & Development Company against granting right of way up the Deschutes River to the proposed Harriman railroad.

The action removes the last Government obstacle in the way of construction of these two roads, it having previously been agreed by both companies to use the same right of way through narrow portions of the canyon which will not accommodate two tracks.

The Secretary's action today put an end to all protest against railroad right of way by private parties and, if they hereafter seek to interfere with railroad construction, they must do so through the Oregon courts.

The right of way contemplates construction at water grade. The railway company agreed to elevate its tracks if in the future it becomes necessary to do so to avoid interference with any irrigation work the Government may build along this river. The railroad company has accepted this stipulation.

ALL SETTLED BUT DAM SITE

Harriman Believed to Have Made Deal With Oregon Trunk.

"This clears up everything except the question of the Government dam site," said Arthur J. Spencer, assistant to W. W. Cotton, attorney for the Harriman lines in the Northwest, last night, when he showed the above dispatch. Local Harriman officials have received no advices from Washington regarding the purchase of the maps by Secretary Ballinger. It is thought that the railroad will now be built right away, as some time ago General Manager O'Brien announced that was prepared to start immediate construction of the railroad up the Deschutes canyon.

The agreement behooves the housewives, wife and heads of culinary departments of the West Side cafes and restaurants to lay in a supply of provisions not later than 12 o'clock noon of each Thursday hereafter.

CANADA TAKES POWER

CLAIMS RIGHT TO FIX RAIL RATES ACROSS BOUNDARY.

Sweeping Ruling by Commission in Alaska Case Likely to Cause Stir.

OTTAWA, Ont., June 18.—The Canadian Railway Commission ruled today that it had jurisdiction over the rates charged on through traffic originating in Canada and destined to a point in the United States, or originating in the United States and destined for Canada.

The ruling was made in the case of an application by the Dawson Board of Trade for an order declaring that rates charged by the White Pass & Yukon Railway were too high. The railway carries traffic by boat to Skagway and by rail across part of Alaska to Dawson, traversing both American and Canadian territory. No decision on the rate question was rendered, but the rates were ordered to file a schedule of its through freight tariffs for approval or modification.

If the ruling is sustained on appeal, all through traffic across the United States and Canadian international boundary line will be under the jurisdiction of the Canadian Railway Commission.

HOLD INQUIRY AT KLAMATH

Charges Against Agent Wilson Referred to Inspector.

OREGONIAN NEWS BUREAU, Washington, June 18.—It has been decided by the United States Department of Justice to refer the charges of Klamath Indians against their agent, Horace G. Wilson, to an inspecting official, who will visit Klamath some time during the summer on his regular tour of inspection. When the inspector is at Klamath agency, the Inspector will be given a full opportunity to review their grievances and Mr. Wilson will be asked to submit his explanation.

NEW PARCELS POST SCHEME

Congressman Bennett, of New York, Would Aid in Rural Delivery.

WASHINGTON, June 18.—To reduce the postal rates, improve the postal service and increase postal revenues Representative Bennett, of New York, yesterday introduced a bill providing for a parcels post within the various rural free delivery routes. The measure proposes to reduce the rate of general merchandise from 1 cent for each ounce to 1 cent for each two ounces. On parcels 1 cent a graduated scale of rates is provided for parcels up to one cubic foot in size and 25 cents postage. The bill also provides that \$10 shall be paid by the postal service for the loss of each registered package upon which no value has been declared and that the full amount shall be paid in all cases where packages valued at \$25 and 2 cents additional for each \$50 additional in value.

MAN WITH GUN SEEKS TAFT

WASHINGTON, June 18.—A tall Westerner walked up to the front door of the Executive mansion yesterday and demanded admission. His actions attracted the attention of the police and he was arrested. When taken to the station and searched, a revolver and belt fitted with 44-caliber steel bullets were found in his possession. The man said he was Colonel James Strickling, of Roseberry, Ark.

MAY SELL DREDGE W. S. LADD

War Department Says Vessel Not Fit to Loan, but Can Be Bought.

WASHINGTON, June 18.—The Senate late today adopted by a vote of 44 to 32, an amendment of the Senate committee on finance fixing a duty of 44 cents on print paper in place of the House rate of 22 cents. The other amendments to the wood pulp and print paper schedule had not been acted upon when the Senate adjourned at 7 o'clock.

The Finance Income tax amendment will be pending when the Senate convenes tomorrow. If a unanimous agreement in accordance with a motion made by Aldrich today is not then obtained, he probably will move to postpone consideration of the subject to a certain day.

MEDALS GIVEN WRIGHT BROTHERS AT DAYTON CELEBRATION.

Nation, Ohio and Home City All Unite to Reward Aeroplane Inventors for Their Efforts.

DAYTON, O., June 18.—Wilbur and Orville Wright, the aviators, today received the medals awarded them by Congress, by the Legislature of Ohio, and by the city of Dayton. Immediately after the ceremony the brothers hurried to their factory to prepare for their departure tomorrow for Washington, D. C., where next week they will resume their flights to satisfy Government requirements.

Wilbur Wright, on receiving the medal, made a speech in which he thanked an inventor to a poet, saying that neither poet nor inventor would suffer from indifference if their wants were really known.

General James A. Allen, chief signal officer, representing Secretary Dickinson, presented the National medal; Governor Harmon, of Ohio, presented the Ohio medal, and Mayor E. E. Burkhardt, of Dayton, gave the local medal.

Behind the Wrights, on rising tiers, sat 2500 people, dressed in red, white and blue and arranged to represent the American flag.

The day's programme concluded with a parade and the crowning feature being an aeroplane.

In presenting the medal from Congress, General Allen said:

"The medals which the Wright brothers have not been due to chance, but to their persistence, daring and intelligence in different parts that go to make up their machine and practically testing the same in flight. Orville and Wilbur Wright have by their genius and perseverance brought honor to the United States. The United States in return has signally honored them by a joint resolution of its Congress and the presentation of these medals, designed by the Secretary of War in compliance with that resolution and approved by the Secretary of the Treasury and the United States mint at Philadelphia."

The medals bear the facsimile of the seal of the United States and the date of the joint resolution of Congress providing for the medal and the words of appreciation: "In recognition and appreciation of their courage and success in navigating the air."

On the reverse side is a cherub bearing the word "country" and the motto: "They shall mount up with wings as eagles."

HARMS CHARGES ARE TRUE

Fellow Inspector at St. Louis Tells of Packing-House Abuses.

EAST ST. LOUIS, Ill., June 18.—Corroboration of many of the charges against the Government's meat inspectors system here was given to the officials by Julius Bischoff, an inspector who was on the stand when the inquiry continued today. According to J. F. Harms, the inspector who opened a letter to Secretary Wilson caused the inquiry, Bischoff substantiated his coworker's accusations.

The secrecy which the inquiry is being conducted has caused considerable comment about the stockyards. Officials here are investigating the conditions of the packing houses and the public publicity would be brought into play, and today several of them said that they had not the least objection to the hearing fall to ally public distrust of the inspection system, no matter what report is made to Secretary Wilson.

Tokio Papers Making Most of Hawaiian Strike Difficulties in Dispatches.

ANTI-AMERICAN CRY AGAIN

Official Quarters Belittle Incident, and Only Lower Classes Are Aroused—Jingoes Are Blamed.

TOKIO, June 19.—Special dispatches from San Francisco to Japanese newspapers are so worded as to indicate that conditions obtaining in the Hawaiian Islands, growing out of the Japanese sugar plantation strike, are extremely serious. They declare that the Japanese on the mainland, as well as those in the islands, are deeply incensed over the treatment accorded their countrymen by the Hawaiian planters, and that the special dispatches are strained almost to the breaking point.

The publication of these inflammatory dispatches is again arousing an anti-American feeling among the Japanese lower classes. The sensational papers are seizing the opportunity of commenting editorially in a manner calculated to increase this feeling of hostility.

Japanese Consul General Uyeno, at Honolulu, and the officials of the Japanese foreign office, are inclined to minimize the seriousness of the Hawaiian situation. They frankly declare their belief that the special dispatches are giving untrue reports and are evidently the work of the jingo element among the Japanese of Hawaii and the mainland.
