

SEARCH FOR LEON
TURNS SOUTHWARD

Murderer of Elsie Sigel Has
Been Traced to Washing-
ton by Detectives.

MAY NOW BE ON ARIZONIAN

Strange Chinaman Reported to Be
Member of Crew of Freighter That
Sailed for Pacific Coast.
More Love Notes Found.

NEW YORK, June 25.—The search for
Leon Ling, wanted for the murder of
Elsie Sigel, whose dead body was found
jammed in a trunk in the Chinaman's
room, took a decided southern turn today,
and efforts of the detective bureau are
now centered in tracing the movements
of the Oriental from Washington.

Detective Van Wagner has definitely
established the fact that it was the much-
wanted Chinaman himself who sent the
telegram from Washington, D. C., to the
girl's parents in this city, saying that
she was at the capital and would shortly
return. Van Wagner returned here today
with the original telegram as written,
and comparison of it with other
writings of Leon's showed conclusively
that the Chinaman wrote it.

The police are still depending principally
on Chung Sing, former roommate of
Leon Ling, in whose room the girl's body
was found. He will be put through another
questioning in the room itself.

Leon Not in Capital Now.

There is further proof, which the author-
ities will not at present divulge, that
Leon Ling is not now in Washington.
One report, which is scouted by the im-
migration authorities, is that Leon has
sailed for San Francisco on the Ameri-
can-Hawaiian liner Arizonian, which left
Norfolk this morning.

Immigration officials say that this re-
port is erroneous, and that the man re-
ferred to is Leon Sang, second cook on
the vessel, and well known to them; but
notwithstanding this, the detective bu-
reau will make an effort to intercept the
Arizonian and run down this possible
evidence. There are three Chinese on that
vessel's crew.

Wrote Loving Letters.

Further delving in the affairs of the
dead girl and the missing Chinaman and
his friends show that Elsie was in corre-
spondence with both Leon and Chung
Gain, and that she told both Orientals
that she loved them.

Letters found in the rooms occupied
by Leon Ling and Chung Gain, rivals for
the love of Elsie Sigel, indicate that
the day before she met her death, she
wrote to each of the Chinese, loving
assurances of her entire faith in them.
A short time after Leon Ling appeared
at the Sigel home intoxicated, and was
driven away by her parents, Miss Sigel
wrote this note to the police, to Ling:

"I am writing this while mother is away.
She would not permit it if she knew it.
Don't think, or write, or give, or show
up for anybody. I will always remember
the dear time with you together. I will
see you soon. With love, ELSIE."

The letter to Chung Gain reads:
"I don't want you to be because
Willie was here tonight. You know that
I love you and you only always. Don't
mind Willie. I'll always be with you.
I don't see him. I don't send for him.
Your loving Elsie."

Chung Gain made an attempt to leave
the city today. His attorney told the
courier that he was under \$1000 bail
and was willing to furnish another
\$1000 if allowed to go to Atlantic City
where he had long planned to attend
a summer school. Permission was re-
fused.

The police of Newton, N. J., today ar-
rested a Chinaman answering in a gen-
eral way the description of Leon Ling.
He said he was Harry Kolo, 25 years
old.

CHINESE WILL CAPTURE LING

Confident in Detective Power and
Offer Reward.

CHICAGO, June 25.—The Men Sun Tsoo,
a local Chinese Masonic organization,
raised \$500 today, which was offered as a
reward for the capture of Leon Ling,
Louis Sing, who has often been of service
to the authorities, told the police today
that if Leon Ling turned up in this city,
he would be handed over to the police
by the Chinese.

"I think he will be found by one of our
countrymen," said Ling.

About Cleveland Article.

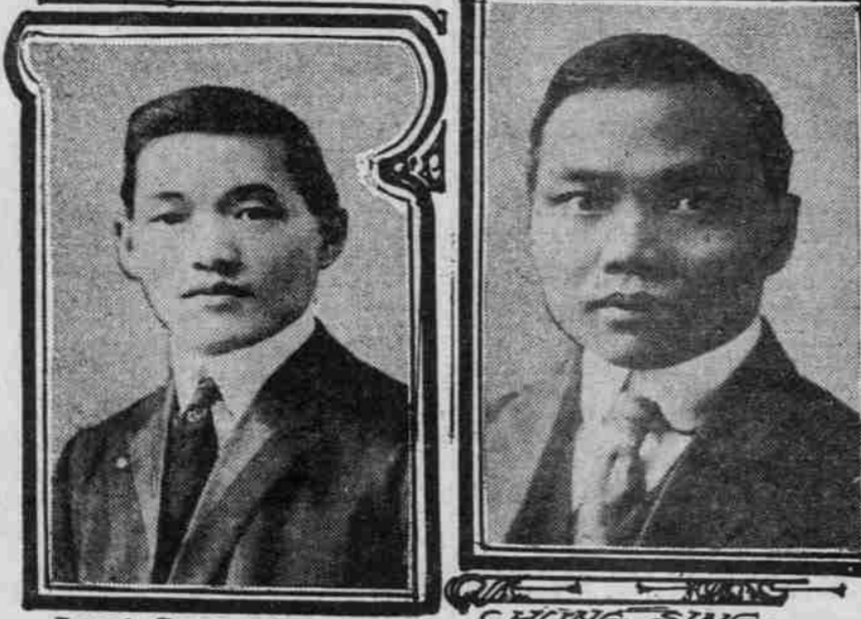
NEW YORK, June 25.—The contin-

junction ordered issued against the Mc-
Loughlin home being placed in the City
Park on Seventh street. M. D. Phillips
is the plaintiff in this case, and claims
that the moving of the McLoughlin
home to the Seventh-street park would
damage his property, which adjoins it.
Other conditions are practically the
same as the former suit recently filed
by Caleb Cross, and which was on
Wednesday dismissed for the reason
that Cross could not show the requisite
right to bring the suit.

The McLoughlin Memorial Association

JAPS VISIT FREAR

Strike Leaders Call on Govern-
nor to Ask Help.

DECLARE CASES HURRIED

Negoro and Makino Say Their Ac-
tions Are Only Peaceable Effort
to Get Higher Wages
From Planters.

HONOLULU, June 25.—M. Makino and
M. Negoro, two of the principal lead-
ers of the Japanese in the strike of
the plantation laborers, and both of
whom are under indictment charging
conspiracy to incite murder and riot,
discuss the strike situation. Follow-
ing the conference Governor Frear said
in an interview:

"The two Japanese leaders called to
assure me that the strikers are peace-
ably inclined, have no intention of
causing disturbance or disorder, and
that they are engaged in a peaceable
movement to secure the same wages for
the Japanese as are paid to laborers
of other nationalities. They also com-
plained of the seizure of their papers
by the High Sheriff, saying that the
act was a violation of their treaty
rights. They wished to see me to learn
what I could do to see that they were
fairly treated. They also declared that
the cases of the leaders who were ar-
rested were being unduly rushed in the
courts, giving them no time to pre-
pare their defense."

"I informed them that I was keep-
ing in close touch with the events in
the islands, and would continue to do
so, but that they must realize that I
could not do anything that would inter-
fere with the judiciary."

Never Drunk in Her Life.

Mrs. Gould experienced another long
ordeal on the witness stand under
cross-examination. The large number
of checks for "refreshments" which
were furnished Mrs. Gould at the St.
Regis Hotel in the Fall of 1906, when
she was charged with the murder of
her husband, were a subject of contro-
versy. Mrs. Gould reiterated her declaration
that she had never been intoxicated in
her life.

After some discussion, counsel for
both sides agreed that Mrs. Gould and
Dustin Farnum, the actor, had met 18
times by appointment.

The witness said she had met Farnum
to talk business on all 18 occasions.
"Now, you say you were thinking of
returning to the stage?" asked Mr.
Nicoll.

"Yes," Mrs. Gould said she met Farnum at
the Hotel Carroll in Lynchburg, Va., in
the Fall of 1906 to apologize to him
because she had invited him and his
manager to Blue Gap farm and then
had notified him not to come.

"Did it take you two days and a
half to apologize?" asked Mr. Nicoll.
The question was not allowed.

Mrs. Gould said she admired Farnum
"as a manly man who was witty and
entertaining at the same time."
She appeared nervous on the witness
stand and cried a little to herself as
she resumed her seat beside her law-
yer.

MRS. GOULD GIVEN
FULL VINDICATION

Granted Separation and Alim-
ony and Charges Held
to Be Disproved.

Expresses Joy at Vindication and
Feels No Pang at Smallness of
Allowance — Judge Rules
Strongly in Her Favor.

ALLOWED \$36,000 A YEAR

NEW YORK, June 25.—Katherine
Clemmons Gould today obtained a legal
separation from her husband, Howard
Gould, third son of the late Jay Gould.
With the exception of alimony, her ver-
dict was complete, but in this phase of
the case, the court decided that \$36,-
000 a year was just, which she asked
for \$250,000. She has been receiving
\$25,000 a year from Mr. Gould.

It was in the vindication from the
charge of intoxication that the original
relations with Dustin Farnum, the
actor, that Mrs. Gould scored most
strongly, for notwithstanding the long
array of witnesses for Mr. Gould, the
court held that her actions alleged to
be due to intoxication might have been
caused by excitement. As to Dustin
Farnum, it was held that his asso-
ciation with him came after Mr. and
Mrs. Gould separated, and that the hus-
band apparently made no objection. A
30 days stay of judgment was granted.
Mr. Shearn then asked for an extra
allowance for counsel fees and the court
gave him \$2000. This, together with the
\$10,000 allowed recently and the origi-
nal allowance of \$5000, will bring his
fees to \$17,000 with an additional sum
of \$2000 for expenses.

Howard Gould hurried from the room
and declined to discuss the case.

Mrs. Gould's dower right in Howard
Gould's real property, amounts to \$3,-
000,000, according to her attorney, and
was unaffected by the separation.

Mrs. Gould said:
"I am the happiest woman living, be-
cause I have been so completely vin-
dicated. Not one little pang shot through
my heart at the smallness of the allow-
ance—only supreme joy and the deepest
gratitude. I send a thousand loving
thanks to all who have helped me."

"So far as the defense has been con-
cerned, I am glad to say that the gen-
eral verdict is in my favor. The defend-
ant failed to support that allegation, but
proof, but on the contrary, the plaintiff
has gone beyond what she was directly
required to do, and I find that affirma-
tively the preponderance of testimony is
overwhelmingly in her favor."

"So far as the allegations of improper
conduct with Farnum are concerned,
there is no question that the plaintiff,
which have been testified to took place
after the desertion of the plaintiff by
the defendant and they could therefore
furnish no justification for her conduct
at the time. So far as this record
discloses, the desertion of the plaintiff
was without sufficient justification and
was without even sufficient provocation."

Reasons for Allowance.

"To apply to the plaintiff in a case
of this kind no more relief than simply
provision for her life and the children
would be obviously unfair and would be
putting a premium upon desertion of
wives by their husbands and would be
making it easier for them to avoid their
expenses by simply leaving their wives
and paying no more than was required
for the actual necessities of life.

"I regret that the question is one of
embarrassment and I have been un-
able to find any rule to govern me. I
have power to do no more in this court,
and I am sorry that I cannot do more
for the plaintiff. In my opinion,
plaintiff will enable her to live in comfort
and ease, and with dignity befitting her
station as the wife of a man who has
made a fortune of \$3,000,000 a year, which
is about \$100 a day. It is a fair percentage
of the husband's income."

"If she should return to the stage,
and the defendant may then be at lib-
erty to take steps to reduce this allow-
ance."

other charges, the police say.

CHAUTAUQUALOSES SINGER

A. E. Gillett, of Seattle, Would Re-
pudiate Season Contract.

OREGON CITY, Or., June 25.—(Spe-
cial.)—The Willamette Valley Chautau-
qua Assembly is in a peck of trouble
over the action of Alvin E. Gillett, a
baritone singer of Seattle, who was
engaged as musical director for the
coming season in Gladstone Park, July
8 to 18 inclusive. Mr. Gillett signed a
contract with the assembly to appear
during the entire season and to give
a number of solos on the Chautauqua
platform, and also to give instruction
in voice. He was to receive \$75 from
the assembly and whatever he obtained
from voice lessons was to be his.

But Mr. Gillett has other fish to fry
and asks to be released from his con-
tract to come to Gladstone Park. In a
three-page letter to Secretary Cross
he recites that he has been salesman
for a piano house at Seattle, and has
been offered the direction of the com-
pany's exhibit at the A-Y-P Ex-
position. He further says that the In-
ternational Epworth League will be
held at Seattle, July 7 to 12, and that
he has been asked to sing the baritone
numbers in the oratorio. He has a
church position at Seattle and he is
afraid he will lose them.

Mr. Gillett recommends
Thomas J. Pennell, of Seattle, in his
place. The board of directors of the
Willamette Valley Chautauqua As-
sembly have declined to permit Mr.
Gillett to violate his contract with
them, as he has been extensively ad-
vertised as the baritone soloist, and
in other ways. He has been tele-
graphed of the decision of the board
but has not responded.

BALLINGER COMES WEST

WILL EXAMINE IRRIGATION
WORK OF GOVERNMENT.

Will Apportion Funds According to
Necessities of Many
Projects.

CHICAGO, June 25.—Secretary Ballin-
ger arrived today on his way to the Far
West, where he will pass the Summer in
the study of Government irrigation pro-
jects and other works of the interior De-
partment.

"The President has sent me West that
I might become more fully acquainted
with the necessities of the Reclamation
Service," said Mr. Ballinger, "and that
I might be able to make such modifica-
tions in its administration as may be
necessary."

"In view of the great number of pro-
jects under construction and the limited
amount of funds, it is necessary to make
the apportionment carry on work where
the greatest necessity or emergencies
exist. For this reason some projects can-
not be completed as rapidly as might be
desired."

ECHO DRUGGIST ARRESTED

Accused of Selling Drugs Without
Being Registered Pharmacist.

PENDLETON, Or., June 25.—(Special.)
—John Dorn, Echo druggist, postmas-
ter and Justice of the Peace, has been
held to appear before the grand jury this
fall for alleged violation of the pharm-
acy law. He has been arrested and ar-
raigned on three different counts, the
combined offenses making him liable to a
fine of from \$75 to \$500. He is charged
with selling a poison and failing to reg-
ister the sale, with selling prescriptions
without being a registered pharmacist or
having a registered pharmacist in his
employ.

So far as is known here this is the first
arrest in this state for a violation of this
law and it is possible he may be able to
make a test case of it. It is believed,
however, that since the evidence against
him is strong, that he will enter pleas of
guilty in the hope of receiving the mini-
mum fines. The evidence was secured
by State Senator F. H. Caldwell, of the
State Pharmacy Board.

Good Things in Portland
Markets

STRAWBERRIES and cherries divide
the honors of the market this week.
The former are selling at three and four
boxes for 25 cents, the latter at 5 to
about a pound, according to kind and
quality. Loganberries, raspberries and
blackberries cost 10 to 12 cents a box,
while red currants and gooseberries are
to be had at 5 cents a pound.
The larger fruits are also beginning to
claim space on the fruit stands. The first
watermelons of the season have arrived
and cost 22 cents. Cantaloupes are getting
somewhat less expensive, costing now
about 10 to 15 cents each. Several kinds
of plums are in at about 35 cents, and
apricots at 40 cents a box. Peaches are
improving in quality and cost 50 cents a
dozen. Fresh black figs are considerably
lower in price this week at 25 cents a
dozen.
In the vegetable market the first okra
of the season has made its appearance.
Cucumbers are getting steadily lower in
price, large ones now costing about 10
cents. Tomatoes are also somewhat
cheaper, and cost a good 15 cents a bushel.
The economically-minded should wait a
little longer for the Spanish omelet sea-
son. Green corn costs 75 cents a dozen,
and asparagus 15 cents a pound. Oregon
string beans are in and peas are good,
and fairly plentiful. Celery is of the
green variety and costs 15 cents a bunch.
Summer squash are to be had at 10 cents
a pound and egg-plant at 25 cents. New
potatoes are inviting at about 5 cents a
pound.
Gravling, or sea trout, are very good
this week at 15 to 20 cents a pound.
Black bass and striped bass are again
to be had at 25 cents a pound. Salmon
and sole cost 15 cents, and perch, shad
and flounder 10 cents a pound. Shad
roe costs 25 cents a pound. Lobster
lobster 75 cents each. Crabs will soon
be out of season, but in the meantime
can be had, fresh, at 10 to 25 cents each.
In the poultry market there is little
change. Hens cost about 20 cents; Spring
chickens, 25 to 35 cents each; ducks, 30
cents and geese 15 cents a pound. Tur-
key is practically out of season. Squab
