

SUICIDE ATTEMPT FAILS

Prisoner, Hanging in Cell, Is Cut Down by Fellow Inmate.

ASHLAND, Or., July 13.—(Special.)—James Wilson, an inmate of the County Jail, awaiting the grand jury on a charge of burglary, Saturday night attempted suicide by hanging. Wilson had improvised a rope from his blankets, tied one end to a cell roof, stood on a box which he tied the other end to his neck. For fear that he might lack courage and try to save his life he tied his hands behind his back. He then kicked away the box and proceeded to die.

A fellow prisoner, seeing Wilson's struggles, ran from the outer corridor and, reaching through the cell wall with an old case knife, managed to sever the blanket rope in time to save Wilson's life. Wilson began the performance in the early evening by trying to dash out his brain by bunting against the steel cage.
