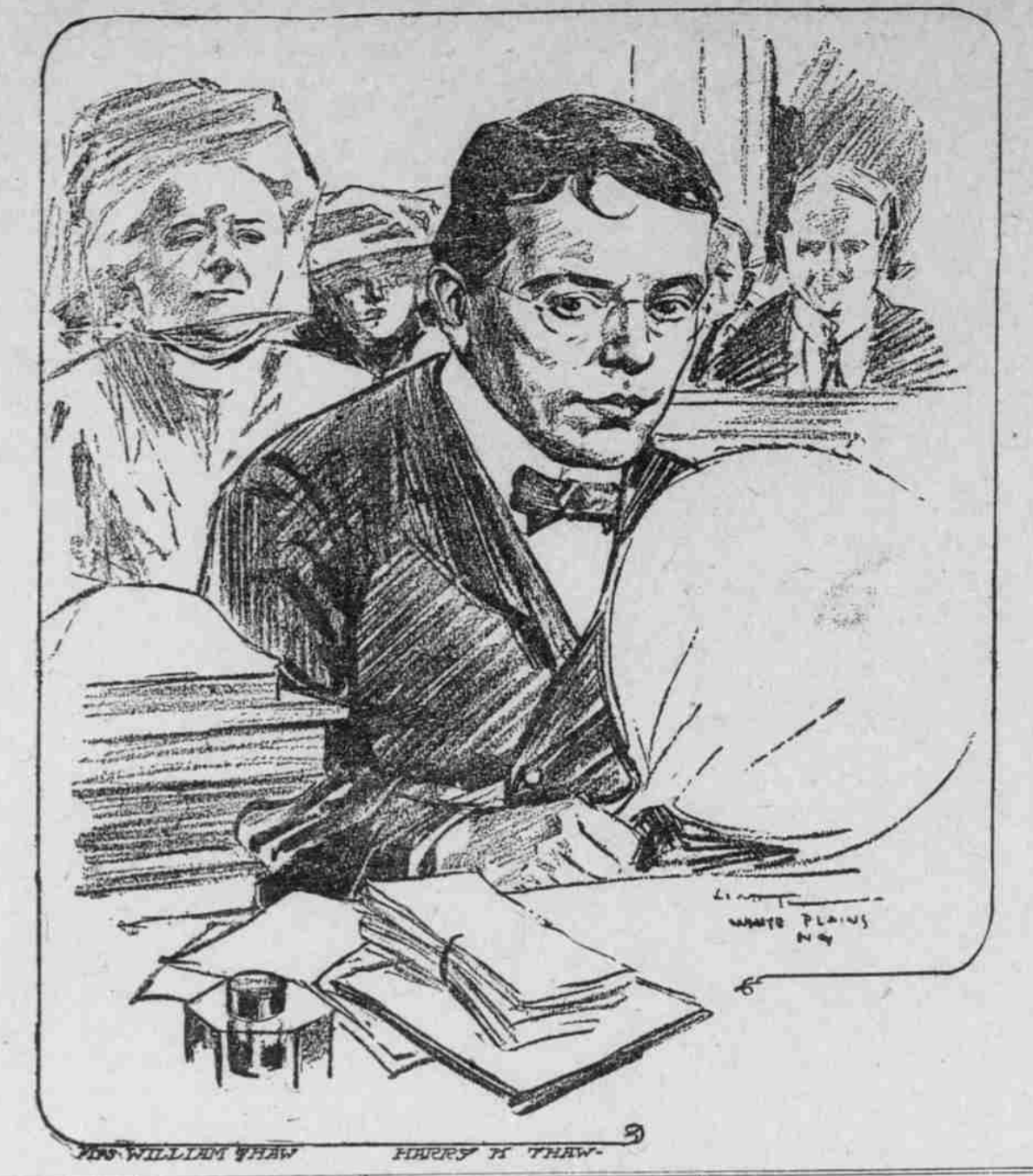

WHICH A KILL CAN BE DIED EVERY 10 HOURS

Mr. Jones believes the estimates of 240 cwt. for the English crop this year to be too high and places the figure at not to exceed 225. The continental crop, which was 500,000 cwt. last year, he thinks, will be much less this year, owing to the heavy rains.

Mr. Jones is favorably impressed with this country and contemplates some heavy investments here and may possibly locate in Oregon. Hop land in England is worth about \$500 per acre, and he looks for a big increase in the value of western lands with the increase in population, which he believes is sure to come. While land in England is valuable, none of it is allowed to go to waste. On the fruit ranches every 18 feet apple and plum trees are planted and every 5 feet between the fruit trees, gooseberries are grown. The cultivating is done by hand tools in the winter. Common labor on the farm is paid at the rate of about \$4 per week, and for picking hops, growers pay about 5 to 6 1/2 cents for 100 pounds.

TRAITORS TO JAPAN

Opponents of Strike Thus Condemned by Strikers.

HAWAII AS JAP COLONY

Trial of Strike Leaders Brings Out Ambition to Acquire Islands for Mikado—Movement is Opposed in Japan.

HONOLULU, July 28.—During the trial today of A. Makino and other leaders in the strike of the Japanese plantation laborers, charged with conspiracy, translations, editorials and other articles that appeared in the Nippu Jiji, the organ of the Japanese Higher Wage Association, were introduced in evidence by the prosecution.

They contained statements that those who were opposing the strike were "traitors to their country, and destroying the colonial foundation of the Japanese nation in Hawaii." Some of the articles also urged the death of those among the Japanese who were opposing the movement for higher wages.

Professor Walter Denison, of the Educational Department of the Japanese government, is acting as interpreter in the trial and was brought here specially for that purpose. Professor Denison was on the witness stand today on behalf of the prosecution and read translations from many articles that appeared in the Nippu Jiji. He said he came here by permission of the imperial government.

Under cross-examination by counsel for the defendants, he admitted having addressed a meeting of strikers at the Waipahu Plantation, telling them that it was the general opinion in Japan that the Japanese in Hawaii had made a mistake in calling a strike, but denied that he had said he represented the government or that the Foreign Office wanted them to return to work.

COUNCIL FAVORS FRANCHISE

Troubles of Molalla Road Promoter Thought Nearly Over.

OREGON CITY, Or., July 28.—(Special.)—The differences between the municipal government and F. M. Swift, who is promoting the construction of an electric railway system from Oregon City to Silverton, through the Molalla Valley, will probably be adjusted, as the Council last night gave favorable consideration to an ordinance conveying a 25-year franchise.

The first 10 years there is to be no consideration, the next 10 years Swift is to pay \$500 per annum, and the last five years \$1000 per annum. The franchise covers Fifth street to Center, and on Center, Eleventh and John Adams streets to the Green Point district. The railway will come into the city through the Mount Pleasant section.
