

Taft Visits Bay in Orange Capital

Sees Sights of Los Angeles, Reviews Children, Dines With Shriners.

SAILS AROUND NEW HARBOR

Launch Sticks in Mud, but Floats Again—Taft Visits Sister—Made Member of Pioneers' Society and Shown Ports.

LOS ANGELES, Oct. 11.—President Taft arrived in the flower land of Southern California today and received an enthusiastic greeting. He visited the inner harbor and deep water of San Pedro, below the city, and had a sail of an hour and a half inside the big Government breakwater. Returning to Los Angeles at 1 P. M., he was taken for an auto ride of two hours through crowded streets. The President passed in review of the school children and made an address to them in which he sought to inculcate a lesson in patriotism by catching them as to the meaning of the flag and their idea of the liberty which it represents. This evening Mr. Taft was the guest of honor at a banquet at the Shriners Auditorium, which in part numbers and lavishness of decoration proved to be a distinctive feature of his trip.

FISH MONOPOLY BROKEN

Interests of Late R. D. Hume to Be Sold at Public Sale.

MARSHFIELD, Or., Oct. 11.—(Special.)—The monopoly of the fishing rights held for so many years by the interests of the late R. D. Hume will soon be broken, as the entire estate is to be sold at private sale this month. After Mr. Hume's death the fisheries and cannery were closed, but were opened for a short time. This fall on account of the approaching sale, the fisheries were closed after 400 cases of canned salmon had been shipped. Since they were closed, the Union Fisheries Company is said to have made a haul with seines which netted 1800 fish. The gasoline schooner Gerald C. which was formerly owned by the Hume estate, has been sold and has made her last trip to Rogue River. She will be taken to Astoria. For over 30 years R. D. Charles W. Morse, Ice King and Bankruptee, whose Sentence Has Been Affirmed.

BACK TO JAIL IS ICE KING'S FATE

Morse's Sentence Affirmed by Appeal Court, but He Will Go Higher.

MAY GO OUT ON BAIL AGAIN

Adverse Decision Interrupts His Work of Rebuilding Fortune. Of 53 Counts, Only 12 Are Sustained by Courts.

NEW YORK, Oct. 11.—Unless the Supreme Court of the United States reverses the decision of the President of the United States Interests, Charles W. Morse, one time "Ice King," convict steamship line organizer, banker and capitalist, will serve 15 years at hard labor in the Federal prison at Atlanta, Ga. After having been at liberty under \$1000 bail since June 17 last, he is back by the Tombs prison tonight as a result of a decision of the United States Circuit Court of Appeals today sustaining the judgment of the lower court which found Morse guilty of violating the National banking laws. The decision was unanimous. To Morse's complaint that 15 years was excessive in view of the suspension of sentence on Alfred Curtis, who was indicted with him, the court answers that the complaint to be made to the President of the United States in asking clemency. Morse took the decision calmly. He heard the news in the office of United States Marshal Henkel, and was almost immediately taken to the Tombs. When word of the decision came, Mr. Morse, who was with her husband, said: "All along we had the utmost confidence that a new trial would be granted. The decision today came as a great surprise to me. My husband is brave and he will continue to struggle for his liberty. Mr. Littleton will remain in charge of his case and will try at once to obtain Mr. Morse's release on bail." When he left the Federal building in custody of an officer for the Tombs, Morse was not handcuffed. Rebuilding of Fortune Stops. One of Mr. Morse's keenest regrets at being forced to return to prison is the interruption of his struggle to rebuild his fortune. During his liberation under bail he had been re-elected president of the Metropolitan Steamship Company, a New England corporation, and of the Hudson Navigation Company, operating a line of boats on the Hudson. He is credited with having discharged the bulk of his debts. From the two big transportation lines that had within the week selected Morse as their president, there was no official statement forthcoming after today's decision. It was understood that, for the present at least, the election would stand. Guttled Bank to Boost Ice. Morse was indicted on March 12, 1908, on his return from Europe. The indictment contained 53 counts, comprising conspiracy to defraud the United States government, the making of false entries and misapplication of the funds of a National bank. It was charged that Morse with others, was engaged in a pool that was manipulating the stock of the American Ice Company. As a result of this pool United States District Attorney Stimpson declared, Morse and his associates became possessors of large blocks of ice stock and finally, getting near the end of their resources, went to the National Bank of North America and obtained money to continue the speculation. The Government alleged that during the time to time \$1,200,000 of the bank's money was used for this purpose.

Sees Harbor Being Dredged.

The President reached Los Angeles at 7:45 A. M. and his train was immediately switched to the tracks leading to the harbor of San Pedro. Arriving there at 9 o'clock, the President was taken aboard a launch for a trip around the waterfront. He was escorted first into the inner harbor to be given a glimpse of the gigantic task of dredging out a basin that will permit the big ocean liners to within 12 miles of the city proper. Much to the chagrin of the Government engineer in charge of this work, President Taft's launch struck a mudbank and stuck fast for a minute or two. The delay was but momentary, however, and when the President's boat headed for the outer water, a flotilla of accompanying craft fell into its wake. The President surprised the committee which had set out to explain the harbor works to him by his intimate knowledge of the plans to make Los Angeles harbor one of the finest in the world.

Inspects Site of Forts.

Before leaving San Pedro, Mr. Taft was shown the site of the fortifications that are to be constructed on a high hill off Point Firmin to protect Los Angeles Harbor. He spent fully 15 minutes on the heights listening to a detailed explanation of the plans. It was in the tropical park near the Railroad Station that Mr. Taft, alighting from his private car, was officially welcomed by Mayor Alexander and a large committee of citizens. It was at this park also that he was made "at sight" an honorary member of the pioneers.

NEED FERTILIZER AT HOME

Ballinger Would Preserve Phosphate Land in Rockies.

SAN FRANCISCO, Oct. 11.—Secretary of the Interior R. A. Ballinger, who left here yesterday to investigate the Sierra water supply, gave out a typewritten statement relating his views on the reclamation service. He said, in part: "The disposition of the phosphate lands of the Rocky Mountain States presents an emergency calling for legislation. All of the known areas of phosphate lands in the public domain are now under temporary reservation, awaiting Congressional action. Common prudence demands that this fertilizer be disposed of with such restrictions as will require its domestic use, so far as possible, in the renewal of the fertility of the American farm, rather than permit of its exportation." "Respecting coal lands, since 1906 no coal land entries have been permitted to be made in Alaska, pending requests upon Congress for legislation to prevent the monopolization of the vast fields of this valuable deposit lying in this territory and to secure authority for permanent reservation for naval purposes. Too much coal has been reserved in favor of legislation which will prevent the absorption of these valuable coal deposits by private interests with the design of monopolization."

DOGS TO BE WELL TREATED

General Maus Issues Strict Orders on Care of Canines in Alaska.

VANCOUVER, Wash., Oct. 11.—(Special.)—Cruel or improper treatment by Army employes of dogs used in Alaska for military purposes will be punished, according to an order issued by Brigadier-General Maus, in command of the Department of the Columbia. General Maus insists in his order that the dogs shall be adequately housed, sheltered and fed, in order that they may be kept in serviceable condition. Employes in charge will be held responsible that the dogs are not maltreated. Cruel or improper treatment of these dogs will be punished by summary dismissal of the offender, and, in case of civil service employes, by suspension and the action required by law. Careful record must be kept of all dogs, and monthly inspections will be made. A system of marking shall be devised, but branding is forbidden.

Mercury Falls With Snow.

KANSAS CITY, Mo., Oct. 11.—With the first snow of the season falling at Sioux City, Ia., and Omaha, Neb., and with sleet at St. Joseph, Mo., portions of those states as well as Eastern Kansas, experienced a decided fall in temperature today. In Kansas and Missouri a temperature of 45 degrees above zero were recorded.

SUICIDE RUMOR UNFOUNDED

Report That Finch Had Taken His Life Proves Hoax.

SALEM, Or., Oct. 11.—(Special.)—In some unexplained manner a report gained circulation in Salem and Portland this afternoon and evening that James A. Finch had committed suicide in his cell at the penitentiary. The report is without foundation. Finch appears to be in his usual cheerful mood. He was visited this evening by his wife.
