The first straight car of new California walnuts is due to arrive in the latter part of the week. The first shipment received by express sold at 14 1/2 cents a pound, but since then the market has cooled off and the price has fallen to 13 1/2 cents.

The California walnut crop, which has been estimated at 100,000 tons, is now in comparatively few hands, and quotations are firm, with an advancing tendency.
