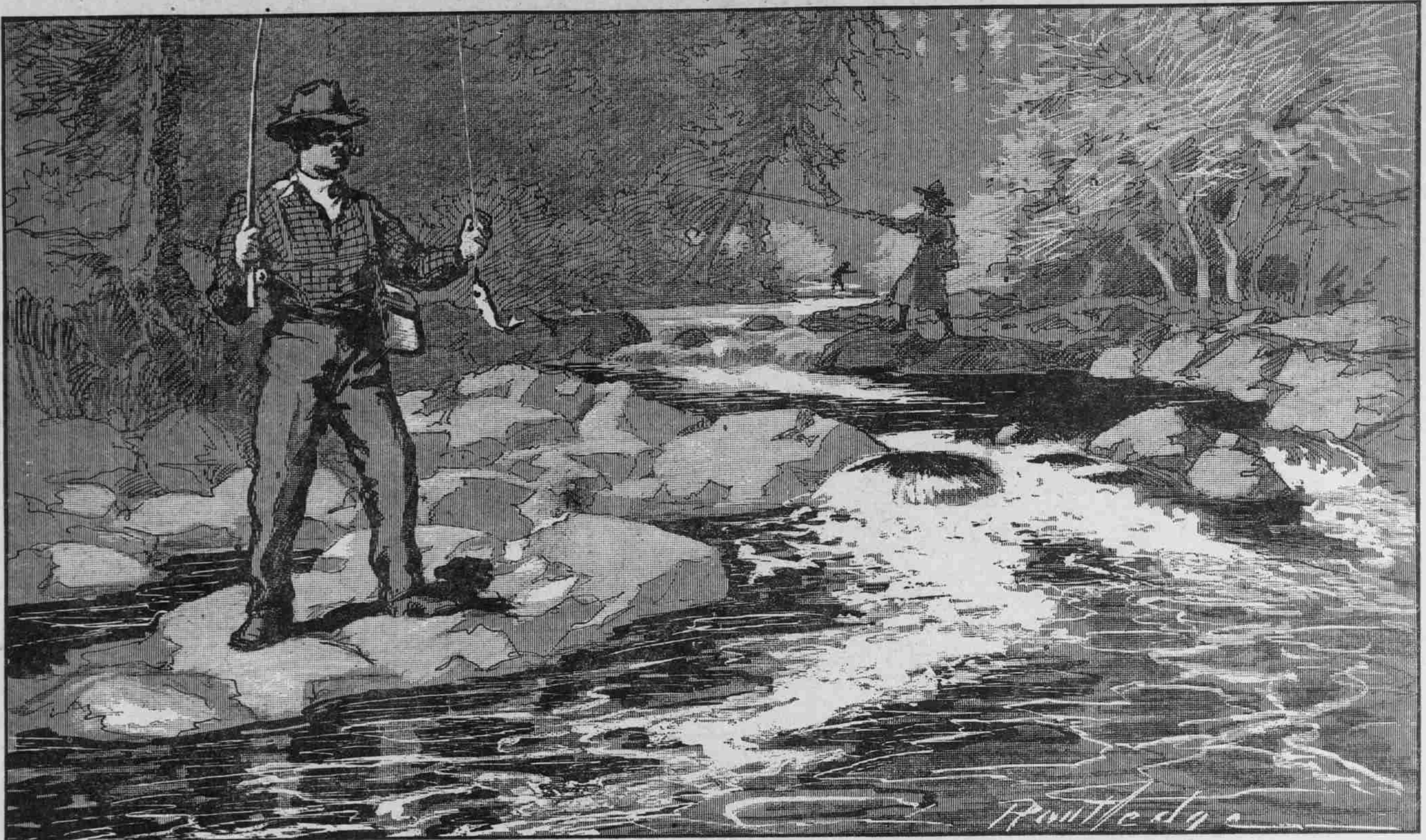

10 SAVED ISOLATED

Captain and Nine Others of
Argo on Lightship Yet.

TUG AWAITS CALM SEA

Port of Portland Craft to Get Refugees When Storm Abates—Tender Forced Back—All Reported Well.

Refugees from the wrecked steamer Argo, who were picked up by lightship No. 70, early Saturday morning, will be marooned on that coast until the terrific gale that prevails has subsided and it is safe for another vessel to take them ashore.

The lightship tender Manzanita started out yesterday morning from Astoria after the men, but on account of the gale was compelled to turn back. Another attempt will be made today if weather conditions permit. In the meantime the men are known to be suffering no great inconvenience, as there are plenty of provisions on board the lightship and fairly good quarters for all.

It was learned by the Port of Portland Commission yesterday that the ten refugees, rescued with Captain Snyder, of the Argo, are safe and well. One of the two tugs, the Wallula and the Tatook, belonging to the Port of Portland, will be on hand to take the refugees ashore as soon as weather conditions permit.

"I sent word to Captain Reed, our man at Astoria," said Superintendent Campbell yesterday, "to do everything he can for the benefit of the refugees. The Wallula went out to the ship yesterday, and if the wind subsides she will take the people off the lightship later. From her I learned that all the refugees were safe."

The lightship is 15 miles from Astoria, and the wind was blowing there yesterday at the rate of about 22 miles an hour. L. P. Branstetter, the owner of the Argo, telegraphed from San Francisco to a Portland friend, H. M. Carlock, that he expects to arrive here this morning. It is understood that the Argo held no insurance and will be a total loss to the owner. The Argo, plying between Portland and Tillamook, paid large revenues to her owner. She was on the route for a year.

Mr. Branstetter also owns the larger

part of Sauvie Island, on the Willamette River. He also holds large interests in Humboldt, Cal., and it was at the latter place that he purchased the Argo, a little more than a year ago, at what he considered a bargain, \$35,000. The original cost of the vessel was about \$45,000.

Although Mr. Branstetter makes his home on Sauvie Island, he was spending the Thanksgiving holidays in San Francisco, where he and his wife were visiting their daughter. A year ago Mr. Branstetter and his wife were also in San Francisco for Thanksgiving, and while there received news of the burning of a valuable barn filled with hay.

DEAD ENGINEER IS BURIED

Funeral of O. R. Meacham Held at Hillsboro.

HILLSBORO, Or., Nov. 28.—(Special.)—The funeral of the late Oren Ransom Meacham, the locomotive engineer killed near Missoula, Mont., last Thursday, took place here today at 1 o'clock at the Christian Church, and interment followed in the Tualatin Plains Cemetery, four miles north of this city. The remains were brought from Missoula by Harry C. Allen, representing the Brotherhood of Locomotive Engineers, of which Meacham was a member.

Young Meacham was an entered apprentice Mason, taking that degree at Helena some time prior to his death. Mr. Allen says Meacham's engine struck a slide a few miles west of Missoula, and rolled nearly 100 feet down an embankment.

The dead man's father, J. J. Meacham, lives at Banks. Meacham leaves a widow and child, and the following brothers and sisters: Charles Meacham, Hillsboro; Thomas G. Henry O. and George Mountaineer; Mrs. Anna Evans, Portland; William, Stella, Wash.; Mrs. Fred Ennes, Hillsboro, and James on the P. R. & N. survey between this city and Tillamook.

KILLING CASE ON TODAY.

Manslaughter Charge Placed Against McMinnville Man.

McMINNVILLE, Or., Nov. 28.—(Special.)—Judge George H. Burnett will hold an adjourned term of the State Circuit Court at this place, beginning tomorrow, at which time Jesse Townsend will be tried upon an indictment charging him with manslaughter in the alleged killing of James Lawrence at Townsend on September 25 last.

Much interest is attached to this case, the killing being the culmination of a quarrel party that gathered at the home of the defendant on the night of the tragedy. The grand jury indicted Townsend with manslaughter. He has been out on bail of \$1500.

M'CORMICK IS OUT

Tacoma Millionaire Timberman Would Be Senator.

FIGHT TO BE INTERESTING

Northern State Sees Robert Laird McCormick Enter Race for Toga of Seattle Man—Contest Now Five-Cornered One.

TACOMA, Wash., Nov. 28.—(Special.)—Although the time for choosing a United States Senator from Washington is a year distant there are already several avowed candidates for the toga of Senator Sam H. Piles, of Seattle, who has apparently decided not to seek another term. To do so there are five aspirants, namely, Robert Laird McCormick, Tacoma; Judge Thomas Burke, John L. Wilson and John E. Humphries, of Seattle, and Congressman Miles Folger, of Spokane. Others are casting out their hooks in an effort to catch the public sentiment.

It will be a merry race and the voters will have a classy field from which to pick their favorite.

Cushman, Logical Senator.

Not long ago Tacoma and the Second district lost an able representative, the late Francis W. Cushman, who served his constituents faithfully and well in the lower house of Congress. At the time of his death he was being groomed for the Senatorial race, the people believing he was entitled to the position. His death robbed Tacoma of a sure chance to have a Senator for it had been conceded in all quarters of the state that Cushman was the logical man. So it is no wonder that this city feels it is entitled to the office anyway. In casting about for one worthy of taking Cushman's place choice settled upon Robert McCormick, the millionaire philanthropist, banker and lumberman, who has been a leader in Republican politics ever since he was old enough to vote. They are working unanimously for him, believing that he will carry out the Cushman policies.

Mr. McCormick announces his policy in these few words: "I am for the people."

Mr. McCormick is a student of history and the English classics. He has studied and read books all his life and his range

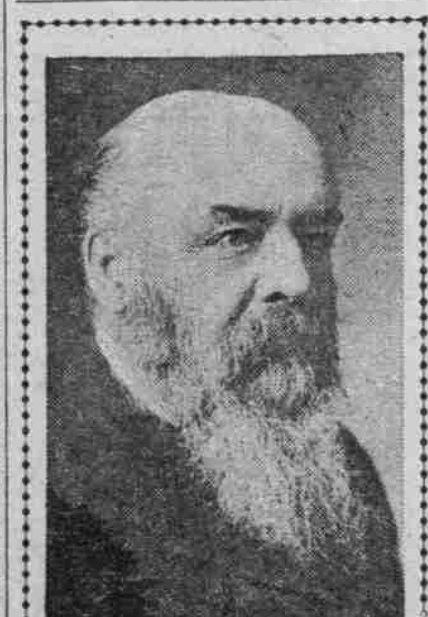
of information borders on the marvelous. He is versatile, forceful and positive; talks frankly and to the point.

The little town of Lock Haven, Penn., was the birthplace of Mr. McCormick, in the year 1847. His early boyhood was spent in hard study and work, his first position after leaving Tuscarora Academy being as station agent for the Pennsylvania & Erie Railroad. Later he moved to Winona, Minn., and then to Wacessa, Minn., where he purchased a lumber yard and inaugurated his career as one of the biggest lumbermen in the Northwest.

It was while residing here that his political career began, which has since rounded out to a membership on the National Republican Committee, representing the State of Washington. He served as Mayor of the Minnesota town for six years and at the age of 33 was sent to the State Legislature as Senator. When he became secretary and treasurer of the Northern Wisconsin Lumber Company, four years later, he abandoned politics.

Success Is Rapid.

His success was rapid. In 1898 he induced the Weyerhaeusers to make heavy purchases of timber in the Northwest, which culminated in the formation of the Weyerhaeuser Timber Company, with a capital of \$12,000,000 and offices in Tacoma. This deal, ten years ago, marked the entrance of Mr. McCormick into the business and political life of Washington and the Northwest.

IDAHO GOING DRY

Prohibitionists Already Have Majority in Lower House.

WETS HAVE SMALL CHANCE

Counties Yet to Be Heard From Give Small Consolation to Minority—Party Leaders Openly for Statewide Laws.

BOISE, Idaho, Nov. 28.—(Special.)—State-wide prohibition stares Idaho in the face today, although this state will not go into the "dry" column without one of the bitterest political conflicts in its history, if the signs of the times all read aright.

The "drys" can claim today a grand total of 35 representatives in the next legislature, of a total representation in the lower house of 59. If all of the counties which have not voted on local option go "wet" the anti-prohibitionists will have a total representation of only 24. The "drys" have 13 out of 23 Senators who will have to be elected from "dry" counties. Two counties, Latah and Oneida, are in the "dry" column, owing to the action of the county commissioners in refusing to grant liquor franchises. The rest of the 11 counties scheduled to elect "dry" Representatives and Senators, have voted temperance under the terms of the local option law passed at the last session. Lemhi last Wednesday gave the "drys" a majority of six votes.

Forecast Favors "Drys."

A forecast as to how the remaining counties will go gives the "drys" four counties, with the possibility of carrying two more. Even the "drys" are inclined to concede that Owyhee, Custer, Boise and Blaine counties, if they vote on local option, will go "wet." They have five Representatives. The only two in the entire state that have so far gone anti-temperance are Ada and Elmore, the former entitled to five Representatives and the latter one, making a total representation of 10 members in the lower house. Shoshone, Nez Perce and Bonner are the three northern counties which have not as yet voted on local option. Bon-

ner is claimed by the "drys." It has a representation of three, while Nez Perce has five members and Shoshone four. Cassia County is another southern county which has not voted but the "wets" are willing to concede that it will go "dry," giving the prohibitionists one member in the house and one in the senate who will be pledged for state-wide prohibition, thus increasing the house representation of the prohibitionists to 35. Placing Nez Perce and Shoshone in the "wet" column nine more Representatives are given their grand total, making 29 in all, against 39 for the "drys."

However, according to the way the counties have voted, the "wets" have a showing of only six members of the house and two Senators, while the "drys" have 25 members and 12 Senators, or a majority in both branches of the Legislature.

Leaders Join Prohibitionists.

It is asserted by the prohibitionists that the political leaders of the state, and especially in the Republican party, will do much towards giving Idaho state-wide prohibition. Among those who have embraced the cause openly are Senator William E. Borah, Governor Frank R. Gooding, ex-Governor John T. Morrison, Speaker Paul Cragston, Judge Alishie, who drafted the local option law, Senator John Hart, president of the senate; Lieutenant-Governor Sweetser, Representative Robert McCracken and M. M. Alexander, Democratic candidate for Governor, who was defeated at the last general election.

LAND RENTS GO UP

Nez Perces Indians Get \$9 an Acre for Two-Year Period.

ACREAGE IS IN DEMAND

More Than 300 Leases Are Closed in November and Approximately \$60,000 Has Been Paid Tribesmen by White Farmers.

SPOKANE, Wash., Nov. 28.—(Special.)—While renegade Nez Perce Indians loafed about the agency at Fort Lapwai, Idaho, waiting for their lease money, more than 300 leases were closed in November for Indian land which will be tilled by white farmers, and approximately \$60,000 has been paid to Indians by farmers. The annual leasing period begins late in October and during November the leasing is extremely heavy. More than 1000 leases are in effect on the reservation. In addition to writing more than 300 leases this year, the Indian office must disburse about \$125,000 to Indian landowners.

The scramble for the rich agricultural lands has advanced prices, in some cases rents having reached \$9 an acre for the two-year period. The first year's crop costs the renter \$5 an acre, while the summer fallow crop nets the Indian owner \$4.

The average Indian renter puts the money away, but profligate squander it gambling with sticks.

TELEPHONE WIRE KILLS

Bread Basket of Baker Comes In Contact and Baker Dies.

VANCOUVER, B. C., Nov. 28.—Charles Pearce, aged 29, a bakery wagon-driver, was instantly killed last night, when he came in contact with a broken telephone wire which had fallen over a heavily-charged power cable.

The telephone wire brushed against a wire bread basket he was carrying on his arm.
