Pedro's Liability Only \$16,500.

SAN FRANCISCO, Dec. 20.-After Hm-ting the Hability of the Metropolitan Lumber Company to \$16,500 for damages caused by the collision of the company's steam schooner San Pedro with the pas-senger steamer Columbia off the Mendo-cino coast on July 21, 1997, in which many lives were lost, Federal Judge Dehaven today ordered the adjustment of the claims-by Commissioner J. P. Brown, of the United States District Court. Chaims have been filed to the amount of

Claims have been filed to the amount of \$615.087 for loss of life and property, the largest being those of the San Francisco & Portland Steamship Company, owners of the Columbia, for the sinking of the steamer and United States Lloyds, as-






