Poltalloch Disposed of by

Eschen & Minor, stevedores of San Francisco bid in the British bark Pol-talloch yesteriny for \$17,500. The money was poid over to the United States Mar-shal yestering afternoon and Captain Eschen, who represented bis firm, de-parted for San Francisco Iast night. The craft was cold by United States Marshal Roed to satisfy claims against be vessel and was on order from the United States Court. E. Black were among the bidders.

Kerr and A. Ia Black were bridge bidders. Bidding was fast until after Mr. Kerr had made an offer of £6,500 for the craft. Marshal Reed made a good anc-tioneer and mode a good talk for the owners. Mr. Exchan finally offsred \$17,000. Messrs. Crowe, Black and Sterling in-dulged in a faw cross bids of \$20 and \$100 each. Captain Exclien then came forward with an offer of \$17,500 and the PoltaBoen was Knocked down to him as the highest bidder.
