

CASTRAWAY WINS DEATH STRUGGLE

Last of Ill-fated Farallon Crew Saved as End Draws Near.

FOOD GOES; FLOOD COMES

Tale of Misfortune of Charles Burns Reads Like Romance, With Alaskan Indian Runners Real Life-Savers—Hero Now Home.

VALDEZ, Alaska, April 1.—The mail steamer Dora arrived from Unalaska today, bringing Charles Burns, the last member of the boat crew that left the camp of the castaways of the steamship Farallon at Blinn Bay, Cook Inlet, after the Farallon had gone on the rocks January 6.

Burns refused to accompany the remainder of the crew when they left Kaguyak Bay to cross Shelikof strait to Kodiak Island, and he was permitted to reach Cold Bay, on the Alaskan Peninsula, and catch the Dora when she made her regular call there.

Burns Sets Out Alone. Burns set out alone in a little open dory, with a small quantity of dried salmon for food, and headed southwestward, skirting the coastward of the mouth of the river, where the supply of salmon became exhausted and he rowed his craft a whole day without food, the bleak shore offering no inducement to land.

Finally, Burns sighted a prospector's cabin and he made a landing. In the cabin was a shotgun, an ammunition box, a tin of powder, a tin of tallow, a tin of lard, a tin of sugar, a tin of coffee, a tin of tea, a tin of salt, a tin of butter, a tin of oil, a tin of vinegar, a tin of ketchup, a tin of mustard, a tin of pickles, a tin of preserves, a tin of jam, a tin of marmalade, a tin of preserves, a tin of jam, a tin of marmalade.

Weak and hungry, Burns started on foot through the snow for Kodiak. He arrived within sight of the town, but could not drag himself further, and went into camp. The next day he staggered to Kodiak, where his wounds were treated and where he found the census enumerator had just departed for Cold Bay with a dog sled.

Indian runners were after the enumerator and induced him to return to Kodiak. He took Burns on his sled and carried him to Cold Bay, where they arrived just in time to catch the Dora. At Unalaska a physician treated Burns' head and the Dora landed him at Kodiak, his home. Burns will recover.

FARMS IN DEMAND

Eastern Firm Clearing Big Tract Near Salem.

SMALL PLOTS ATTRACTIVE

Willamette Valley Proves Objective Point to Homesteaders Who Would Produce Fruit—Big Farms Give Way to Smaller.

SALEM, Or., April 1.—(Special.)—The A. C. Bohmstedt Company, of Minneapolis, which recently purchased nearly 2000 acres of land east of Salem has under option several hundred acres more, has a large force of men and teams at work planting apples and cherries. This entire tract will be planted in fruit and sold in five and ten-acre tracts, the company remaining in possession until the fruit is in bearing. The work is in charge of County Fruit Inspector E. C. Armstrong.

There is a marked tendency in this part of the Willamette Valley to subdivide the large land holdings and plant varieties of fruit on the smaller tracts. This is seen in the large acreage being cut up on every side of the city. Derby & Wilson are marketing a 200-acre farm on the Polk County hills southwest of the city. This land is being cut into ten-acre tracts and practically all of it will be devoted to fruit culture.

Salem to Inspect Waterworks.
